### **Executive Summary**

Issue 1: The Benefits Of The Medical Services Fund Advisory Council Outweigh Costs; Council Provides Useful Guidance To The Commissioner Of The Bureau For Medical Services.

The Medical Services Fund Advisory Council is a federally mandated advisory committee for the Bureau for Medical Services (BMS). The Council is required to provide guidance to BMS in three areas, the primary area being health and medical services. The Council presently has 13 members who regularly provide advice on amendments to the State Plan and recommendations regarding policies and procedures. In addition, the Council operates at minimal expense to the State since the staff donated by BMS devote a small percentage of time to the Council. In addition, no Council member seeks travel reimbursement, which further reduces costs. **Therefore, the Legislative Auditor concludes that the benefits provided by the Medical Services Fund Advisory Council exceed the costs and recommends that the Council be continued.** 

#### Recommendations

1. The Legislative Auditor recommends that the Medical Services Fund Advisory Council be continued.

### Review Objective, Scope and Methodology

This Preliminary Performance Review of the Medical Services Fund Advisory Council is required and authorized by the West Virginia Sunset Law, Chapter 4, Article 10 of the West Virginia Code.

#### **Objective**

The objective of this report was to determine if the Medical Services Fund Advisory Council effectively serves its mandated function to advise the Commissioner of the Bureau for Medical Services.

#### Scope

This report used information from Council meetings from calendar years 2004 and 2005. Some historical information is included for background purposes.

#### Methodology

The Medical Services Fund Advisory Council provided the Legislative Auditor with meeting minutes for calendar years 2003, 2004, and 2005, as well as current membership. The Legislative Auditor then reviewed the meeting minutes to determine if the Council made recommendations to the Commissioner of the Bureau for Medical Services as required by Code. Every aspect of this evaluation complied with Generally Accepted Government Auditing Standards (GAGAS).

### **Issue 1**

#### **Issue Summary**

The Medical Services Fund Advisory Council is a federally mandated advisory committee for the Bureau for Medical Services (BMS). The Council provides guidance to BMS in three areas, the primary area being health and medical services. The Council presently has 13 members. In addition, the Bureau for Medical Services regularly receives advice from the Council. The advice ranges from support of amendments to the State Plan to recommendations regarding policies and procedures. In addition, the Council operates at minimal expense to the State. The staff donated by BMS devotes a small percentage of time to the Council. Additionally, no member seeks travel reimbursement. Therefore, the Legislative Auditor concludes that the benefits provided by the Medical Services Fund Advisory Council exceed the costs and recommends that the Council be continued.

The Medical Services Fund Advisory Council is a federally mandated advisory committee for the Bureau for Medical Services.

#### Council is Required by Federal Mandate

The Legislature created the Medical Services Fund Advisory Council in 1953 to provide advice on disbursements from the Medical Services Fund. Then, in 1965, with the Title XIX Amendment (Medicaid) to the Social Security Act, the Legislature chose to use the Council as an advisory body to the state Medicaid agency as required by Title XIX. The governing federal rule is Code of Federal Regulations (CFR) §431.12, which states "a state plan must provide for a medical care advisory committee...to advise the Medicaid agency director about health and medical services."

The Council is organized under West Virginia Code §9-4-3, and may have 9 to 13 members. According to state Code, the heads of the public health and public welfare agencies are ex-officio members. However, the Code of Federal Regulations mandates that only the director of the public welfare department or the public health department be a member, so long as he or she does not head the Medicaid agency. The remaining membership must be medical professionals familiar with the needs of the low-income population, and members of consumer groups. The Council presently has 13 members as shown in Table 1.

# The Council Provides Useful Guidance to the Bureau for Medical Services

The Council is mandated to assist the state Medicaid agency in the establishment of rules, standards and bylaws.

According to state Code, the Council is mandated to assist the state Medicaid agency in the establishment of rules, standards and bylaws. Additionally, the Council also serves as a consultant to the state Medicaid agency by providing guidance on:

- 1) the Medical Services Fund;
- 2) disbursements from the Fund; and
- 3) health and medical services.

The mandates set forth in West Virginia Code §9-4-3 exceed the federal mandates, which require guidance on health and medical services. However, the state Code does not conflict with federal regulations.

The Medical Services Fund Advisory Council meets at the call of the state Medicaid agency, Council Chairperson, or upon written request of any 3 members. In addition, there is evidence that the Commissioner of the Bureau for Medical Services has called at least two emergency meetings in the last two

years. However, the Council usually meets approximately once every quarter. During quarterly meetings, the Council is updated on the Medicaid budget and recently on the Medicaid Management Information System (Unisys) progress, and is informed of pending State Medicaid Plan Amendments. In addition, the Council routinely makes recommendations to BMS and either supports or withholds support of State Plan Amendments. Recent motions adopted by the Council include:

- A recommendation that the Department of Health and Human Resources consider raising the dental fees up to 50% for doctor of emergency and oral surgery services.
- A three part recommendation during the October 8, 2004 meeting regarding the implementation of Unisys. According to the minutes, the Council recommended that 1) the Bureau for Medical Services have a list of issues with definitive dates and that the agency prioritize the issues based on impact; 2) the agency explore its legal options and cost recovery for both agency and vendors; and 3) decide if delivery is possible with a deadline by the end of December 2004.
- A recommendation during the January 14, 2005 meeting to remove the economic self-sufficiency criteria from the MR/DD Waiver Manual.

In addition to the formal recommendations made by the Council, it also offers useful advice. According to the Commissioner of the Bureau for Medical Services:

The Council is a valuable resource for myself and my staff as individual members of the Council bring important and unique perspectives to Medicaid policy issues.

### **Council Operates At Minimal Cost**

The Legislative Auditor requested an estimate of costs incurred by the Bureau for Medical Services staff who provide administrative support to the Medical Services Fund Advisory Council. However, the Department of Health and Human Resources was unable to provide such information. Given that the Council meets approximately 4-5 times per year during normal business hours, and that the Bureau for Medical Services provides staff for administrative support, it is likely that the State spends a few thousand dollars per year on

salaries. In addition, since membership in the Council is voluntary, members do not seek travel reimbursement. Furthermore, according to the Commissioner of the Bureau for Medical Services:

The cost to the Bureau for Medical Services (BMS) for providing administrative support to the Council is minimal, especially when compared to the value and necessity of the Council to BMS and the Medicaid community.

The cost to the Bureau for Medical Services (BMS) for providing administrative support to the Council is minimal.

#### **Conclusion**

The Council is required by federal mandate and is responsible for providing guidance to the Commissioner of the Bureau for Medical Services regarding health and medical services. The Council's advice comes in the form of recommendations regarding the Medicaid State Plan to recommendations regarding the Bureau's policies and procedures. In addition to providing advice, the Council operates at minimal expense to the State. The staff provided by the Bureau for Medical Services spend a small percentage of their time working for the Council and no member of the Council seeks travel reimbursement. Therefore, the Legislative Auditor concludes that the benefits provided by the Medical Services Fund Advisory Council exceed the costs and recommends that the Council be continued.

#### Recommendation

1. The Legislative Auditor recommends that the Medical Services Fund Advisory Council be continued.
