This memo is to recap our meeting yesterday, where you, Kim Ellis and I reviewed the expenditures related to your office. We discovered that some expenditures were made with state funds without your knowledge or consent. Neither Kim nor I were aware that these were personal items so we had not provided copies of the invoices to you for repayment. The items that we discovered are:

- Milo Baughman Sofa. This was purchased with state funds from Capitol Business Interiors on their invoice 57844 dated 09/25/13. The cost of the sofa was \$6,100.00. In a March 14, 2016 memo from Steve Canterbury, he indicated that the sofa was your personal property. This discrepancy was not known to any of us until yesterday. You indicated that wish to keep the sofa as your personal property, and will reimburse the state for the cost.
- Milo Baughman Armchairs. The chairs were purchased by Steve Canterbury (with personal funds) at auction on or around June 9, 2013. The shipping cost of the chairs was paid with state funds at cost of \$474.50.
- Milo Baughman Armchairs. The chairs were subsequently reupholstered by Window Fashions at a cost of \$2,790.00, also paid with state funds.
- Paul Legeard Coffee Table. Repair work on the finish of the coffee table was performed by Acme Brass Custom Plating, Inc. The cost was \$655.00 and was paid with state funds via Joan Mullins' purchasing card.

The total of the four items above is \$10,019.50. If you wish to reimburse the state for the cost of these items, I will note the reimbursement from you and ensure that these are not recorded as assets that belong to the court.

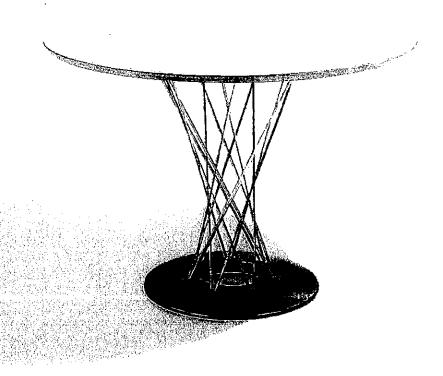

CYCLONE TABLES Conceived in 1953 as a rocking stool made of metal wire and wood, Noguchi's playful object was manufactured the following year in varying sizes, and later evolved into a table that became a companion piece to the Bertoia wire children's chair. At the suggestion of Hans Knoll, Noguchi's small table was enlarged to full size in 1957. Reintroduced by Knoll in collaboration with the Noguchi Foundation, the design is now meticulously produced from Noguchi's original drawings. The sculptural base consists of a column of chrome-plated steel wires set into a cast-iron black porcelain-finished foot. The top is available in white or black laminate. Dining and side table heights are offered.

ISAMU NOGUCHI The son of an American writer and a Japanese poet, Isamu Noguchi was born in Los Angeles in 1904. He spent his childhood in Japan and his adolescence in America. Noguchi's fascination with art began while he was a pre-med student at Columbia University. A Guggenheim Fellowship in 1927 took him to Paris, where he worked in Brancusi's atelier. Noguchi's interests were as wide ranging as his travels: He designed visionary sets and costumes for the Martha Graham Dance Company and New York City Ballet, furniture and objects for a variety of manufacturers, the Akari lamps and myriad environments, site installations and large-scale public sculptures of great note. The Noguchi Garden Museum in Long Island City, New York, is a repository of his work.
