Edwards, determined this meeting was properly noticed with the Secretary of State's office and a sufficient number of Board members were in attendance to constitute a quorum. The quorum was determined by the presence of Dr. Edwards, Dr. Marshall, Dr. Smith, Dr. Conard, Mrs. Dent, Mrs. Gribble, Dr. Paletta, Dr. Klenk, and Dr. Meadows. Therefore, the meeting of the West Virginia Board of Dental Examiners was called to order.

The first order of business was the meeting notice to the Secretary of State which was distributed for information purposes only.

The next order of business was the approval of minutes from the April 2009 meeting and the June 2 and 15, 2009, meetings. Upon motion by Dr. Richard D. Smith, and properly seconded by Dr. Craig L. Meadows, and unanimously passed, the minutes were approved as distributed.

At this time, the President announced the need for an Executive Session to consider matters under provisions contained in Chapter 6, Article 9A, Section 4, not limited to, but primarily for those contained in Subsections (4) and (6).

Upon motion by Dr. Craig L. Meadows, and properly seconded by Mrs. Dolores L. Gribble, and unanimously passed, the Board went into an executive session. Thereafter, the Board came back into a general session upon motion by Dr. George D. Conard, Jr., and properly seconded by Mrs. Debra D. Dent, and unanimously passed, where upon the following matters were discussed and/or acted upon.

The next order of business was the proposed coronal polishing course requirements. Upon motion by Dr. Richard D. Smith, and properly seconded by Dr. George D. Conard, Jr., and unanimously passed, the Board adopted the course requirements with the following amendments:

The first paragraph requiring the course to be taught at an ADA accredited institution is to be deleted and the number of hours of course work will be changed from 6 to 3.

Upon motion by Dr. Michelle G. Klenk, and properly seconded by Dr. George D. Conard, Jr., and unanimously passed, the staff will send a letter regarding the board's actions today concerning the course requirements and the billing of coronal polishing by assistants.

Dr. Craig L. Meadows was appointed by the President to review course approval requests for coronal polishing.

The next order of business were the recommendations from the West Virginia Dental Association concerning collaborative agreements. Upon motion by Dr. Michelle G. Klenk, and properly seconded by Dr. Richard D. Smith, and unanimously passed, the document was opened up for discussion. Thereafter, and upon motion by Dr. George D. Conard, Jr., and properly seconded by Dr. Diane Paletta, and unanimously passing, the Board approved the document to be presented as an interpretive rule or guidelines.

At this time, the President announced the need for an Executive Session to consider matters under provisions contained in Chapter 6, Article 9A, Section 4, not limited to, but primarily for those contained in Subsections (4) and (6).

Upon motion by Dr. Richard D. Smith, and properly seconded by Mrs. Debra D. Dent, and unanimously passed, the Board went into an executive session. Thereafter, the Board came back into a general session upon motion by Dr. George D. Conard, Jr., and properly seconded by Dr. Craig L. Meadows, and unanimously passed, where upon the following matters were discussed and/or acted upon.

The next order of business was a discussion concerning the Board's membership in the Council of Interstate Testing Agencies (CITA) and appointments of voting members and members to the Board of Directors. Upon motion by Dr. Craig L. Meadows, and Mrs. Debra D. Dent, and unanimously passed, to make appointments to the Board of Directors and as the voting members, Dr. George D. Conard, Jr., and Dr. Michelle G. Klenk were appointed.

The next order of business was the membership invitation to the Central Regional Dental Testing Service (CRDTS) and Western Regional Examining Board (WREB). A motion was made by Dr. Richard D. Smith, and properly seconded by Dr. George D. Conard, Jr., to join both CRDTS and WREB and further, moved to divide the question for a separate vote on each agency. The first vote to join CRDTS passed by a majority. The second vote to join WREB passed by a majority.

The next order of business was a decision in case # 2009-DB-0022D. Upon motion by Dr. Richard D. Smith, and properly seconded by Dr. Craig L. Meadows, and unanimously passed, the Board approved a Consent Decree in this matter.

The next order of business was a decision in case # 2008-DB-0020D. Upon motion by Dr. Craig L. Meadows, and properly seconded by Dr. Michelle G. Klenk, and unanimously passed, the Board approved a Consent Decree in this matter.

The next order of business was a decision concerning application # 2009-004. Upon motion by Dr. Richard D. Smith, and properly seconded by Mrs. Debra D. Dent, and unanimously passed, to deny the application for licensure as the applicant does not meet licensure requirements.

The next order of business was a decision in case # 2005-DB-0017D. Upon motion by Dr. Michelle G. Klenk, and properly seconded by Dr. Craig L. Meadows, and passing by majority, the suspension of the license in this matter shall remain stayed except for 120 days. The licensee shall not engage in the business or practice of dentistry during the suspension period and must appear before the board at one of its regularly scheduled meetings, but no sooner than the January 2010 meeting, before being reinstated. The licensee shall not prescribe, dispense or administer any scheduled controlled substances until he personally appears before the board and is granted permission by the board to resume prescribing, dispensing or administering any controlled substances.

The next order of business was the approval of all other recommendations made during executive session. Upon motion by Mrs. Debra D. Dent, and properly seconded by, Dr. Craig L. Meadows, and unanimously passed, all recommendations made during executive session were approved.

#### November 6, 2009

Edwards, determined this meeting was properly noticed with the Secretary of State's office and a sufficient number of Board members were in attendance to constitute a quorum. The quorum was determined by the presence of Dr. Edwards, Dr. Marshall, Dr. Conard, Mrs. Dent, Mr. Ford, Dr. Klenk, Dr. Meadows, Dr. Paletta and Dr. Smith. Therefore, the meeting of the West Virginia Board of Dental Examiners was called to order.

The first order of business was the meeting notice to the Secretary of State which was distributed for information purposes only.

The next order of business was the approval of minutes from the July, 2009 meeting and the September 3, and September 28, 2009, meetings. The minutes were approved by general consensus.

The next order of business was appointments made by the Governor. Dr. David G. Edwards was appointed to a second next term and Mr. William E. Ford, III, was appointed as the consumer member.

The next order of business was a discussion concerning dermal fillers and botox, which included letters from the American Academy of Facial Esthetics and Facial Rejuvenation Injection Training Seminars, information regarding the policies of other state dental boards and a draft policy for consideration.
