FUNCTIONS OF THE STATE BOARD OF ARCHITECTS

The functional objectives of the State Board of Architects are to administer the provisions of the West Virginia Laws, Rules and Regulations governing the profession of Architecture in such a manner as to protect the public's health, safety and welfare.

The program of this agency can be generally classified into Administration and Enforcement. The Administrative functions include the following:

1. Process and qualify applications for licensees
2. Issue licenses to qualified applicants
3. Investigate formal complaints filed
4. Conduct hearings for possible suspension or revocation of License
5. Renew licenses annually

The State Board of Architects consists of five registered professional Architects and two lay members, each Board Member being appointed by the Governor of West Virginia and with the consent of the Senate of the West Virginia Legislature for terms of five years or until their successors are named.

When an exam candidate has completed the ARE Exam and stated WV as his/her state of registration, his/her initial application to practice architecture is then submitted to the board to be registered.

Formal Complaints Filed: 0

3 inquiries were submitted to the board to be investigated for unlicensed practice of architecture or for offering architectural services when they do not have an architect registered with the board.

The assistant Attorney General for the board along with the board members investigated inquiries. One inquiry was mailed a letter from the AG of Cease and Desist the use of the person for architecture services as he was not a registered architecture.

The 2nd inquiry was found not to be in violation of the practice of architecture by their services or name of their firm. They clearly stated they rendered drafting and drawing services only and not architectural services.

The 3rd inquiry removed the word architect/architecture from the title of its firm at the request of the Board's Cease and Desist Letter.

Inquiries were not formally filed as complaints and therefore were not formal complaints to be filed with the board office.
