**Board Suit:**

The Board Office has been notified by counsel, Perry Oxley, from Anspach Law Firm, that the pending suit against HOPE Clinic, John Pellegrini, D.O. and the WV Board of Osteopathic Medicine has been filed. The Board has not yet been served but is working with Mr. Oxley in preparing the defense.

**NEW BUSINESS:**

**Executive Director Report:**

**Revision to Lease:**

The renewal lease agreement for office space with Neyer Management does not expire until November 2015. The additional \$55 for parking for a new employee will be added to the budget as a "miscellaneous" charge until the new leasing contract is negotiated. **(Rubin/Whitler)**

**2014 Policy Reviews:**

The Safety Policy and Confidentiality Policy were reviewed by all Board members present and confidentiality statements were signed.

**Board Investigator Contracts:**

The Executive Director received a resume from a trained investigator expressing interest in doing work for the Board. He is currently a WV state vendor for his services and has hospital administration experience. Board approved signing a contract with Michael Hall as a back up investigator. **(Whitler/Muscari)**

**Licensing of Pain Management Clinics:**

The Board has been notified that WVDHHR's Office of Health Facility Licensure and Certification (OHFLAC) will begin requiring licensure of those physician practices that primarily treat patients for chronic pain as of July 1, 2014. The Board was also asked by OHFLAC to identify those practices known to the Board as chronic pain clinics. A letter will be forwarded to Jolynn Marra, Director of OHFLAC, with a physician listing with a caveat that this is not a complete listing as the Board has no way of knowing all physician offices who would meet the pain clinic definition.

**Legislative Rules:**

The proposed changes to the PA Rule 24 CSR 02 have been out for public comment. Three comments have been received; two positive and one negative. The Executive Director responded to the questions posed in the negative comment, but the physician continued to speak against the revisions. These will be reported during the Legislative Review.

MedExpress submitted requests for additional work sites for six osteopathic physicians. All have current licenses and have renewed their CSL's.

**T. Lauderman, D.O.:**

Before he renewed his 2014 license, Dr. Lauderman requested his probationary status be lifted. He has met all the requirements of the Consent Agreement. Motion made and approved to lift the probationary status on Dr. Thomas Lauderman. **(Rubin/Whitler)**

**License Renewal Update:**

With only four days left in the 2014 license renewal period, there are still 140 physicians who have not yet renewed their WV license. The Board Staff has made reminder phone calls and sent reminder emails to those licensees with current contact information.

**Executive Director Report:**

**Licensure Analyst:**

The Board previously approved a temporary, full time position for a licensure analyst to assist the Board during high volume license renewal period. The Executive Director requested that position be made full time, permanent. Motion was made to make the temporary position, permanent. **(Whitler/Schreiber)**

**Expert Witness Invoice:**

The Board received an invoice from Jason Pope, M.D. for \$22,575 in conjunction with his time spent on the Phillip Fisher, D.O. hearing. As this is an excessive amount, the Board requested a full accounting, day by day and month by month of the time spent on the case at \$300 per hour. Future contracts will reflect a cap on any given case.

**FSMB Board Attorney Workshop & CMBI:**

The Annual Board Attorney Workshop is being held in Savannah, Georgia on October 23 – 24, 2014. Approval was given for Ms. Akers to attend. The CMBI workshop is scheduled for November in Baltimore, Maryland. Mr. Kidd has already re-certified.

**Pharmacy Rules:**

A copy of the proposed joint revisions to the pharmacist immunization rules in Title 15, Series 12, to allow pharmacy interns to give meningococcal vaccines with a Pharmacist present, was presented to the Board prior to going to the Legislative Rule Making Committee. No changes were recommended.

**Office Lease:**

The current five-year lease with Neyer Management for the office space for the Board is up for renewal in November 2014. A new lease agreement has been presented to the Board for approval. The only increase is the \$55.00, per month, added for a fourth parking space. Motion was made to approve the new five year lease and submit to the West Virginia State Real Estate Division for approval and processing. **(Schreiber/Whitler)**

**Uniform Application:**

The Federation of State Medical Boards has assured the Board that grant money is available for the implementation of the Uniform Application with the West Virginia Board of Osteopathic Medicine. The Executive Director was advised to follow up with Big Picture for a projected cost and then apply to FSMB for a grant. **(Whitler/Muscari)**

**Complaint Filed Against Board Counsel:**

A complaint has been filed with the Office of Disciplinary Counsel by a former witness in the Phillip Fisher, D.O. hearings. The complaint is against the Board's counsel, Ms. Akers. If Attorney General's Office does not provide legal counsel for their employees and Ms. Akers was acting as a representative of the Board, this should be reported to BRIM, our insurance carrier. Motion made to contact BRIM about possible legal representation for Ms. Akers, as may be needed. **(Whitler/Schreiber)**

Additional information was obtained following Dr. Sutherland's interview with the full Board at our June 26<sup>th</sup> meeting. His application still reflects a "No" answer to question #1. Upon correction and written explanation to question #1, Dr. Sutherland will be issued a license. **(Muscari/Schreiber)**



**Brian McDevitt, D.O.** Current Consent Order for reinstatement requires the completion of a CPEP assessment or a comparable assessment. Dr. McDevitt has concerns over the osteopathic representation within the multiple choice section of the evaluation. CPEP has confirmed that NBME designed and scored the multiple choice portion of the assessment. Motion was made to allow Dr. McDevitt to sit for the Convex exam in place of CPEP. However, results of the CPEP assessment must be released to the Board before approval of license reinstatement. **(Whitler/Muscari)**

**Phillip Fisher, D.O.:** A hearing was held in the 4<sup>th</sup> Floor Conference Room at 405 Capitol Street from the last week in July through first week of August. We are awaiting the completed transcripts for each counsel to submit their Findings of Fact and Conclusions to the Administrative Law Judge.

The Board moved into Executive Session at 4:35 PM with the Executive Director and Board Counsel present. **(Schreiber/Whitler)**

Motion was made to move back into Public Session at 5:10 PM. **(Whitler/Schreiber)**



Motion was made to accept the wording in the policy being proposed by the WV Board of Medicine with the addition of the Definition found in the FSMB Model Policy:

Telemedicine is not an audio-only, telephone conversation, email/instant messaging conversation, or fax.

With the inclusion of the above added definition, the Board approved the Telemedicine Policy drafted by the WV Board of Medicine. **(Whitler/Muscari)** Dr. Schreiber abstained from voting.

**Interstate Licensure Compact:** After hearing Jonathan Jagoda's presentation, there was much discussion about the interstate compact. Concerns were raised regarding the standards for a compact license being higher than that for licensing with either the West Virginia Board of Medicine or the West Virginia Board of Osteopathic Medicine. Also, no mention of Complex versus USMLE. Motion was made to support the presentation of the Interstate Compact License to the West Virginia Legislature in 2015. **(Blatt/Whitler)** Motion was withdrawn for lack of consensus.

**Executive Director Report:**

**Update on Interstate Compact:** Nine state legislatures have now approved the Medical Interstate Compact concept, therefore, the Commission can begin its work in Establishing policies, procedures and bylaws. A national press conference has been scheduled in Washington, D.C. on June 24, 2015. Both WV licensing boards have been invited to participate. Motion made for Executive Director to attend the Press Conference as the Board's representative. **(Whitler/Schreiber)**

- WVU List Request:** Original physician listing request was received by Board Office in February. No action to date.
- Lobbyist Contract:** Current quarter will expire at end of June. Board elected not to renew the contract.
- CSMP Review Committee Nominee:** A request was received from the Executive Director of the Board of Pharmacy requesting an osteopathic physician be nominated by the WV Board of Osteopathic Medicine for the vacancy left by the retirement of C. Clark Milton, D.O. Because of potential conflict of interest with filing of complaints from the CSMP, the Board did not place a nomination. It should come from West Virginia Osteopathic Medical Association.
- Board Staffing:** A resignation had been received from the Administrative Assistant in May, but she asked to return to her position after being gone for only one week.
- Moral Character Requirements:** The Board discussed the necessity of requiring Moral Character References for residents after their first year of internship. The recommendation letter should be adequate if completed by the Residency Director. The Executive Director is asked to develop a form incorporating the residency recommendation and the moral character reference into one document beginning July 1, 2016.
- Policies/Procedures:** The following policies were presented for review:
- 1) Telemedicine Policy: Senate Bill 334 was presented during the 2015 session of the West Virginia Legislature. This bill outlined changes to the WV Code to include telemedicine practice, requirements, exceptions, definitions and rulemaking. However, the bill died in committee leaving the WV Board of Osteopathic Medicine with no statutory reference to telemedicine. A guideline was drafted which incorporated portions of that bill and the model policy for telemedicine provided by the Federation of State Medical Boards. The guideline was tabled until all members had opportunity to review the material.
  - 2) Purchasing Card Policy/Procedures: A revised P-Card Policy was presented for review. With the addition of travel expenses being added to the Board's Purchase Card, the policy needed to have the travel provisions added to it. The policy was signed by the Chief Financial Officer.
  - 3) Confidentiality Policy: The Confidentiality Policy was reviewed and all Board Members signed their Confidentiality Statements for 2015-16.
  - 4) Safety Policy: The Safety Policy was presented for the annual review. All departmental safety checks have been conducted and will be reported through the BRIM Loss Control Survey for 2015.
- Licensing Issues:** Six (6) dispensing requests were received for Osteopathic Physicians. All have current Controlled Substance Licenses and all dispensing sites were approved. The Board requested written explanation from MedExpress as to how the recent buyout by Optum will affect dispensing contracts.
- MedExpress:**
- Collaborative Pharmacy Practice Agreements:** Since the pilot programs in 2008, the Board has not received an application for a Collaborative Pharmacy Practice Agreement and an application had not been developed for such a license. However, in 2015 a request has been received by the Board from a Pharmacist to enter into a Collaborative Pharmacy Practice Agreement with Charleston Internal Medicine Group which has several Osteopathic Physicians working in the practice. An application form should be developed and provided to the first applicant according to 11 CSR 8.



**Physician Assistants Without DEA's:** If a physician assistant applicant does not provide a DEA, the PA is not given prescriptive privileges. A DEA is currently required by Legislative Rule for prescriptive privileges, regardless of whether the PA will be prescribing any controlled substances.

The Board moved into Executive Session at 3:30 PM with the Executive Director and Board Counsel present. **(Rubin/Whitler)**

**Lonnie Sipsy, D.O.:** Dr. Sipsy let his West Virginia license lapse in June 2006. There no complaints or disciplinary actions pending at that time. Dr. Sipsy can apply for re-instatement of his WV license with the understanding that his WV license will be with a Consent Order. **(Rubin/Whitler)**

**Cheri Gryskevich, D.O.:** Dr. Gryskevich let her West Virginia license lapse in June 2006 while two complaints were pending. The complaints were dismissed without prejudice as she never reapplied for her West Virginia license. Those complaints will be re-opened if she applies for reinstatement. As Dr. Gryskevich has not been practicing medicine since 2006, the Board outlined several requirements before the application process can be considered. Those include: Comvex, OSCI Prep Course at WVSOM, Psychiatric and General Medical Evaluations conducted by Board-approved physicians. **(Rubin/Muscari)**

**Edward Riley, D.O.:** Dr. Riley met with the Board today via conference call to answer questions regarding his application. The Board considered this his interview and approved his application for full, unrestricted license. **(Whitler/Schreiber)**

**Next Meeting:** The Board will have its next meeting in Parkersburg, West Virginia at the Blennerhassett Hotel. The meeting will begin at 10 AM on September 17, 2015.

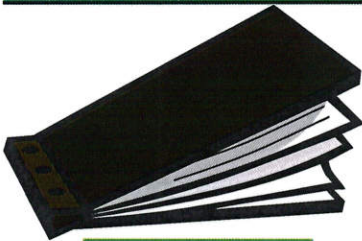

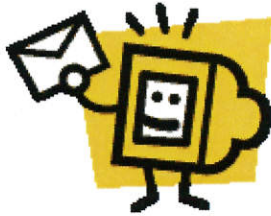

Just a reminder that the WV Medical Professionals Health Program is available to physicians, surgeons and other healthcare professionals in the State of West Virginia. Their mission is to help identify, refer for evaluation and/or treat and monitor the recovery of healthcare practitioners who have a mental or addictive illness, which could potentially affect their ability to practice with reasonable skill and safety. WVMPPH is the only recovery treatment/monitoring program authorized and financially supported by both physician licensing boards in West Virginia and is a nationally-recognized program. Confidentiality is protected to the maximum extent provided by existing State and Federal law.

As outlined in §24-18.3, any licensee is required to report any known or observed behavior of a licensed colleague who has been unable to practice medicine with reasonable skill and safety to patients by reason of illness, drunkenness, excessive use of alcohol, drugs, chemicals or any other type of substance, or by reason of any physical or mental abnormality or they, too, will be in violation of the rule.

## Legislative Rule Changes 2014

While the WV Board of Osteopathic Medicine did not intend to request changes to their Legislative Rules in 2014, there are changes to the WV Code that will affect Physician Assistants licensed in West Virginia. Both the WV Board of Medicine and the WV Board of Osteopathic Medicine license physician assistants. Which Board the PA will be licensed with is determined by who is named the primary supervising physician. If it is an Osteopathic Physician, the PA will be licensed by the Osteopathic Board. If the primary supervising physician is an Allopathic Physician, the PA will be licensed by the Board of Medicine.

In order to make the licensing of PA's in West Virginia easier and less complicated, the two medical licensing boards have recommended the creation of a new section of the Code, Article 3E. This authorizes both Boards to license and discipline Physician Assistants based on who is named the Primary Supervisor. It will allow for both MD's and DO's to serve as alternate supervising physicians, with the full responsibility

of the Physician Assistant assigned only to the primary supervising physician.

This has been a collaborative effort by both medical licensing boards to insure there is no delay or obstacle placed upon Physician Assistants becoming licensed by either Board. It will streamline the administrative application process for PA's practicing in West Virginia and, at the same time, clarify the due process rights and disciplinary sanctions that each licensing board is authorized to administer.

Once the WV Legislature has approved the Code change and the Governor has signed the bill, Emergency Rules will be developed and sent to the Legislature for approval. Please check our website, [www.wvbdosteo.org](http://www.wvbdosteo.org) for all legislative updates. The Physician Assistant rule will be identified under Series 2.

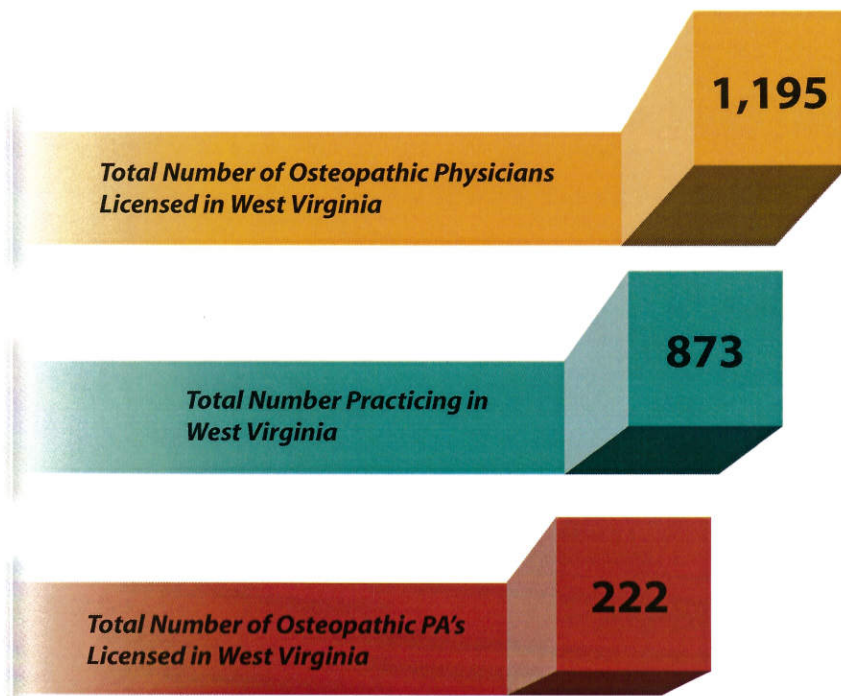

## QUESTIONS/ANSWERS FROM MID-WINTER CONFERENCE

During Dr. Arthur Rubin's presentation on the state pain prescribing regulations, several questions were raised. The Board felt it may be helpful to print those questions and answers for all to read.

1. You are the physician of record for an established patient for whom you have been prescribing opioids. You have accessed the Pharmacy Data Base and placed copies of your patient's Rx's in the chart as required along with everything else you are supposed to do. The patient has decided for whatever reason to transfer their care to another physician and has signed a release of records to send the chart to Dr. X. Should the pharmacy data base report that is in the patient's chart be sent with the rest of the records?

**YES**, anything medically related is the property of the patient and should be made available to him/her per signed release.

2. Mr. Jones calls a physician's office to come as a new patient. He has not signed any releases or completed any screening documents your office may have regarding insurances, etc. Is a physician allowed to run a report on Mr. Jones from the Pharmacy Data Base as a screening mechanism for accepting him as a patient if he is not yet established?

**NO**, this would violate §60A-9-7(f) which states such unauthorized access...of the information in the database is a felony punishable by imprisonment in a state correctional facility for not less than one year nor more than five years or fined not less than \$3,000 nor more than \$10,000, or both imprisoned or fined.

3. You are a physician who is advertising for a front desk receptionist. Mary has applied for the job. She is not an established patient in your practice. She has sent her CV but has not signed any releases or references yet. Are you allowed to access a report on Mary from the Pharmacy Data Base as a screening tool for whether you will interview and subsequently hire Mary?

**NO**, this would violate §60A-9-7(f) which states such unauthorized access...of the information in the database is a felony punishable by imprisonment in a state correctional facility for not less than one year nor more than five years or fined not less than \$3,000 nor more than \$10,000, or both imprisoned or fined.

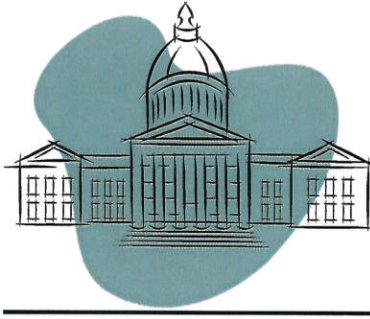

### NEW THIS RENEWAL CYLCE

With the Emergency PA Rule which went into effect June 6, 2014, Physician Assistants MUST have a Practice Agreement, completed and signed by the PA and the Supervising Physician. This is in place of your Privilege List and Prescriptive Authority, both of which are included in the Practice Agreement.

**EVERY PHYSICIAN ASSISTANT RENEWING IN 2015 MUST COMPLETE AND SUBMIT A PRACTICE AGREEMENT. IF NOT, YOUR RENEWAL APPLICATION WILL BE CONSIDERED INCOMPLETE AND YOUR LICENSE WILL NOT BE RENEWED.**

This has been a collaborative effort by both medical licensing boards to insure there is no delay or obstacles placed upon **Physician Assistants** becoming licensed by either Board. It will streamline the administrative application process for PA's practicing in West Virginia and, at the same time, clarify the due process rights and disciplinary sanctions that each licensing board is authorized to administer.

The WV Legislature approved the Code change and the Governor signed the bill on June 6, 2014. Emergency Rules have been implemented and sent to the Legislature for final approval. Please check our website, [www.wvbdosteo.org](http://www.wvbdosteo.org) for all legislative updates. The **Physician Assistant** rule will be identified under Series 2.

Also new in this rule, will be the creation of a Practice Agreement. This will replace the Privilege List and Prescriptive Authority forms found in the old PA Application. A Physician Assistant can obtain a license as soon as they complete their education and pass the NCCPA boards. However, they cannot work until a Practice Agreement has been completed and signed by both the PA and the Supervising Physician.

All practitioners holding a current WV Osteopathic License are required to complete 3 hours of Board-Approved CME on Pain Prescribing and Drug Diversion Training before each renewal period. Check the Board's website, [www.wvbdosteo.org](http://www.wvbdosteo.org) for all Board-Approved CME offerings. If it is not listed on the Board's website, it has NOT been approved by the Board.

Any practitioner licensed after July 1, 2014, must complete the 3 hour CME on Pain Prescribing and Drug Diversion within the first year of licensure. That includes all Osteopathic Physicians and Physician Assistants whose license issue date is **July 1, 2014** or later.

No other CME programs will be accepted other than those listed on our website. Pay particular attention to the marketing brochure when registering for a CME program. If it does not say it was approved to meet the 3 hour requirement by the WV Board of Osteopathic Medicine, we will not be able to give you credit for it. 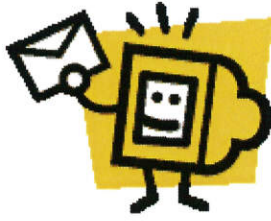

## Quick Notes for Providers

### EBOLA

- All ill patients should be questioned about a travel history. Specifically looking for travel to Liberia, Guinea, Sierra Leone and Nigeria, as well as the Democratic Republic of Congo.
- It would include contact with friends or family that have traveled to these areas as well for the preceding 21 days.
- Ebola incubates for 2 to 21 days; average is 8 to 10 days
- A patient is not contagious until symptomatic
- Symptoms include fever, muscle aches, vomiting, diarrhea, abdominal pain and unexplained hemorrhage
- Ebola is spread through direct contact with blood or bodily fluids of a contagious patient. It is not spread through the air, in water or in food
- Ebola is killed with hospital grade disinfectants
- Ebola virus dried on surfaces such as doorknobs and countertops can survive for several hours. Ebola in bodily fluids can survive days at room temperature
- Treatment is supportive. Basic interventions tremendously improve survival. They include IV fluids, balancing electrolytes, maintain oxygen levels and blood pressure and treating other infections.
- Report all suspected cases to your local health department and the Bureau for Public Health at 1(800) 642-8244.
