West Virginia Board of Funeral Service Examiners BOARD MEETING February 6, 2012

The meeting was called to order at 1:06 pm, by President Chad Hutson. Members present: John Stump, Keith Kimble, Chad Hutson, Chad Harding, nonmembers present Regina Foster, Administrative Assistant and Constance Sloan, Executive Director. Raymond Tomassene and Sarah Lobban were present via telephone.

Chad Harding moved to go into Executive Session pursuant to WV Code 6-9-4(4), seconded by Raymond Tomassene. The motion carried unanimously.

On motion of John Stump, seconded by Chad Harding, the Board voted to return to public session.

The Board then moved to the recommendations of the Complaint Committee as follows:

Complaint 2011-07

Complaint alleges unprofessional conduct by funeral director and complainants are upset they were not put in the lead car. Funeral Director responded about complaint, states he spoke to complainant who called concerning price for direct cremation and informed the Funeral Home that the Father had no money and the children were financially unable to pay, she said Father's girlfriend and her daughter would be making the funeral arrangements. The day of the funeral the funeral director went over parking arrangements and put the girlfriend of the deceased in the lead car due to her need for assistance in walking to the cemetery. He tried to explain this to the children and son of the deceased almost attacked him. To sum it up it appears there has been a breakdown in communication between the complainants and the person they authorized to make the funeral arrangements.

The Complaint Committee found that the funeral director has not violated any rules or regulations and recommends the Complaint be dismissed.

Complaint 2011-08

Complaint alleges unprofessional conduct by funeral director. Complainant made contact with funeral director regarding some changes to a prepaid cremation. Funeral director quoted a price to her and she responded the price seemed more expensive than expected. Complainant stated funeral director immediately responded with unprofessional manner towards her, although he did apologize after the occurrence. The next day the complainant went to the funeral home to express her opinion and see the funeral director in person. Complainant did not respond to answer from the funeral director.

The Complaint Committee feels that the actions by the funeral director do not rise to the level to warrant disciplinary action and recommends the Complaint be dismissed.

However the Complaint Committee feels the Board should advise the funeral director in a letter that his comments were inappropriate and reflect badly on the entire funeral profession and will be warned against similar conduct in the future.

Complaint 2011-09

Complainants allege they met with the funeral director April 2010 regarding funeral services for the deceased. Complaint says they discussed their options initially providing and insurance policy but it had no value. Later the funeral bill appeared on complainant's credit report. It appears there was no follow up with DHHR by the parties complaining. Nothing was ever paid on the bill; subsequently the corporate office reported the bill delinquent. Complainants want the credit bureau report removed. In reviewing the documents provided by the funeral director the Complaint Committee does not feel the funeral director has violated any of the Board's laws or regulations. This Board has no authority to require the corporate office to withdraw any information

Keith Kimble moved that the Board accept the recommendations of the Complaint Committee. The motion was seconded by Raymond Tomassene and carried unanimously.

The Minutes of the Meeting held October 18, 2011 were discussed. The minutes were unanimously approved on motion of Chad Harding, seconded by Raymond Tomassene.

The Financial reports for September, October, November and December of 2011 were unanimously approved on motion of Chad Harding, seconded by Raymond Tomessene.

On motion of Chad Harding, seconded by Sarah Lobban, the Purchase Card reports for October, November and December of 2011 were unanimously approved.

The Board then considered the approval of Consent Decree in Complaint 2011-05 the Consent Decree was unanimously approved on motion of Chad Harding, seconded by Raymond Tomessene. Consent decree signed by President Chad Hutson.

The Board then entered into discussion of the payment of bill from AG for responding to Board's letter to dismiss Complaint 2009-10. The Board did not ask for a response from the AG. On motion of Raymond Tomessene, seconded by John Stump the Board decided not to pay the bill at this time.

The Board discussed approval to reduce number of OSHA hours from 4 to 2 every two years. The Board voted to make no changes at this time. This was unanimously approved on motion of John Stump, seconded by Chad Harding.

West Virginia Board of Funeral Service Examiners SPECIAL MEETING VIA TELEPHONE CONFERENCE April 25, 2012

The Board of Funeral Service Examiners met in Special Session, via telephone conference on April 25, 2012, at 9:00am for the purpose of discussing and acting on the recommendations of the ALJ in Complaint No. 2010-08.

The meeting was called to order at 9:06 pm, by President Chad Hutson. Members present: John Stump, Keith Kimble, Chad Hutson, Chad Harding, Raymond Tomassene and Ira Handley. Nonmembers present, Constance Sloan, Executive Director. Mr. Hutson advised the members present that the only business to be discussed was the matter of acting on the recommendations of the ALJ in Complaint No. 2010-08 and that the Board had the option of accepting in whole or in part the recommendations, to reject the recommendations, or to alter amend the recommendations.

The members discussed the Recommendations of the ALJ in length. Ira Handley moved that the Board accept the recommendations of the ALJ but that the funeral home be given 30 days from the date of entry of the Order to obtain the licensed funeral director to act as Licensee in Charge and the suspensions of the funeral directors= licenses and the funeral home license will be effective 30 days from the entry of the Order.

Keith Kimble asked that the Board also require the funeral home provide documentation from the State Tax Department that they have a current business license and also to provide documentation from Unemployment that they are either current with that agency or that they are not required to be covered by Unemployment Compensation and that the funeral home be placed on probation for a period of one year and be required to operate under the supervision of a licensed funeral director who is not under any disciplinary restrictions, limits or probationary terms imposed by this or any other professional licensing authority.

Mr. Hutson added that the order state that the Board will furnish Myers with a Statement of costs to be reimbursed and that the funeral home shall pay those costs within thirty days of receiving the statement.

John Stump moved that the motion of Ira Handley with the amendments made by Keith Kimble and Chad Hutson be adopted. The motion was seconded by Raymond Tomassene and each Board member voted in the affirmative.

The Executive Director was directed to advise the Board=s attorney of the Board=s decisions and that he prepare an order reflecting those decision.

On motion of Chad Harding, seconded by John Stump, the Board adjourned.

West Virginia Board of Funeral Service Examiners BOARD MEETING Stonewall Jackson Resort June 11, 2012

The meeting was called to order at 1:00 p.m. by President Chad Hutson. Members present: Chad Hutson, John Stump, Keith Kimble, Ira Handley and Raymond Tomassene. Non members present, Constance Sloan, Executive Director and Regina Foster, Administrative Assistant.

Raymond Tomassene moved to go into Executive Session pursuant to WV Code 6-9-4(4), seconded by John Stump. The motion carried unanimously.

On motion of Raymond Tomassene, seconded by Ira Handley, the Board voted to return to public session

The Board then moved to the recommendations of the Complaint Committee as follows:

COMPLAINT 2012-02

5/14/12 Complainant states that she got death certificate and to dismiss the complaint.

COMPLAINT 2012-03

This complaint was filed by a former employee who alleges several problems at the funeral home as follows:

- 1. A preneed sales person is making at need arrangements
- 2. Passed off "scratch & dent" caskets to consumers who were not advised they were damaged caskets
- 3. Medical waste is improperly disposed of
- 4. Food consumption within 15 feet of prep room
- 5. Desecration of a deceased (photos attached)
- 6. Failure to allow the complainant medical leave

The funeral home responded saying:

- 1. preneed counselors do perform at need duties "under the direct supervision of a funeral director."
- 2. When they offer damaged caskets the same are inspected and approved by the purchaser

- 3. denies that medical waste is disposed of improperly
- 4. the funeral homes does not prepare any food on the premises but families are permitted to bring in already prepared food and refreshments. The family lounge and adjacent room are not adjacent to or used as an exit from the prep room.
- 5. the hairdresser who was to do the hair of the deceased (the subject of the photos) states in a letter attached to the response that she did not witness the act complained about
- 6. provided copy of letter to complainant relating to his claim for medical leave of absence

There is nothing in this complaint that can be substantiated. Further, as to the photos of the deceased, complainant stated he took them on his cell phone and that no one but him knew of the photos. However, the hairdresser who came shortly thereafter states that the photos she was shown do not depict the condition of the deceased when she went in to do the hair.

The Board has nothing to do with family medical leave, that is between the complainant, the funeral home and the department of labor. As there is nothing to substantiate the allegations in this complaint, the Complaint Committee recommend that it be dismissed.

COMPLAINT 2012-04

This complaint is being made against a funeral home by a competitor funeral home and alleges that the competitor placed a death notice in the local newspaper which said arrangements were incomplete at complainant's funeral home. The following day a complete obituary was in the newspaper and this time listed the competitor's funeral home as being where arrangements were made. The complaint also alleges that at the same time three preneed contracts transferred to the competitor's funeral home and blames the obituary notices as being the scheme which caused the transfers.

The complaint wanted the matter referred to the Cabell County Prosecuting Attorney for investigation of identify theft (which has been done) and that Roy Terry should be banned from working or being affiliated with any other funeral homes now or in the near future. Ralph Layton was also advised of the preneed transfers in the event there is a violation of the preneed laws.

The competitor funeral home responded stating that Roy Terry who was once employed by the other funeral home is now employed at the competitor funeral home and that Mr. Terry simply acted out of "habit" when he placed the first obituary notice. The three preneeds that transferred were close friends of Mr. Terry and wanted their funerals at a funeral home he was affiliated with.

If there is any criminal conduct in this case, that is the Prosecutor's job and the Board has no authority in that area. Likewise, violations of the preneed act fall under the Attorney General. It appears that the use of the competitor's name in the first, incomplete, obituary was an error.

The Complaint Committee recommends that complaint be dismissed and that the Board send the funeral home a letter asking them to be more careful in the future.

Raymond Tomassene moved that the Board accept the Complaint Committee recommendations; the motion was seconded by Keith Kimble and carried unanimously.

The Minutes of the Meetings held February 6, 2012 and April 25, 2012 were unanimously approved on motion of Raymond Tomassene, seconded by Ira Handley.

The Financial Reports for January, February, March and April 2012 were unanimously approved on motion of Raymond Tomassene, seconded by John Stump.

On motion of Raymond Tomassene, seconded by Ira Handley, the Purchase Card reports for January, February, March and April 2012 were unanimously

The Board next discussed the renewal of the lease for its office space and on motion of Ira Handley, seconded by Raymond Tomassene, the Board unanimously approved the renewal of the lease for the period July 1, 2012 to June 30, 2013.

The Board then discussed conducting continuing education seminars at five (5) different locations around the state, those being proposed are Morgantown, Parkersburg, Charleston, Flatwoods and Beckley. On motion of Keith Kimble, seconded by Raymond Tomassene, the Board voted to conduct such seminars and instructed the Executive Director to continue to finalize the plans for the same.

The next matter on the agenda was salary increases for the Executive Director and Administrative Assistant. On motion of Raymond Tomassene, seconded, by John Stump, the Board voted to give a five percent (5%) raise to the Executive Director, Constance Sloan, and the Administrative Assistant, Regina Foster, effective July 1, 2012.

The Board then moved to election of officers for the coming year. On motion of Raymond Tomassene, seconded by Ira Handley, the Board voted unanimously to continue the term of Chad Hutson as President. On motion of John Stump, seconded by Ira Handley, the Board voted unanimously to continue Raymond Tomassene as the Board's Secretary.

West Virginia Board of Funeral Service Examiners BOARD MEETING Charleston, WV October 24, 2012

The meeting was called to order at 1:00 p.m. by President Chad Hutson. Members present: Chad Hutson, John Stump, Keith Kimble, Ira Handley and Chad Harding. Sarah Lobban attended but was late arriving. Non members present, Constance Sloan, Executive Director and Regina Foster, Administrative Assistant.

The President announced the Board would take up the matters of the requests of Leslie Murray for reconsideration of her application for apprenticeship and the request of Cathrine Pettry for an exception to the educational requirements and allow her to sit for the Board exam.

Ms. Murray was present, accompanied by Deborah Rodecker, General Counsel for the Medical Licensing Board, who stated she was there for support of Ms. Murray. Ms. Murray presented to the Board a folder containing a letter and exhibits and read to the Board the letter explaining her position. She and Ms. Rodecker then left the meeting.

The Board considered the application of Leslie Murray and the exhibits she presented. The Board found that Ms. Murray had obtained an Associate in Applied Science in the mortuary science program at her college, however, she had not obtained the required undergraduate hours prior to attending mortuary school and, therefore, her education did not comply with the statutory requirements. The educational requirements set out in the statute have been in effect for over 15 years and every funeral director in the State has complied with those requirements prior to being licensed. Although the Board was sympathetic to her position, the Board does not have the authority to waive the requirements and that her option was to proceed to obtain a Bachelor's in Mortuary Science.

John Stump moved that the application be denied, the motion was seconded by Chad Harding and carried unanimously.

The Board then reviewed the application of Cathrine Pettry for an exception to the licensing requirements in order that she could sit for the Board Exam based on her previous licensure in the State of Kentucky. In order for the Board to grant a license to a person licensed in another state, the statute requires, among other things, that the person hold a license or its equivalent to practice in another state which was granted after completion of educational requirements substantially equivalent to those required in this state. The certificate received from the Kentucky State Board indicates that at the time of her licensure in Kentucky, she did not meet West Virginia educational requirements. The transcripts provided to this office from her mortuary school reveal that Ms. Pettry did not have undergraduate hours prior to obtaining her hours in Kentucky and obtained a Bachelor's in Mortuary Science a year after she was licensed in Kentucky.

John Stump moved that the application be denied, the motion was seconded by Chad Harding and carried unanimously.

The Board then considered the Minutes from the June 11, 2012 meeting and on Motion of Ira Handley to approve the same, seconded by John Stump, the minutes were approved unanimously.

The Financial Reports for May, June, July and August, 2012, were reviewed. On Motion of Chad Harding, seconded by Ira Handley, the financial reports were approved unanimously.

The P-Card reports for May, June, July and August, 2012, were reviewed. On Motion of Chad Harding, seconded by Ira Handley, the P-Card reports were approved unanimously.

The payment to the International Conference for due in the amount of \$250 was discussed, and on motion of Ira Handley, seconded by Keith Kimble, the invoice was approved for payment.

The Board then discussed setting specific office hours for the staff which would be consistent with other State agencies. On motion of Chad Harding, seconded by John Stump, the Board voted unanimously to establish the following office hours: Employees will work 37.5 hours per week (5 days at 7.5 hours) and be compensated for one-half lunch time. Employees will allowed two (2) 15-minute breaks daily, one in the morning and one in the afternoon. Employees who do not utilize the 15-minute breaks may add them to the lunch break and receive an hour paid lunch break.

The Board discussed the need for yearly inspections of "chapel only" facilities on motion of Ira Handley, seconded by John Stump, approved allowing the inspector to inspect these facilities every two years.

The Executive Director stated that the criminal prosecution of Tom Stevens in Boone County should take place at the next grand jury and the office will follow up with the Prosecutor in late November for a status report. The criminal proceedings against another funeral director are pending with the Charleston Police Department and has been put on hold at the request of the Attorney General's Office until they have completed their civil case.

On motion of Keith Kimble, seconded by Ira Handley, the Board went into Executive Session to consider Complaint Committee recommendations, pursuant to West Virginia Code 6-9A-4(b)(A). On motion of Chad Harding, seconded by Keith Kimble, the Board returned to public session.

The Board discussed whether to bring disciplinary action against a funeral director whose Virginia license had been revoked for three years for his failure to complete continuing education and to submit to an audit of the Board. On the motion of Chad Harding, seconded by Keith Kimble the Board voted unanimously to take no action on this matter.

The Board then discussed whether to take disciplinary action against a funeral director who had been convicted of a misdemeanor and served a jail sentence. On motion of Chad Harding, seconded by John Stump, the Board voted to take no action at this time on this matter.

On motion of John Stump, seconded by Ira Handley, the Board voted unanimously to accept the recommendation of the Complaint Committee as follows:

2012-06: The Complaint Committee is authorized to enter into a Consent Agreement with the funeral director in which he will be placed on probation and reprimanded for his willful failure and refusal to complete a death certificate as required by law and for his willful failure and refusal to respond to the complaint filed against him with this Board.

The Committee finds that there was a lack of communication between the funeral director and the complainant, but that the funeral director did not act in a manner that was negligent or unprofessional and, in fact, followed standard procedures for the handling of cremains. As there is no violation of the Funeral Service Act, the Committee recommends the complaint be dismissed.

Authorize the Committee to enter into a Consent Agreement with the funeral director reprimanding her and placing her on probation for a period of one year for her unauthorized practice for funeral directing while she had no valid State or City business license and her license to operate the funeral home had not been renewed.

Dismiss as the funeral director acted appropriately under the circumstances in this case and there is no violation of the Funeral Service Act.

Dismiss as there is no violation of the Funeral Service Act, however, the Committee recommends the Board advise the funeral director that this type behavior by his employees will not be tolerated and any similar conduct in the future will likely result in disciplinary action against him.
