### WEST VIRGINIA STATE BOARD OF EXAMINERS FOR LICENSED PRACTICAL NURSES

#### **OVERVIEW OF ACTIVITIES FOR FISCAL YEAR 2015 AND 2016**

Members and staff of the West Virginia State Board of Examiners for Licensed Practical Nurses are active participants in meetings and activities across the country on matters of licensing, professional regulation and changing health care delivery systems. Members and staff continue, as has historically been the case, to serve on committees at the national level with agencies involved in licensing nurses from other states as well as agencies relating to health care and other professions within our own state. This involvement assures that members are aware of the many issues surrounding not only practical nursing, but the entire health care system, as the industry continues its attempts to organize and reorganize delivery of health care to achieve acceptable quality care with fewer health care practitioners and fewer health care dollars. Changes in the patterns of delivery and mix of competent providers have resulted in fluctuations in demand for licensed practical nurses. Over time the demand in one area increases while the demand in another area may decrease. Summaries of annual reports from the state's licensed practical nursing schools demonstrate over the past few years that the number of graduates of nursing programs has remained fairly stable, and that graduates are obtaining employment in the health care field. Licensed practical nurses particularly continue to be steadily employed in long term care, and are important parts of the health care team in that setting. Numbers of actively licensed LPNs in West Virginia have risen gradually over the past ten (10) years and continue to do so.

The number of LPN schools in West Virginia was twenty-seven in 2016.

Of the other existing twenty-five programs, twenty-two programs are within the vocational education system. One program, the B.M. Spurr School of Practical Nursing, is privately

sponsored by Reynolds Memorial Hospital, one program is located at New River Community and Technical College, one is at Salem International University, and one is located at Pierpont Community and Technical College and one at West Virginia Junior College.

The Board utilizes the National Council Licensure Examination for Practical Nurses, through contract with the National Council of State Boards of Nursing, Inc. This examination provides for interstate endorsement of licensees without further testing. With computer adaptive testing technology candidates are permitted to contact the testing center and test six days a week, year round rather than twice per year. They are also permitted to test in any of over 100 testing locations across the country, rather than in West Virginia alone to get a West Virginia license. Results are transmitted to the Board via internet technology from the national testing service. Candidates are forwarded their results and licensure information for new licensees is posted on the NURSYS website as early as the same day as the candidate completes the exam. Retesting of failing candidates is available every forty-five (45) days.

The West Virginia State Board of Examiners for Licensed Practical Nurses was the first NCSBN Member Board to implement the Optimal Regulatory Board System (ORBS) for renewal purposes starting in 2015. For the first time, all nurse license renewals were done completely online. Board staff went above and beyond their regular duties and licensees in the state were very pleased with the new system. Additional elements of ORBS have since been implemented, and all applications, including those for initial examination, retest, endorsement, reinstatement, and renewal are now handled entirely online.

To prepare for implementation, portions of the board's website were revised to accommodate the new online processes. This required collaboration between the board, NCSBN staff, and the state treasurer's office. A process manual was also developed that contains details about each activity related to licensing and discipline that occurs in the board office. The manual was shared with other member boards to assist them in preparing for ORBS.

The implementation of ORBS supports NCSBN's mission and vision. Not only are applications processed much more quickly, now licensee data is automatically uploaded to the NCSBN Nursys® database several times per day, making licensure information more accessible to all stakeholders including

the public.

This success paved the way for other member boards to implement ORBS and the board has provided assistance to other member boards preparing for and implementing ORBS. The West Virginia State Board of Examiners for Licensed Practical Nurses dedication and willingness as well as its spirit of collaboration in effectively executing an innovative idea has benefited all boards of nursing and contributed to enhanced public protection.

The Board monitors licensee compliance with continuing competence requirements of twenty four contact hours of continuing education and four hundred (400) clock hours of practical nurse employment in each designated two year reporting period. A reporting cycle was completed with the renewal period ending June 30, 2016. The next reporting period will end on June 30, 2018. Random continuing education audits are conducted on 7 to 10% of licensees per reporting cycle.

The Board continues to receive complaints against licensees for professional misconduct. In FY 2014 the Board received one hundred seventy complaints, and in FY 2015 one hundred eighty-two disciplinary cases were logged. In FY 2016 this number was one hundred eighty-seven cases. Increases in numbers of disciplinary cases continue to be observed in all licensed professions in all states across the country. Continuing efforts to refine the process and procedures for complaint management have resulted in effective and timely resolution in most cases. The average complaint takes approximately seventy calendar days from receipt of the complaint to execution of board action either imposing disciplinary measures or dismissing charges as unsubstantiated or outside the jurisdiction of the Board. Board staff addresses groups of nurses, nursing employers, and students upon request to discuss the disciplinary process, the importance of accurate documentation when providing patient care, etc.

The LPN Board continues to participate in self-evaluation activities through its participation in the Commitment to Ongoing Regulatory Excellence Project sponsored by the National Council of State Boards

of Nursing. This project involves data collection on areas including licensure, governance, nursing education, discipline, fiscal information, practice, and information technology utilized by the Board. Data is collected from Board staff, Board members, and stakeholders of the Board including licensees, nurses complained against, individuals who had filed a complaint, nursing schools, professional associations, and health care facilities. Data is compiled and results are provided at three year intervals. As the purpose of the project is to collect performance data from boards of nursing in order to identify best practices, those procedures or processes that make up the best, most effective practices are then to be identified and shared with other boards of nursing. Preparation of a strategic plan, reviewed by the Board each year during its June Meeting, incorporates specific activities to guide members and staff of the Board in achieving the strategic initiatives and outcomes related to the mission of the board.

The RN and LPN Boards meet annually to discuss matters of common interest. In the joint meeting held June 10, 2015, the Boards reviewed information regarding the West Virginia Center for Nursing, scope of practice, and other issues affecting nursing regulation.

The Board is committed to collaboration with other health related or licensing agencies and organizations to improve public access to and information about education, licensure, practice, discipline and accountability for LPNs. The board maintains a web site, a toll free telephone line, and publishes two newsletters a year. Information from the licensee data base is available on the NCSBN NURSYS website which is update several times daily.

The Executive Director of the Board was appointed to her position in July 2016. The current Executive Director formerly served as the Associate Executive Director at the Board for eleven years before being promoted to Executive Director. Members and staff continue to be active in National Council activities including attendance of meetings and service on committees.

#### FROM THE PRESIDENT

We often hear or read disturbing facts associated with living in West Virginia. While we face many issues of concern, we can also take pride in our state, especially with regard to the Practical Nursing Programs. Did you know that West Virginia consistently reports reports higher than national average passage rates for first time NCLEX testers? In 2013 the national passage rate of the NCLEX was 83.18% and the rate for WV was 83.87%. The scores have consistently been higher and in 2014, the national NCLEX pass rate was 81.06 and WV reported a pass rate of 87.5%. By 2015, the national average was 76.60% while WV reported a rate of 92.59%. Years prior to 2013 have similar results. What this means is that WV Schools of Practical Nursing are high quality educational entities. We are fortunate to have outstanding educators who put students first! Remember, no one is more cherished in this world than someone who lightens the burden of another, Instructors, you certainly lighten ours! As we near the end of another school year, our soon to be graduates will be joining the ranks of the nursing profession. Experienced nurses can help those joining the ranks by providing mentoring and peer support, by providing information about required continuing education, by explaining and assisting with the on-line licensure process, etc. Please help new nurses understand the required 24 contact hours of continuing education and the required 400 clock hours of LPN practice in each two year reporting period. Since reporting is completed in even years, murses will report this year. Our new graduates will report in 2018.

We congratulate the Boone County Career and Technical Center on their journey to begin a new LPN program. We wish them luck as they begin their process to join other schools within the state.

The WV Board of Licensed Practical Nurses remains committed to ensuring public safety through nursing regulation. The board meets again on June 22<sup>nd</sup> at 10:00 am. You are invited to join our meeting. Here's to a happy and safe summer!

If you renewed your LPN license in WV last year you will already have an account on the portal and can sign in using your email address and password. If you have forgotten your password you can click the "Forgot Password" link and reset it.

#### Please note:

- If you have changed your name you must renew in the license currently on record with the Board. You
  can then submit the legal document (copy of marriage certificate or divorce decree) via email, fax, or
  mail to complete the name change process.
- If you have been convicted of a crime, had disciplinary action or have action pending in another state since your last renewal, legal documents must be uploaded during the renewal process before your application can be submitted.

 If you are currently on active duty in the military you will need to upload documentation confirming your status at the time that you renew your license.

The fee to renew your license is \$50.00 plus \$1.13 credit card processing fee. You may use a credit or debit card. Transactions are secure and processed through the WV State Treasurer's Office.

If you wish to place your license on inactive status, please select the online link for "Inactive License" and follow the instructions. There is no fee to place your license on inactive status.

Online transactions are processed the next business day, therefore waiting until late June to renew is not advised so that you and your employer will have time to verify your new expiration date of June 30, 2017. Updated license verification information will be on <a href="https://www.nursys.com">www.nursys.com</a>.

#### IMPORTANT INFORMATION - CHANGES TO CE REQUIREMENTS!!!!

In 2012, the West Virginia Legislature added the requirement for CE in the subject of substance abuse. <u>Therefore, during each reporting period ending each licensee must have completed at least three (3) contact hours in the topic of substance abuse to renew the LPN license.</u>

In 2014 The West Virginia Legislature added the requirement for CE in the subject of mental health conditions common to veterans and family members of veterans. Therefore, effective with the reporting period ending in 2018 (between July 1, 2016 and June 30, 2018) each licensee must have completed at least two (2) contact hours in the topic of mental health conditions common to veterans and family members of veterans to renew the LPN license. This is not a one-time requirement and must be completed during each subsequent reporting period.

You may access a partial list of approved CE providers on the Board's website under "NEWS." The RN Board website at www.wvrnboard.com also contains a list of CE providers that you can utilize.

#### **EXCITING CHANGES TO BOARD OPERATIONS**

Changes are here with regards to how you will interact with the Board to reinstate and renew your license, apply to the Board for the licensure exam, change your address, and utilize other services. Paper applications are no longer available. The West Virginia LPN Board is the first Board of Nursing in the US to begin using a new Operations Management System offered by the National Council of State Boards of Nursing. One significant change is that all actively licensed LPNs in West Virginia are required to have a valid email address to utilize the many new online services which will be offered. If you do not have an email address, you can establish one at google.com, yahoo.com or other websites. Remember to notify the Board if you change your email address. You must use a credit or a debit card for renewals or other applications on the Nurse Portal. Please feel free to contact the Board with any questions.

#### INTRODUCING e-Notify! FREE OF CHARGE!

e-Notify is a new nurse licensure notification system developed by the National Council of State Boards of Nursing that delivers real-time notifications to employers about nurses who work for them. Once registered the employer will automatically receive changes to licensure status and available discipline data as the information is entered by boards of nursing. Registration by an employer is free for all nurses employed at the facility. Please see www.nursys.com or contact nursenotify@ncsbn.org for more information and registration. You can also enroll your own license to get updates about your expiration date and any other changes in your licensure status. You can enroll at www.nursys.com or via your Nurse Portal on the LPN Board website.

As we enter winter and a time of celebration, I am thankful to be a part of the WV Board of Examiners for Licensed Practical Nurses. We welcome three new members to our board, Grady Bowyer, Coralee Hatcher, RN, and Megan Johnson, LPN. The addition of these three new members will further the work of the board.

As a reminder, LPNs are required to complete 24 contact hours of continuing education and engage in 400 clock hours of LPN practice in each 2 year reporting period. Reporting occurs on the even years, so you should be preparing your documentation for the reporting period ending June, 2016. Unlike the end of life CE requirement that must only be completed once, the three hours of CE credit for substance abuse must be competed each bi-annual reporting period. In 2014, the West Virginia Legislature also added a CE mental health conditions common to veterans and family members of veteran's requirement. The first required reporting for this particular CE requirement will occur in 2018. Each board meeting, we review disciplinary actions of those penalized for audit failures and working on lapsed licenses. While there are other infractions, which result in fines, these two are the most common. Please be diligent in maintaining your licenses and CE records. All information to rules and updates can be found on our website. You may also call the LPN office at 877-558-LPNS.

The board also congratulates Lanette Anderson, Executive Director, who completed her tenure in 2015 as Area II Director with the National Council State Boards of Nursing. Lanette represented West Virginia and the other Area II states with true professionalism and commitment. West Virginia is well respected within the NCSBN and is fortunate to have Lanette, Michelle, Elsie, and Kim leading the WV Board of Examiners for Licensed Practical Nurses.

They are also reported to the NURSYS national nursing data base as maintained by the National Council of State Boards of Nursing, the HIPDB Data Bank as maintained by the federal government, and also to the Office of the Inspector General when a license has been surrendered, suspended, or revoked.

## IMPORTANT INFORMATION -CHANGES TO CE REQUIREMENTS!!!!

In 2012, the West Virginia Legislature added the requirement for CE in the subject of substance abuse. <u>Therefore, during each reporting period ending each licensee must have completed at least three (3) contact hours in the topic of substance abuse to renew the LPN license.</u>

In 2014 The West Virginia Legislature added the requirement for CE in the subject of mental health conditions common to veterans and family members of veterans. Therefore, effective with the reporting period ending in 2018 (between July 1, 2016 and June 30, 2018) each licensee must have completed at least two (2) contact hours in the topic of mental health conditions common to veterans and family members of veterans to renew the LPN license. This is not a one-time requirement and must be completed during each subsequent reporting period.

You may access a partial list of approved CE providers on the Board's website under "NEWS." The RN Board website at www.wvrnboard.com also contains a list of CE providers that you can utilize.

# FREQUENTLY ASKED QUESTIONS ABOUT CONTINUING COMPLETENCE REQUIREMENTS

## HOW OFTEN DO I HAVE TO RENEW MY LICENSE?

You renew your license annually, however, you only report CE and identify an employer to verify your practical nursing work experience every other year ON THE EVEN YEAR at the time you renew your license.

#### DO I HAVE TO WORK TO KEEP MY LICENSE ACTIVE?

Yes. You must work in a position that requires that you be an LPN to renew your license. The number of hours of you must work as an LPN is 400 clock hours, throughout the 2 years.

### WHAT IF MY WORK DOES NOT INCLUDE PATIENT CARE?

Your job will qualify as practical nursing practice providing LPN licensure is specified in your job description. In other words, if an individual who is not licensed as an LPN could do the same job you cannot count this as employment hours.

### WHAT IS A CONTACT HOUR?

A contact hour is equivalent to 50 consecutive minutes of instruction. The unit of measure for CE in West Virginia is the contact hour. The law requires 24 contact hours during each two (2) year reporting period.

## WHERE CAN I FIND APPROVED CE ACTIVITIES?

You may contact the inservice departments of hospitals and nursing homes, your local vocational school, as well as the CE departments of colleges and universities in your area to find out what is available. Associations such as the West Virginia Nurses Association, West Virginia Health Care Association, and other health care associations and organizations may offer CE for LPN's. In addition, the Board=s website lists several approved online CE providers under ANews & from the Board=s homepage.

### HOW WILL I KNOW IF A CE ACTIVITY IS APPROVED?

CE approved by any state or national nursing organization, other health related national organizations, other state boards of nursing or health related licensing boards is acceptable if the identified target audience includes nurses. Activities approved by the West Virginia Board of Examiners for Registered Professional Nurses and West Virginia Nurses Association are accepted without a specific number from the LPN Board.

### WHEN SHOULD I GET MY CONTACT HOURS?

Start early. Waiting until the last minute can cause delays in renewing your license, increased fees and cause you unnecessary distress that can be avoided by acting early.

### WHAT ARE THE MINIMUM STANDARDS?

- 1. The activity is at least 50 minutes/1 contact hour in length.
- 2. The target audience is identified and includes nursing, except as otherwise provided.

- 3. Acceptable subject areas are:
  - a. nursing practice areas and professional development;
  - b. nursing theories and sciences;
  - c. legal, social, economic or ethical aspects of health care; and
- 4. Written objectives are available to participants.
- 5. Content relates to nursing/health care.
- 6. Instructor qualifications are provided.
- 7. A written schedule is provided to participants which indicates content and time frames.
- 8. Program announcements specifically indicate that it is approved for CE credit for nurses.
- 9. A written method is established to determine that the participant has achieved stated objectives of the activity.
- 10. A certificate of completion is provided to participants.

### HOW WILL I KNOW IF AN ACTIVITY IS ACCEPTABLE?

Most of the requirements can be evaluated by carefully reading the published brochure for the activity. If you need further clarification, you should contact the activity provider.

#### HOW CAN I EARN CE HOURS?

You may:

- 1. attend approved CE activities, workshops, seminars and conferences dealing with issues in nursing,
- 2. enroll at a college or university in courses relevant to nursing,
- 3. take home study courses including online courses in nursing or complete the continuing education offerings in professional nursing journals,
- 4. read professional journals and other available nursing literature. (You may identify 5 of the 24 contact hours required as learner designed. This means the reading or other programmed instruction you choose need not be approved, but simply selected by you for professional growth.)

#### IS COLLEGE CREDIT ACCEPTED FOR CE?

Yes. Successful completion of courses provided by an accredited college and academic credit is awarded can be used to satisfy the CE requirement, providing they are relevant to nursing. The following formula is used to calculate contact hours from credit hours:

- 1 Quarter hour = 10 contact hours
- 1 Semester hour = 15 contact hours

#### **EXCITING CHANGES TO BOARD OPERATIONS**

Changes are here with regards to how you will interact with the Board to reinstate and renew your license, apply to the Board for the licensure exam, change your address, and utilize other services. The West Virginia LPN Board is the first Board of Nursing in the US to begin using a new Operations Management System offered by the National Council of State Boards of Nursing. One significant change is that all actively licensed LPNs in West Virginia are required to have a valid email address to utilize the many new online services which will be offered. If you do not have an email address, you can establish one at google.com, yahoo.com or other websites. Remember to notify the Board if you change your email address. You must use a credit or a debit card for renewals or other applications on the Nurse Portal. Please feel free to contact the Board with any questions.

### INTRODUCING e-Notify! FREE OF CHARGE!

e-Notify is a new nurse licensure notification system developed by the National Council of State Boards of Nursing that delivers real-time notifications to employers about nurses who work for them. Once registered the employer will automatically receive changes to licensure status and available discipline data as the information is entered by boards of nursing. Registration by an employer is free for all nurses employed at the facility. Please see www.nursys.com or contact nursenotify@ncsbn.org for more information and registration. You can also enroll your own license to get updates about your expiration date and any other changes in your licensure status. You can enroll at www.nursys.com or via your Nurse Portal on the LPN Board website.
