





OVERVIEW OF ACTIVITIES AND RESPONSIBILITIES WEST VIRGINIA BOARD OF LICENSED DIETITIANS 2007 – 2008

The West Virginia Legislature mandated the requirement to hold an active/valid license to practice dietetics in the State of West Virginia – West Virginia Code – Chapter 30 - Professions and Occupations – Article 35 – Board of Dietitians – commencing on July 1, 1997. The law, effective 90 days after March 9, 1996, mandated the formation of a Board as the WVBOLD. The WVBOLD is a regulatory and disciplinary body. It is the sole authority for the issuance of licenses to practice dietetics in the State of West Virginia. The purpose of the Board is to protect the public interest through its licensure and professional discipline of dietitians and to provide a professional environment that encourages the delivery of quality nutritional information and medical nutrition therapy in the State of West Virginia. The Board consists of five (5) members who are appointed by the Governor, by and with the consent of the Senate. Four of the members are experienced registered and licensed dietitians and one member is a layperson.

The WVBOLD maintains a code of ethics; establishes professional continuing education requirements and standards; establishes licensure and renewal requirements of duly qualified applicants; establishes procedures and guidelines for the suspension or revocation of a license; adopts procedural and interpretive rules in accordance with the provision of Chapter 29 of the code; adopts an official seal; renews licenses; issues interim provisional permits to duly qualified applicants; imposes and collects fees for the issuance and renewal of permits or licenses; suspends, revokes and reinstates license; conducts hearings on licensing issues and any other matter properly within the jurisdiction of the Board; utilizes available mechanisms/ methods to protect the health and well-being of the public in nutrition related issues; maintains a record of proceedings of the Board and submits a biennial report to the Governor describing activities of the Board.

WVBOLD established:

Title 31 – Procedural Rule – Series 3 – Contested Case Hearing Procedure. Title 31 – Legislative Rule – Series 1 – Licensure and Renewal Requirements. Title 31 – Legislative Rule – Series 2 – Code of Professional Ethics. Title 31 – Legislative Rule – Series 4 – Disciplinary and Complaint Procedures. Title 31 – Legislative Rule – Series 5 – Continuing Professional Education Requirements

Licensed and registered dietitians are proficient in the science of nutrition. They are required to hold degrees in nutrition, dietetics, public health or related field such as biochemistry, medicine or a nutrition specialty in family and consumer sciences issued by accredited colleges and universities. After or during their education, they must complete a supervised internship and pass a comprehensive examination administered by the Commission on Dietetic Registration. WVBOLD renews a contract each year with the Commission on Dietetic Registration as the approved standards for nutrition education. Professional education credits are required (20 each two years) throughout a career to maintain licensure (page 3, para. 5). The need for qualified providers of nutrition advice has become more focused within the past 20 years. As with the specialization of medicine, the science-based nutrition field has necessitated a higher understanding and communication of nutrition prescription and advice to those in need of this service. Physicians rely upon the expertise of dietitians as a critical member of the healthcare team. Dietitians specialize in medical nutrition arenas, as cardiology, oncology, pediatrics, neonatal, renal diseases, eating disorders, weight loss, gastroenterology, inborn errors of metabolism, geriatrics, sports medicine, osteoporosis' conditions, hypertensive issues, diabetes, trauma, enteral and parenteral nutrition and others. An example: Obesity is documented as a leading preceptor for diseases causing higher healthcare cost, as well as trauma to the patient and family members. As the WV Legislature moves to address these issues, dietetics will be in the forefront among the healthcare providers.

The RD status means that the individual possesses the skills and knowledge to translate nutrition science into practical meal planning. The individual can assist with eating disorders; work with healthcare teams to assist patients/clients to change eating plan pre-post surgery; assist in goal setting for athletic performance on various levels; prescribe and counsel patients and families with a myriad of disease entities and to assist physicians and healthcare providers in assessing a patient's needs and prescribing a nutrition therapy to best benefit the patient or client.

While the credential RD is significant it, unlike the credential LD, cannot be significantly regulated in the State of West Virginia. Initials following a name do not necessarily qualify an individual to provide nutrition services. Licensure and registration provide the only assurance the public has to judge that the individual is proficient in the science of nutrition.

Licensure in West Virginia provides the vehicle to file a complaint should anyone have reason to believe the person is not providing accurate nutrition advice or falsely claiming to be a qualified dietitian. The State of West Virginia, with licensure, can regulate the term "licensed dietitian" or "dietitian". States without licensure experience self-proclaimed persons claiming to be experts with little if any actual nutrition training or with only mail-order credentials. When an individual needs trusted, accurate, timely and practical nutrition advice, they should be able to identify the qualified professional.

WVBOLD utilizes the examination by the Commission on Dietetic Registration as one component to examining an applicant's qualifications, prior to issuance of a West Virginia license.

By law, when licensure began in 1997, the examination as a route to licensure was waived (as a one time opportunity) for those who were:

- (a) Currently registered with CDR as a Registered Dietitian.
- (b) BS or higher degree, with a major in human nutrition, dietetics or food systems management or equivalent and engages in the practice of dietetics or

nutrition three (3) of the previous ten (10) years.

• (c) Licensed in another state with comparable requirements.

Exemptions include: Those marketing, distributing or providing information about food/ food materials or dietary supplements; healthcare providers - where nutrition was included in the profession's scope of practice; academic institutions; various government agencies - as Veterans' Administration or WIC - who have their own standards.

In 1997, 33 individuals were "Grandfathered", in accordance with waiver (b). Under the reciprocation waiver (c), one Kentucky dietitians was later granted a WV license. Many have retired from their chosen profession, i.e.: County Home Demonstration Agents or WIC Nutritionist. Some have relocated and a couple found they did not require a license in their government-based employment. Two allowed their license to expire and, after some time, applied for renewal. Those were denied, per State law as being ineligible for licensure. WVBOLD handles the "Grandfather" status renewals as a routine renewal, giving due diligence to CEU credits.

Licenses are issued throughout the year. Renewal applications must be postmarked June 30th of each year. It has been the practice of the WVBOLD Board Chairman to personally contact those not having complied with renewal in the last week of June or first week of July. Out-of-state dietitians often express surprise and are pleased to have this personal service.

WVBOLD monitors licensure compliance with continuing competence requirements of twenty (20) hours in each designated two year reporting period. A reporting of Continuing Professional Education Credits serves to ascertain the completion of the twenty hours by licensees. The applicant renewing licensure is charged with the responsibility of reporting educational activities (date, event and CEU credits) on the CEU Form accompanying the renewal application. A visual scanning is performed by the Board Chairman and Board Secretary prior to issuance of the renewed license. At the completion of the Renewal Period, a listing of all licensees required to submit the CEU credits in that given two year period is compiles. The list is, then, submitted to a Huntington-based company, with whom the WVBOLD has an agreement. 10% of the list is randomly selected to have a full audit of their CEUs. The audit is conducted by Board Member and Professional Inquiries Liaison – Betty Forbes – Director of Dietetic Education at West Virginia University.

WVBOLD is committed to collaboration with other healthcare related licensing agencies and organizations in West Virginia and nationally. The purpose is to identify needs and to improve public access to and information about education, licensure, practice, discipline and accountability for healthcare professionals.

WVBOLD developed a website and maintains a toll-free public telephone line. The telephone number is published in all telephone blue page directories in West Virginia and promotes the use of the credential "LD" as a means for the public to identify those qualified to deliver nutrition advice and counseling.

The American Dietetic Association and the West Virginia Dietetic Association issues press releases to West Virginia newspapers encouraging them to recognize the term "LD" and the qualified provider of nutrition information.

A complaint form is found on the website. Efforts are ongoing to refine the process for complaint management. While complaints are rare, numerous inquiries are received from healthcare institutions and the public with questions concerning acceptable duties of other nutrition personnel, i.e.: Certified Dietary Managers, Diet Technicians, etc. Inquiries from dietitians assist them in the assignment of duties to the same personnel.

The presence of the WVBOLD has increased public awareness of the services of a qualified dietitian tremendously. By the number of inquiries one can safely say that the public needs are being addressed. Nursing Homes, Personal Care Homes, Exercise Entrepreneurs and hospitals utilize the Board to determine what duties can be performed by their nutrition staff members.

OFFICIERS AND RESPONSIBILITIES OF THE BOARD:

The Board maintains an office at 723 Kanawha Blvd., East – Room 105 – Union Building - Charleston, WV 25301.

In accordance with State law, open meetings are conducted. Board meetings are posted in the State Register. The agenda for each meeting accompanies each posting. Notice of each meeting and the agenda are posted on the office door. Officers are elected annually.

The Board Chairman is elected to preserve order and conduct all proceeding by parliamentary rules and insures conformity thereto by members, appoints all committees and signs required documents. The office is not staffed with an Executive Director or Secretarial Services however, the Board Chairman serves in both capacities on a continuous basis. This involves a presence at least three times a week and as inquiries or requests are received. The telephone rolls over to the Board Chairman's home where all inquiries and request (verification of license, inquiries as to licensure requirements, inquiries from the public who are selecting a qualified dietitian and request of State agencies) are met in a timely manner. Licensed dietitians utilize this service from 7:00 am to 10:00 pm. E-mails are monitored daily. During the renewal periods the Board Chairman assumes the responsibility of obtaining the renewal applications from the State Treasurer's Office and is in the office on a daily basis. The 2009 goal is to provide a listing of licensed dietitians on the website.

The Vice-Chairman also serves as the Board Treasurer. This person acts as Chairman in the absence of the Board Chairman and call special or emergency meeting of the Board by joint action with the Chairman. As Treasurer, this position maintains all financial records to be in compliance with the requirements of the State of West Virginia. The Board Secretary is to maintain the database, prepare documents - as licenses and rosters, prepare and process meeting minutes and is active in the renewal process.

The Professional Inquiries Liaison fields questions pertaining to Continuing Education Credits, talks with the public concerning the educational route to licensure and audits the 10% chosen annually, at random for the auditing of their CEUs.

The Lay Member is a vital part of the WVBOLD. The person currently in this position is cognizant of the need for licensure of the profession of dietetics. He was formerly a healthcare foodservices representative of one of the largest companies in the United States and remains in the healthcare field. The person represents the citizens of the State of West Virginia in all actions of the Board. He votes on new applicants, discusses the need for changes in procedures and speaks to the public needs.

Board members of the WVBOLD are active participants in meetings and activities across the country on matters of licensing, professional regulation and changing healthcare as it relates to dietetic and nutrition.

Two members of the WVBOLD hold membership in the Association for West Virginia Boards. This enables a healthy exchange of ideas and discussions on key issues facing boards in West Virginia.

Board members attend the Annual Training Seminar for WV State Licensing Boards by the State Auditor's Office. They find this most helpful in the operation of the Board.

The Board Chairman served on the American Dietetic Association's Political Action Board 2002-2005, serving as chairman of ADAPAC 2003-2004. The Board Chairman serves as the Public Policy Coordinator for the West Virginia Dietetic Association. This group is responsible for promoting dietitians as the nutrition experts and advising the WV elected U. S. Congressional officials in such issues and concerns. In this role, the WVBOLD keeps abreast of issues surrounding not only dietetics but, the entire healthcare delivery system.

Four Board members are members of and some attend the annual meeting of the American Dietetic Association (FNCE), West Virginia Dietetic Association, Educational Alliance and serve on other healthcare coalition groups.

The WVBOLD maintains close working relationships, often making decisions that do not require formal Board actions. The Board Chairman and Vice-Chairman are in frequent contact in regards to routine Board business and for various State offices request. The Board Chairman and the Board Secretary meet at the Board Office periodically to conduct all secretarial type duties, such as issuing licenses, licensure verification and processing mail. The Board Chairman has contact with the Professional Inquiries Liaison, cognizant that this individual is best qualified to The WVBOLD maintains close working relationships, often making decisions that do not require formal Board actions. The Board Chairman and Vice-Chairman are in frequent contact in regards to routine Board business and for various State offices request. The Board Chairman and the Board Secretary meet at the Board Office periodically to conduct all secretarial type duties, such as issuing licenses, licensure verification and processing mail. The Board Chairman has contact with the Professional Inquiries Liaison, cognizant that this individual is best qualified to assist the issues relating to the Continuing Professional Education arena and to advise inquirers who are considering the dietetic profession. The Lay Board member is a very involved individual, with contact 2-3 times weekly.

While it is not the duty or responsibility of the WVBOLD to recommend dietitians to the public, the Board receives numerous inquiries as to how to locate a qualified dietitian for nutrition or medical nutrition therapy. The inquirer is referred, according to the need, as to the nearest medical facility or dietitian(s).

All applications are voted on by ALL Board members prior to issuance of a license. This keeps Board members quite involved in the daily business of the Board. Board members act in a volunteer role for such actions. This eliminates the need for formal Board meeting during certain periods of time. Actions requiring Board votes is, again, voted on at the scheduled Board meeting. Minutes of Board meeting are posted promptly on the website by the Board Secretary.

Formal Complaints in 2007-2008:

None received however, dietitians continue to call the Board with questions regarding the Scope of Practice for dietitians and for pharmacists. A frequently asked question is in relationship to the acceptable duties of a Dietetic Technician. For this reason, it is included in various newsletters. Three calls were received with questions about allowable counseling in Wellness Centers. These were not formal complaints. The dietitians were encouraged to either submit a complaint if they believed the person counseling had exceeded the allowable duties – or – meet with the facility manager to apprise them of the WV Code – Chapter 30 – Professions and Occupations – Article 35. Two reported back to the Board that they had, indeed, talked with the manager/owner. As a result, counseling practices changed. Two calls were received from clients of Wellness Centers to ask if the person counseling was a qualified person. Upon verification of the name, the caller was informed that the person was not a licensed dietitian. The name of a local dietitian was given to the caller to discuss the specific questions/concerns.

Notes of 2007-2008:

The Board would like to express appreciation that the WV Legislature mandated an Annual Training Seminar for West Virginia State Licensing Boards by the State Auditor's Office. This has proven to be most beneficial to the "WVBOLD. This, also, allows for interaction between boards.

WV Treasurer's Office E-Government was utilized for the 2007-2008 renewals. This will continue in the 2008-2009 renewals. Several "problems" have been identified with the WV Treasurer's Office to be corrected in the next renewal process.

West Virginia Board of Licensed Dietitians Policy and Procedures: Pregnancy Discrimination-No Tolerance

The West Virginia Board of Licensed Dietitians prohibits, forbids, and does not tolerate discrimination against anyone on the basis of pregnancy. All employees, supervisors, board members and job applicants are guaranteed the same employment opportunities. No person, or employee, no matter his or her position has the authority, expressed, actual, apparent or implied, to discriminate against a pregnant employee or employment applicant of the West Virginia Board of Licensed Dietitians.

The West Virginia Board of Licensed Dietitians prohibits, forbids, and does not tolerate carelessness, substandard or hazardous work practices within the facility, on its property or while conducting board business.

The West Virginia Board of Licensed Dietitians expects and demands that its employees perform their board/employment duties with care and attention to the citizen needs the safety and welfare of fellow workers and board members, and to The West Virginia Board of Licensed Dietitians quality standards and requirements. Per West Virginia Code Chapter 30. Professions and Occupations Article 35/ Board of Dietitians

§30-35-7 Qualifications; licensure; examinations; waivers and fees

- (a) An applicant for a license to engage in practice as a licensed dietitian shall submit to the board written evidence, verified by oath, that he or she:
- (1) Complies with the code of ethics adopted by the board.
- (2) Has completed a major course of study in human nutrition, dietetics, food systems management or the equivalent thereof and possesses a baccalaureate or post-baccalaureate degree; and
- (3) Has completed a planned continuous professional experience component in dietetic practice of not less than nine hundred hours under the supervision of a registered or licensed dietitian.
- (b) Each applicant is required to pass a written examination demonstrating competence in the discipline of dietetics and nutrition. Each written examination may be supplemented by an oral examination. The board shall determine the times and places for examinations.
- (c) When an applicant successfully passes an examination or examinations, the board shall issue to the applicant a license to engage in practice as a licensed dietitian. In the event an applicant has failed to pass examinations of three occasions, the applicant shall, in addition to the other requirements of this section, present to the board other evidence of his or her qualifications.

- (d) Upon application and submission of the applicable fee, the board may waive the examination requirements of this section and issue a license to practice as a licensed dietitian to an applicant who is registered by the commission on dietetic registration or who has been duly licensed as a nutritionist or dietitian under the laws of another state if the standards for licensing in that state are no less stringent than those required under of this article.
- (e) Any person applying for a dietitian license shall submit a fee of fifty dollars or a reasonable fee established by legislative rule pursuant to section six, article one of this chapter with the application to the board, which shall be deposited to the credit fund provided in section five of this article.

It was the opinion of Anthony Eates II that Ms. Glaze would need to comply with (1), (2) and (2b). The application does not provide proof that Ms. Glaze has met these requirements. She does not provide proof of professional experience nor an approved examination. Her examination appears only that for a licensed nutritionist. He also requested that a letter be drafted and sent to Ms. Glaze requesting additional evidence of the above items and that we were requesting this additional information under the advice of our attorney. Helen was to draft the letter and e-mail it to Anthony for his review and approval.

New Business

Person Seeking Licensure (Should we list her name? and if so Betty please spell it)

Betty has been working with an individual –SK- who is a Certified Dietary Manager who has had advanced classes and is seeking recommendations on how she can advance her future. Betty has reviewed her transcripts and determined that she has taken the appropriate classes and could sit for the CDR exam and if she passes could then submit an application to become a Licensed Dietitian. SK has also asked about the possibility of applying to an internship program. Although she may meet the requirements, Betty is unable to sign off on her internship application because she did not attend classes at WVU. Several of her classes were distance classes at various institutions and she may have difficulty finding someone to sign off on her application. The board recommends that Betty notify her of her right to sit for the exam and become a Licensed Dietitian in WV. SK would need to submit this request in writing to the Board Office. The board also recommended that Betty explain that her Licensed Dietitian status would ONLY be good in WV. Also it was recommended to explain to her that although she may become licensed, may hospitals in WV would also require her to be an RD before they could hire her secondary to The Joint Commissions standards.

If SK submits her request, then Betty will contact CDR and determine what the next step is to setting her up to take the exam.

COMPLAINTS, INVESTIGATIONS AND CLARIFICATIONS 2007 - 2008

Formal Complaints in 2007-2008:

None received however, dietitians continue to call the Board with questions regarding the Scope of Practice for dietitians and for pharmacists. A frequently asked question is in relationship to the acceptable duties of a Dietetic Technician. For this reason, it is included in various newsletters. Three calls were received with questions about allowable counseling in Wellness Centers. These were not formal complaints. The dietitians were encouraged to either submit a complaint if they believed the person counseling had exceeded the allowable duties – or – meet with the facility manager to apprise them of the WV Code – Chapter 30 – Professions and Occupations – Article 35. Two reported back to the Board that they had, indeed, talked with the manager/owner. As a result, counseling practices changed. Two calls were received from clients of Wellness Centers to ask if the person counseling was a qualified person. Upon verification of the name, the caller was informed that the person was not a licensed dietitian. The name of a local dietitian was given to the caller to discuss the specific questions/concerns.

A PERSON FROM TEXAS APPLIED FOR A LICENSE, STATING THE QUALIFICATIONS HAD BEEN MET, GAVE TWO DIFFERENT LAST NAMES ON CERTIFICATES AND SUPPLIED A NUMBER CERTIFYING HER TO PRACTICE DIETETICS IN TEXAS. A LETTER WAS SENT REQUESTING FURTHER CLARIFICATION, ENCLOSING THE WV CODE REGULATING THE PROFESSION. NO FURTHER CONTACT WAS MADE TO THE BOARD. A CALL REVEALED THAT THE PERSON HAD DECIDED NOT TO COME TO WV. THE BOARD WITHDREW HER APPLICATION AS THERE WAS NO FURTHER INFORMATION PROVIDED – THE INCOMPLETE INFORMATION MADE HER INEGILIBLE FOR LICENSURE.

FREQUENTLY ASKED QUESTIONS

WHAT DUTIES CAN BE PERFORMED IN THE STATE OF WEST VIRGINIA BY A CERTIFIED DIETARY MANAGER?

According to the Dietary Managers' Association website: A certified dietary manager (CDM, CFPP) has the education, training and experience to competently perform the responsibilities of a dietary manager and has proven this by passing a nationallyrecognized credentialing exam and fulfilling the requirements needed to maintain certified status. On a regular basis, certified dietary managers perform the following nutritional service tasks:

- Interview patients/clients for diet history
- Conduct routine nutritional screening/assessment
- Calculate nutrient intake
- Implement diet plans
- Document nutrition information on patient's/client's medical records
- Counsel patients/clients on basic diet restrictions; specify standards and procedures for food preparation
- Evaluate effectiveness of nutrition care plans.

HOWEVER, in a state that has licensure for dietitians, SUCH AS WEST VIRGINIA, a Certified Dietary Manager must follow what is written in that particular state's law as well as the Rules and Regulations of the Dietary Managers Association. In the STATE OF WEST VIRGINIA, the LAW DEFINES what duties a licensed individual can perform. It also defines that these individuals are the legitimate source for providing Medical Nutrition Therapy. They can supervise others to do various tasks, such as those defined in the above definition of Certified Dietary Manager. HOWEVER, they cannot assign these tasks and fail to follow-up with these individuals with such duties as either developing the tools that these individuals use and/or sign off on their documentation. It is ultimately the responsibility of the

licensed individual to be responsible for the medical nutritional care of the patient or client.

How long does it take, once the completed licensure packet is received, for an applicant to become a licensed dietitian?

Once the application (following the guidelines on the application packet—MEANING COMPLETED IN ITS ENTIRETY) is received – including verification from any other state in which the applicant holds or has held a license, 5 – 10 working days. The WVBOLD generally turns the application around within 24-36 hours.

What does a Provisional Permit mean?

An applicant who has completed all required education and who is waiting to sit for the CDR Exam can ask for a Provisional Permit to practice dietetics in the State of West Virginia for a period not to exceed three years from the date of issuance.

How can one obtain his/her original licensure date?

Above the licensee's name on the address label – the license number is on the left and the original date of licensure on the right.

How long can one hold "INACTIVE" status?

For a period not to exceed three years following the Inactive Status date.

Can a third or fourth year dietetic student perform nutrition services in a nursing home without the signature of a licensed dietitian.?

A third or fourth year dietetic student can perform nutrition services only as a part of the internship and requires the signature of a licensed dietitian.

WHY DID I NOT RECEIVE A NEWLETTER OR RENEWAL OF LICENSE INFORMATION?

Perhaps you moved and did not notify the WVBOLD of your address change. To change an address—Fax or e-mail the Board of the change. Remember to include any telephone, employment or e-mail change.

IT IS THE RESPONSIBILY OF THE LICENSEE TO HAVE THE CURRENT INFORMATION IN YOUR LICENSURE FILE—JUST AS IT IS WITH THE WV DEPARTMENT OF MOTOR VEHICLES.—BOTH ARE STATE AGENCIES

Enclosed you will find an Annual Renewal License Application to practice dietetics in the State of West Virginia for the year 2008-2009 and a Continuing Professional Education Form.

Every licensed dietitian will receive a Continuing Professional Education (CEU) Form. Not every
dietitian is scheduled for reporting CEUs in 2008. The law for CEU hours started July 1, 1999.Dietitians licensed in WV on that date fall into reporting on June 30, 2009, 2011, 2013, etc.2000, has a schedule of 2008, 2010, 2012, etc.;2002 has a schedule of 2008, 2010, 2012, etc.;2004 has a schedule of 2008, 2010, 2012, etc.;2006 has a 2008, 2010, 1012 schedule2008 has a 2010, 2012, 2014 schedule

List ALL hour/units that apply for your two-year period on the enclose CEU form. Please List your hours in chronological order. If you are to obtain hours within the last two weeks of June 2008, please list and indicate as intended hours. Should you not complete the hours, it is YOUR responsibility to contact the Board. To do otherwise will render your license invalid and subject you to disciplinary action.

The Renewal License Application and (if applicable) a check for the appropriate fee and your Continuing Professional Education Form must be postmarked by June 20, 2008 to avoid a late fee. Remember your license to practice dietetics is to be displayed in your place of employment. Where dietitians are employed in multiple venues, notarized copies should be displayed.

There is NO grace period. Practicing without a license renders the dietitian subject to a fine and disciplinary action. A Change of address may prevent a dietitian from holding a valid license. WVBOLD uses every opportunity to remind dietitians to apprise the Board of any change to their licensure portfolio. This ensures that the licensee will receive all WVBOLD communications.

ON-LINE RENEWAL IS ENCOURAGED. Once processed by the E-Government of the WV Treasurer's Office and credit is given to WVBOLD, the Renewal application and CEU forms are picked up at the Treasurer's Office in Kanawha City, WV by Helen Lodge – Board Chairman. Helen checks Renewals for changes in name, membership status, address, telephone, fax, e-mail, work related information and scans the CEU form for any glaring omissions and inclusion dates Notations are made of changes for reporting to the WV Legislature and to Dee Bartoe, WVBOLD Secretary. Dee gives a final check and enters any changes into the WVBOLD database, prints the individual license and mails it in the pre-labeled envelope. Your label contains your license number to the left of your name and the original date of licensure to the right of your name. Checks and balances are utilized throughout the process to ensure that no one is omitted.

If "postal mail" is the preferred renewal method, an envelope is enclosed for your convenience. The forms go to a dedicated U.S. Post Office Box, where the processing, as for on-line, is utilized.

Dee compiles a list of dietitians eligible for random auditing. Frank Markun facilities the random selections through an independent company and notifies Betty Forbes. She sends a letter to those selected for auditing, requesting verification of reported CEUs. Upon receipt, she checks the reported hours for acceptance and verifies to the WVBOLD that all persons have completed the necessary CEUs. If the education does not meet the WVBOLD requirements, Betty contacts the person, for the purpose of correcting or clarifying the infraction. A summary of this and other information is reported to the WV Legislature in the Annual Report.

336 LICENSED DIETITIANS IN WV

A total of 336 dietitians renewed a license to practice dietetics in the State of West Virginia at the end of the Renewal process ON June 30, 2008 Of those: WV—236; Kentucky—10; Maryland—4; Ohio 35; Pennsylvania 20; South Dakota —1 and Virginia 29.

WVBOLD MISSION: The West Virginia Board of Licensed Dietitians is a regulatory and disciplinary body. It is the sole authority for the issuance of licenses to practice dietetic in the State of West Virginia.

OPERATIONS: The purpose of the board is to protect the public interest through its licensure and professional discipline of dietitians and to provide a professional environment that encourages the delivery of quality nutritional information and medical nutrition therapy within the State of West Virginia.

The board is responsible for the following:

- Promoting a code of professional ethics.
- Maintaining a record of all proceedings of the board.
- Submitting a biennial report to the Governor describing the activities of the board.
- Setting minimum continuing education requirements and standards.
- Examination, licensure and renewal requirements of duly qualified applicants.
 - Conduct licensure examinations.
 - Issue and renew licenses and issue interim permits.
 - Impose and collect fees for the issuance and renewal of permits or licenses.
- Establish procedures and guidelines for the suspension or revocation of a license.
 - Suspend, revoke and reinstate licenses.
- Conduct hearings on licensing issues and any other matter within the jurisdiction of the board.

2009 GOAL: To review all files for accuracy, complete database and submit selected database information to the WV Treasurer's Office for ON-LINE Licensure Verification by the public. This will eliminate the need for the Board Chairman to search for each request (often 10-12 in one request) and will be available 24-7. At this time, there will be no charge for this service—as it has been the practice since the inception of the law governing the practice of dietetic in the State of West Virginia. It is rapidly becoming clear to the Board that administrative and secretarial services will need to be contracted therefore, dues may need to increase. This will be conveyed to the licensed dietitians prior to an increase.
