Annual Report 2012 Highlights

Injection Rule Guidelines Released

The Board developed its injection guidelines as required by West Virginia Code of Rules §14-11, Injectable Pharmaceuticals Certificate. The rule became effective on November 1, 2011. The types of injections approved are intramuscular, intravenous, subcutaneous, and subconjunctival injections. All applicants who graduate in 2011 or thereafter and who pass the Injection Portion of the National Board Exam will automatically be qualified to administer intramuscular and intravenous injections. Those who have graduated prior to 2011 or who wish to perform all authorized types of injection must complete a Board approved course in injection administration that includes supervised hands-on training with written and injection proficiency examinations.

All of the Board's rules, §14-1 through 14-8, were revised and became effective on August 15, 2011 along with new rules §14-9, Contacts That Deliver Pharmaceutical Agents Certificate, and §14-10, Continuing Education, which includes a new pre-approval procedure.

2012 Complaint Report Dr. David Laughlin, Complaint Committee Chairman

OPTOM 12-01 Moore/Sowders Patient says her records were not transferred to her surgeon in a timely manner. The doctor says the records have been forwarded. Both the patient and the optometrist have confirmed that her surgeon has received her records.

OPTOM 12-02 Ritchie/Gerenday Patient asked for two pairs of glasses, one for distance and one for close up. These pairs did not suit his needs for driving. Patient was given a refund.

OPTOM 12-03 Myers/Laughlin Dr. John Myers violated a domestic protection order. Dr. Laughlin, Complaint Chairman, filed a complaint against Dr. Myers. A consent decree was negotiated, and Dr. Myers agreed to suspension of his license.







A Word from the President, Matthew Berardi, O.D.

The West Virginia Board of Optometry has undergone some changes. On June 11, 2010, the newly revised Chapter 30, Article 8 of the W.Va. Code went into effect. It gave this Board the ability to promulgate legislative rules that change your scope of practice. These new abilities come with new responsibilities. The Board of Optometry is now responsible for keeping all licensees aware of changes in scope as well as education requirements for scope expansion.

We have created three new officer positions in an effort to accomplish our new duties. Dr. James Campbell was appointed as Education Officer. He will advise the Board on what new procedures are being taught in Optometry and will work with our association on future education Dr. Glenn Bailey was appointed as Rules Officer. He will lead our efforts in legislative rule writing. He will be working with our Executive Director. Pamela Carper, who has previous experience in this area. Dr. Greg Moore was appointed as Legislative Liaison, and he will represent the Board before the Legislative Rule Making Review Committee.

Promulgating rules has created a new financial obligation; as a result, we increased the license renewal fee. Dr. Moore and Pam Carper were able to reduce our spending in many areas last year and we will continue to make efforts to control our budget. Rules must be reviewed by legal staff in order to meet all requirements. This increased financial obligation required an increase in fees.

A doctor recently asked this board if his license allowed him to remove skin tags from eyelids with chemical cauterization. The doctor was told that his license allowed him to administer any drug for topical application to treat conditions of the human eye and its appendages. In Review of Optometry, May 2010, page 87, Dr. Jeff Yunker, OD, describes this procedure. I must admit, I did not realize I could offer my patients this procedure. I believe a list of procedures that



reflects our scope of practice will help us to practice optometry that best serves the needs of our patients.

On behalf of the Board of Optometry, I want to thank those members of the West Virginia Association of Optometric Physicians for the many hours they spent at the capitol building to ensure passage of Senate Bill 230 and our legislative rules. Your efforts will impact your profession forever. This board will work to reward your efforts and expand our scope of practice. Our first class for injection administration had 50 optometrists

New Annual Renewal Period Begins on July 1, 2012

Optometric law was changed to reduce the biennial renewal period to an annual renewal. This new change is listed in our rules, §14-1. The fee for annual renewal is \$400. The current license period ends on June 30.

The continuing education requirements were left on a two

year cycle for the convenience of the optometrists.

The rules now state that CE requirements are that 40 hours of continuing education are to be obtained during any even numbered two year cycle. As before, a minimum of 12 hours of CE must be taken in pharmacology or therapeutics, a maxi-

mum of 6 hours may be taken in practice management, and a maximum of 10 hours of CE may be taken by correspondence or via the Internet.

License renewal is conducted on line on our web site, www.wvbo.org under "Licensees," then "Online Annual Renewal."

I have no doubt that each of these board members and especially Pam went well above and beyond what is normally expected in these rolls.

As for the other optometrists on the Board, I can't even begin to express how honored and humbled I am to serve on a board with each of them. Although we have various backgrounds and practice modalities, each one of them is with out a doubt the very embodiment of the best our profession has to offer.

The past two years were an amazing experience. I will forever reflect on my time as President of the West Virginia Board of Optometry as one of, if not the, highlight of my career." In the final analysis, I am confident that the Board was an integral and

effective part of one of the most significant changes in the history of optometry and perhaps the entire health care industry. I am proud we all have finally lived up to the legacy left by those who effected change in the landmark 1976 legislation.

West Virginia Code, 30-8, will be remembered as the legislation that laid the groundwork for removing from the legislative code specific scope issues yet maintaining legislative oversight through the state Board.

Make no mistake, our law caught national attention. In fact I was invited to address this issue in Washington DC by the Citizens Advocacy Council.

My talk was titled "Intellectual Bigotry" and in it I quoted Thomas Jefferson who said "I am not an advocate for frequent changes in laws and constitutions, but laws and institutions must go hand in hand with the progress of the human mind. As that becomes

more developed, more enlightened, as new discoveries are made, new truths discovered and manners and opinions change, with the change of circumstances, institutions must advance also to keep pace with the times. We might as well require a man to wear still the coat which fitted him when a boy as civilized society to remain ever under the regimen of their barbarous ancestors."

To my colleagues throughout the state, some who will be privileged enough to one day sit on this board, know that by being a WV OD you have been given an awesome responsibility.

We live in uncertain times in the medical community. I submit that if you maintain your practice at the fullest potential allowed by WV law, and support efforts to keep pace with advances in eye care you will not only have a rewarding and fulfilling career, but you will pave the way for others in our profession through out the world to have those same rights and privileges.

Annual Renewal Online is Quick and Easy

Optometrists actively engaged in the profession of optometry in this state must renew their license annually on or before June 30, 2012. The fee for renewal is \$400. There is a late renewal fee of \$200 for those renewals not received by June 30, 2012.

License renewal will be conducted using the Board's web site, www.wvbo.org. Payment may be made by credit card, using the numbers from the bottom of your check or check by mail postmarked within 48 hours of license renewal on the web site.

You may click on "Licensees" in the left column of the home

page. This leads you to a new menu. Please select "Online Annual Renewal." The next action will be to click your mouse on "Account Manager".

If you have established an encrypted user account with the web site you may enter your user name and password. If you are a new licensee who has not registered on the web site you may establish a new account.

Review your personal information including all addresses, e-mail address and phone numbers. Please be sure to list the address of all of your office locations then mark "yes" or "no" to the licensee assurances at the end of your listing. The process will take approximately five minutes.

Annual notification of renewal is a courtesy of the Board, and failure to receive a notice does not exempt anyone from the penalties of failing to meet the requirements of renewal by the West Virginia Code.

The Board no longer maintains proof of all CE hours. Maintaining proof of at least 40 hours of continuing education credits per each even numbered 2 year period is your responsibility.

You should retain records for the current and previous re-

newal periods.

The Board begins it's CE audit by checking your listing in OE Tracker through the ARBO web site at www.arbo.org. If you have enough hours accumulated in this database you will not be audited further. If enough hours are not listed there you will be asked to provide paper copies of CE proof of attendance.

If you hold an and Injectable Pharmaceuticals Certificate you must obtain at least 2 additional hours of CE in injections in addition to the 40 hours required annually. You must also maintain current CPR certification.

West Virginia Board of Optometry License Interview Date is July 14, 2012

The West Virginia Board of Optometry will hold its Summer, 2011 license exam on July 14 beginning at 9:00 a.m. in the board office at 179 Summers Street, Suite 231, Charleston, WV 25301. The deadline for applications to be received in the Board office is June 14, 2012.

The interview includes questions on pharmacology, laboratory procedures, ocular manifestations of systemic diseases and ophthalmic science (e.g.: optics). There is a written multiple choice exam on jurisprudence administered simultaneously. You may also choose to take the jurispru-

dence exam through the National Board of Examiners in Optometry on its website at www.optometry.org. The fee is \$25. Go to "Laws and Regulations Governing Optometry" on our website at www.wvbo.org to study for the jurisprudence exam.

The requirements for an application are listed in <u>West Virginia</u> <u>Code</u>, §14-1-3. Some important requirements to remember are:

•A certified, sealed transcript from the applicant's undergraduate and optometry school must be sent directly to the Board office.

- ●The applicant must take and successfully pass the exam from the National Board of Examiners in Optometry (NBEO) parts I, II, and III including the examination on injections. A copy of the exam results must be sent to the Board office.
- •A copy of your birth certificate is to be enclosed.
- •Two 2" x 2" color photographs must accompany the application.
 - •The fee for the applica-

tion is \$300.00.

The application may be requested from the board office at 1-800-250-4150, downloaded from the board's web site at www.wvbo.org or requested by postal mail.

§14-1 on the application process is posted on the web site under "Laws and Regulations."

The requirement that all new applicants take and pass the NBEO exam on injections is a new requirement for our rule, §14-11 Injectable Pharmaceuticals Certificate.

The Board's New Legislative Rules

The Board's enabling statute, §30-8, was completely rewritten by Senate Bill 230 effective on June 11, 2010. All of the Board's legislative rules were re-written to comply with the bill. Some changes were minor, such as re-labeling sections of the rules to match the new legislation.

The Board has added three new rules, §14-9 on Contacts That Contain and Deliver Pharmaceutical Agents, §14-10 on Continuing Education and §14-11 on Injectable Pharmaceutical Agents.

§14-9 sets up a certificate to allow optometrists to prescribe and dispense contact lenses that deliver pharmaceutical agents for a reasonable and customary fee. An optometrist may not dispense these contacts based on an outside prescription.

§14-10 on Continuing Education takes CE out of §14-1, Rules of the Board. This will allow the Board to make adjustments to continuing education requirements as the scope of practice increases. It also modernizes the pre-approved sponsor list, and makes the CE approval process and documentation required more clear. A two year period to acquire the required hours in continuing education is retained.

§14-11 sets up requirements to obtain the privilege of administering injectable pharmaceuticals. The Board will keep a list of approved courses for training in injection techniques and the pharmaceuticals approved for administration. The Board will also maintain a list of approved injection sites and pharmaceuticals permissible for inspection by the public. Those optometrists who gain the privilege must obtain certification from the American Heart Association or American Red Cross in basic life support.

The Board has re-written §14-2 on oral pharmaceutical agents. It now includes the statutory categories of oral antibiotics, oral nonsteroidal anti-inflammatory drugs and oral carbonic anhydrase inhibitors so all oral pharmaceutical categories will be listed in the rule together. It also outlines criteria for the Board to approve new oral drugs. A list of approved new drugs will be maintained by

the

Board for public inspection.

§14-1 Rules of the WV Board of Optometry changes the license renewal period from two years to one year beginning on July 1, 2012. The two year period for acquiring required continuing education hours is retained in the new §14-10, Continuing Education. The rule adds the new forms of permits and licensure required in the new law. A temporary permit is added for new graduates who have not had their Board interview to practice under supervision. The temporary permit is in effect for 90 days.

§14-5, Fees, adds new fees for the new permits.

The rules are posted on the web site under "Rules and Regulations Governing Optometry."

The WV Health Information Network for Electronic Health Records

The West Virginia Health Information Network was formed under the oversight of the Health Care Authority to facilitate exchange of health records

through the use of Electronic Health Records.

Annual Report 2011 Highlights

AR 1

Updated Oral Pharmaceuticals Rule and New Injection Rule

The main advantage of both rules is that the Board will no longer have to return to the Legislature for approval of each new drug or to determine which types of injections and drugs that may be administered. The West Virginia Legislature passed an updated oral pharmaceutical rule in its 2011 session. It allows the Board to add new oral pharmaceuticals to the formulary without having to go through legislative approval to do so. The rule outlines criteria for adding new drugs.

The legislation passed last year allowed licensees to administer epinephrine by injection. The new rule sets up a mechanism for the Board to authorize additional drugs by injection for the treatment of the eye and its and its appendages. The Board may establish a formulary for injections. The rule also allows the Board to add additional pharmaceuticals for injection using the criteria listed above. The Board will also maintain a list of approved training for injection certification. Peribulbar and Retrobulbar injections are prohibited. No injection may be given directly into the globe of the eye. The rule establishes reporting procedures for the optometrist to inform the primary care provider of the diagnosis of the condition, the treatment given and the expected results of the injection. A log book of injections will be maintained for Board inspection.

2011 Complaint Report

OPTOM 11-01 McCartney/Hyre Dr. Hyre pointed out that a ½ page advertisement was being distributed where Dr. Mccartney was offering a free service. This is against WV Code. Dr. Mccartney brought the advertisement into compliance.

OPTOM 11-02 Crowder/Mccomas Patient alleged that the doctor had missed a diagnosis which was given by another doctor. The doctor's records were not thorough. A consent decree has been prepared per Board direction requiring additional training for Dr. Crowder and reprimand. The consent decree was signed, additional training was completed.

OTPOM 11-03 Cohen/Stephens Patient had difficulty receiving his eyeglass prescription. The patient received his prescription after intervention by the Board.

OPTOM 11-04 Bryant/Marchi Patient states that his new eyeglasses made his eyesight more blurry. There was no violation of optometric law. Patient was satisfied.

OPTOM 11-05 Rodgin/Cochran Patient alleges that the doctor touched her inappropriately. An order of immediate suspension pending investigation was issued. A CD was written to include voluntary surrender of license and has been signed by both parities.

OPTOM 11-06 Wiles/Blake Patient claimed that he had been harassed due to his sexual orientation. The Board found no evidence to support the patient's claim. The Board also found no violation of optometric law.

OPTOM 11-07 Simpson/Hiltner Ms. Hiltner says she received glasses that not improve her vision. She is asking for a refund of the exam fee of \$65.00. The optometrist has replied that the patient only made a complaint so she could find him after he moved. The Board has requested that Ms. Hiltner present that point of view to the Board. The Board is waiting on Dr. Simpson's official written response.

OPTOM 11-08 Esposito/Richards the patient had complaint regarding her contacts. The complaint was resolved to the patient's satisfaction.

OPTOM 11-09 Seese/Merrifield Patient was required to submit to a new eye exam when seeking a refill of her eye drops. The glasses made her eyesight worse. Her glasses were changed back to the previous prescription. The patient wants a refund of the price of the new glasses. Dr. Seese told her that it was a mistake by the optical where her prescription was filled, and would not give a refund. The board is awaiting the doctor's written response.




