

President Lewis called the meeting to order and stated that a quorum was present. The agenda for the meeting had previously been posted on the Board's website and made available through the Board's office. The meeting was opened with a prayer.

1. Motion was made by Board Member Bernabei to approve the June 27 and 28 meeting minutes. The motion was seconded by Board Member Rucker and passed unanimously with no discussion
2. The Executive Director gave his report. Mr. Goff gave a brief office update, including the status of the document scanning project, pharmacist license backlogs and other office items. There was also a summary given of the completed Inspection Program audit, as well as the PERD audit we are currently undergoing. Director Goff also discussed the ongoing civil litigation and various interactions with DEA, AG, licensing boards and MAT providers. Motion was made by Board Member Bernabei to approve the report. The motion was seconded by Board Member Bowyer and passed unanimously with no discussion.
3. The Chief Financial Officer then gave his report. Mr. Smolder gave FY2018, 2019, 2020 and 2021 Year End Summaries along with FY 2022 YTD comparison. Mr. Smolder then followed with the cash balance and remaining Fiscal Year Budget along with reports that are provided on a quarterly basis. Motion was made by Board Member Bernabei to accept the report. The motion was seconded by Board Member Misiti and passed unanimously with no discussion.
4. The General Counsel gave his report. Mr. Hatfield stated that he has responded to several FOIAs since the last meeting. Mr. Hatfield stated that legislative rules had been posted, with no comments received, and that the rules have already passed out of the rulemaking committee. Mr. Hatfield stated that discipline is up to date with a few cases recently scheduled for hearings. Mr. Hatfield stated that he and Mr. Goff had been working to compile documents responsive to a PERD audit. Finally, Mr. Hatfield stated that the Legislative Committee had been working on a collaborative practice bill to propose. Motion was made by Board Member Skaff to accept the report. The motion was seconded by Board Member Bernabei and passed unanimously with no discussion.
5. The Director of Professional and Regulatory Affairs then gave her report. Dr. Capehart provided an update on vaccinations in West Virginia and impending monoclonal antibody distribution throughout the state. A comprehensive summary of the WVBOP Workload Survey data was presented and discussed. The Task Force will be assembled to create recommendations. Dr. Capehart reviewed upcoming expansions to the website surrounding USP 800 and other inspection topics. Motion was made by Board Member Bowyer to accept the report. The motion was seconded by Board Member Bernabei and passed unanimously with no discussion.
6. Motion was made by Board Member Bowyer to enter Executive Session. The motion was seconded by Board Member Bernabei and passed unanimously with no discussion.
7. Motion was made by Board Member Bowyer motioned to accept the recommendations of the Complaint Committee. Board Member Skaff recused from consideration of the following cases: 2021-04-24; 2021-06-29; 2021-07-33; 2021-07-36B; and 2021-07-40.

Board Member Misiti recused from case 2021-06-31. The motion was seconded by Board Member Misiti and passed unanimously without discussion.

8. The Chief Compliance Officer gave his report. Mr. Robinette reported that a total of 153 inspections were conducted in the last quarter. Mr. Robinette reported that the Board received 65 suspicious orders in the last quarter, with none requiring follow-up. Mr. Robinette reported that the FDA extended the time period to sign the MOU to October 27, 2022. Mr. Robinette reported that inspectors were currently reviewing all controlled substance permits to identify the specific pharmacy services they are associated with. Mr. Robinette stated that upon completion of this review, a revised set of types of pharmacy services will be developed and inspection requirements will be established. Mr. Robinette stated that Hazardous Drug handling enforcement will begin October 1, 2021. 
President Lewis called the meeting to order and stated that a quorum was present. The agenda for the meeting had previously been posted on the Board's website and made available through the Board's office. The meeting was opened with a prayer.

1. Motion was made by Board Member Skaff to approve the September 26 and 27, 2021, meeting minutes with the correction to list Dave Bowyer as Secretary and not Vicky Skaff. The motion was seconded by Board Member Bowyer and passed unanimously with no discussion.
2. The Executive Director gave his report. Mr. Goff gave a brief office update, including plans for office modifications, progress of the document scanning project and continued response to various lawsuits. Director Goff discussed working with DHHR, ODCP and others to expand access to MAT and the related medications, and also issues with Naloxone distribution. Mr. Goff also mentioned the continuation of the PERD audit and the Workload Survey group. Motion was made by Board Member Bernabei to approve the report. The motion was seconded by Board Member Skaff and passed unanimously with no discussion.
3. The Chief Financial Officer then gave his report. Mr. Smolder gave FY2018, 2019, 2020 and 2021 Year End Summaries along with FY 2022 YTD comparison. Mr. Smolder then followed with the cash balance and remaining Fiscal Year Budget along with reports that are provided on a quarterly basis. Motion was made by Board Member Bernabei to accept the report. The motion was seconded by Board Member Misiti and passed unanimously with no discussion.
4. The General Counsel gave his report. Mr. Hatfield stated that there have been three administrative hearings since the last Board meeting. Mr. Hatfield stated that Director Goff and he had been working on an audit with the legislative auditor. Mr. Hatfield stated that he has been working on responding to a large subpoena requesting certain documents. Mr. Hatfield stated that he had sent the Board's Collaborative Practice Bill proposals to both the Board of Medicine and the Board of Osteopathic Medicine. Finally, Mr. Hatfield stated that he has drafted a proposed rule to govern inspections to be presented to the Board in order to satisfy an audit. Motion was made by Board Member Bernabei to accept the report. The motion was seconded by Board Member Skaff and passed unanimously with no discussion.
5. The Director of Professional and Regulatory Affairs then gave her report. Dr. Capehart Dr. Capehart provided a summary report of COVID-19 vaccinations, the Omicron variant and the monoclonal antibody demand/supply. She provided introductory remarks about the WV BOP Pharmacist Workload Task Force and the work it is undertaking. All communications to licensees regarding COVID-19 updates and the wvbop.wv.gov FAQ section were discussed. Motion was made by Board Member Bowyer to accept the report. The motion was seconded by Board Member Skaff and passed unanimously with no discussion.
6. Motion was made by Board Member Bernabei to enter Executive Session. The motion was seconded by Board Member Misiti and passed unanimously with no discussion.
7. Motion was made by Board Member Skaff to accept the recommendations of the Complaint Committee with two changes as noted below, finding probable cause to pursue discipline in the following cases: 2021-04-25; 2021-07-39 (Reprimand the facility permit holder, not the consultant); 2021-08-41; 2021-08-42; 2021-09-51; 2021-09-55 (Reprimand

- the facility permit holder); and 2021-10-59B. Board Member Bowyer recused from case number 2021-10-59B. Board Member Skaff recused herself from all cases involving Walgreens. The motion was seconded by Board Member Bowyer and passed unanimously.
8. Motion to deny the PT Trainee application of Ms. Shroyer due to felony drug conviction was made by Board Member Skaff. The motion was seconded by Board Member Bowyer and passed unanimously.
 9. The Chief Compliance Office gave his report. Mr. Robinette stated that 118 inspections were conducted in the last quarter. Mr. Robinette stated that the Board received 75 suspicious order reports between October 1, 2021 and November 30, 2021 with two reports requiring further investigation. In both instances of further investigation, evidence of valid prescription volume was evidenced. Mr. Robinette stated that inspectors have completed the work of identifying those facilities having a controlled substance permit, the type of service, and those that do not have a consultant pharmacist. Mr. Robinette stated that inspectors have begun inspecting pharmacies for compliance with USP 800. The inspectors have been writing Non-Compliance Reports for those facilities with seriously deficient compliance and giving them 30 days to meet compliance requirements. Mr. Robinette recommended that the Board approve biennial inspections of correctional facilities and have the consultant pharmacists provide copies of their inspection documents to the Board for inclusion in the database. Mr. Robinette recommended using the term "Long Term Care Facilities" in place of nursing homes and extended care facilities. Motion was made by Board Member Bowyer to accept the report and approve the recommendations of Mr. Robinette. The motion was seconded by Board Member Bernabei and passed unanimously.
 10. The Controlled Substance Monitoring Program Administrator then gave his report. Director Goff provided a brief summary of the 2021 CSMP Annual Report. Mr. Goff also gave an update of CDC grant funding and also mentioned the data projects being worked on by Board epidemiologists. Motion was made by Board Member Skaff to accept the report. The motion was seconded by Board Member Bernabei. and passed unanimously with no discussion.
 11. The CE Committee Report was then given by Board Member Bowyer. Board Member Bowyer stated that there were 29.5 CE Hours received, with 9.25 being approved.
 12. The following Pharmacy Technician Training Programs were presented for approval: Pierpont Landing Pharmacy, Belldina's Health Mart Pharmacy, Preston Family Pharmacy, Champion Pharmacy and Wellness, Highland Pharmacy and Wellness and Key Pharmacy and Wellness. Motion was made by Board Member Skaff to approve the training program applications. The motion was seconded by Board Member Misiti and passed unanimously with no discussion.
 13. Mr. Hatfield gave a brief overview of the legislative agenda for the Board for the 2022 Legislative Session. Mr. Hatfield stated that the Legislative Committee will hold bi-weekly meetings to discuss legislative items.
 14. Mr. Hatfield then presented 15 CSR 19, Emergency Rule Governing Inspections, for consideration by the Board. The Board made the following changes to the proposed version: extend all 30 day timeframes to 90 days; not more than 10% of pop-in inspections; change 10 years of practice experience to 10 years of pharmacy practice experience; change two days to report inspection reports to "must be submitted in a timely manner;" change 6.3 to "submit" to allow flexibility in submitting electronic copies; and state clearly that noncompliance must be fixed pursuant to the inspector's timeline or will be referred to the

Complaint Committee. Motion to accept the rule as revised was made by Board Member Misiti. The motion was seconded by Board Member Skaff and passed unanimously.

15. The Board set the following goals for the 2022 calendar year: conduct public service announcements; make the chief compliance officer a full-time position with no inspection responsibilities; form better relationship with DEA; provide employment benefits to inspectors; provide scholarships to the Pharmacy Recover Network; complete revisions to collaborative pharmacy practice; and expand protocols.
16. The next quarterly Board meeting is scheduled for March 27, and March 28, 2021, with the location to be determined.


President Lewis called the meeting to order and stated that a quorum was present. The agenda for the meeting had previously been posted on the Board's website and made available through the Board's office. The meeting was opened with a prayer.

1. Motion was made by Board Member Skaff to approve the December 12th and December 13th, 2021, meeting minutes, as amended to include recusals on discipline. The motion was seconded by Board Member Bernabei and passed unanimously with no discussion.
2. The Executive Director gave his report. Mr. Goff introduced Michael LeMasters as the Board's new Chief Compliance Officer. Director Goff then gave a brief office update, including details of the search for a new office location, staff discussions and the current lawsuit status. Mr. Goff then mentioned some of the recent legislative items and budget concerns. Motion was made by Board Member Bowyer to approve the report. The motion was seconded by Board Member Kapourales and passed unanimously with no discussion.
3. The Chief Financial Officer then gave his report. Mr. Smolder gave FY2018, 2019, 2020 and 2021 Year End Summaries along with FY 2022 YTD comparison. Mr. Smolder then followed with the cash balance and remaining Fiscal Year Budget along with reports that are provided on a quarterly basis. Mr. Smolder presented the cost of replacing the main water line due to the old water line leaking. Also Mr. Smolder presented a future cash balance analysis which the board asked for ideas to eliminate the cash sweep issue and to be presented at the next board meeting within a month. Motion was made by Board Member Skaff to accept the report. The motion was seconded by Board Member Bowyer and passed unanimously with no discussion.
4. The General Counsel gave his report. Mr. Hatfield stated that discipline was up to date and three hearings had been recently held. Mr. Hatfield stated that the previous legislative session went well for the Board, but that would be gone over in more depth at Monday's meeting. Mr. Hatfield stated that the Board is now being named in lawsuits regarding neonatal abstinence syndrome. Mr. Hatfield stated that the Board has been involved in responding to numerous subpoenas over the previous quarter. Additionally, Mr. Hatfield gave a brief update on the status of the PERD Audit that is to be presented in the Summer of 2022. Finally, Mr. Hatfield stated that the emergency rule governing inspections was posted for a 30 day comment period and the one comment received will be discussed at Monday's meeting. Motion was made by Board Member Skaff to accept the report. The motion was seconded by Board Member Misiti and passed unanimously with no discussion.
5. The Director of Professional and Regulatory Affairs then gave her report. Dr. Capehart provided an update on the WV COVID-19 vaccination plan, COVID therapeutics, and COVID cases. Dr. Capehart provided a summary of the numerous meetings (approximately every two weeks since November 2021) reviewing the survey from August 2021 and creating proposed recommendations. The proposed recommendations were provided to the Board for discussion and review. Dr. Capehart stated that a fraudulent prescription section has been added to the WVBOP website to alert pharmacists of identified fraudulent

prescriptions. Finally, Dr. Capehart stated that email blasts continue to be sent out and that the Board assisted the WV Bureau of Medical Services with a survey of pharmacy providers regarding certain pharmacy waivers. Motion was made by Board Member Misiti to accept the report. The motion was seconded by Board Member Bernabei and passed unanimously..

6. Motion was made by Board Member Kapourales to enter Executive Session. The motion was seconded by Board Member Bernabei and passed unanimously with no discussion.
7. Motion was made by Board Member Misiti to accept the recommendations of the Complaint Committee with the following revisions: table case number 2022-01-03. Board Member Skaff recused from all cases involving Walgreens. The Board voted to revoke for case number 2018-12-84. The Board voted to reinstate the license for case number 2019-10-59. Probable cause to pursue discipline was found in the following cases: 2021-10-68; 2021-10-69; 2021-11-71B; 2021-12-75; 2022-01-02B; and, that Board Member Skaff is hereby recused from all Walgreen cases. The motion was seconded by Board Member Lewis and passed unanimously.
8. Motion was made by Board President Lewis to give a 5% raise to all staff members excluding Executive Director Goff. The motion was seconded by Board Member Bernabei and passed unanimously.
9. Motion was made by Board Member Bowyer to give Executive Director Goff a 7.5% raise. The motion was seconded by Board Member Rucker and passed unanimously.
10. The Chief Compliance Officer gave his report. Mr. Robinette stated that a total of 196 inspections were conducted during the past quarter. The Board had received 115 suspicious order reports during the last quarter with 3 requiring further investigation. Once investigated further, no action was found to be needed as all three issues were resolved. The Board directed Chief Compliance Officer LeMasters to further investigate the USP 800 assessment of risk issue. Motion was made by Board Member Skaff to accept the report. The motion was seconded by Board Member Misiti and passed unanimously.
11. The Controlled Substance Monitoring Program Administrator then gave his report. Director Goff stated that drug overdose deaths are continuing at a high rate, and most deaths related to fentanyl and other illicit drugs. Mr. Goff also mentioned continued grant funding of the CSMP and related activities, and that Board epidemiologists were presenting at the Rx Drug Abuse & Heroin Summit in Atlanta. Motion was made by Board Member Kapourales to accept the report. The motion was seconded by Board Member Skaff. and passed unanimously with no discussion.
12. The CE Committee Report was then given by Board Member Bowyer. Board Member Bowyer stated that in the previous quarter there were 33.25 continuing education hours received and 20.25 were approved. This included 11 general hours, 2.25 consulting hours, and 7 drug diversion hours.
13. **MINUTES OF THE WEST VIRGINIA BOARD OF PHARMACY
JUNE 26, 2022 AND JUNE 27, 2022**

On Sunday, June 26, 2022, and Monday, June 27, 2022, the West Virginia Board of Pharmacy ("the Board") convened at the Four Points by Sheraton in Charleston, West Virginia, for the Board's quarterly board meeting. The following morning the Board completed its two-day meeting. The meeting was open to the public.

President Lewis called the meeting to order and stated that a quorum was present. The agenda for the meeting had previously been posted on the Board's website and made available through the Board's office. The meeting was opened with a prayer.

1. Motion was made by Board President Lewis to elect Board Member Bernabei President. The motion was seconded by Board Member Skaff. The motion passed unanimously without discussion.
2. Motion was made by Board Member Rucker to elect Board Member Lewis Vice President. The motion was seconded by Board Member Bernabei and passed unanimously.
3. Motion was made by Board Member Bowyer to approve the March 27 and March 29, 2022, meeting minutes, as amended to include recusals on discipline for Board Member Skaff. The motion was seconded by Board Member Misiti and passed unanimously with no discussion.
4. The Executive Director gave his report. Mr. Goff gave a brief office update, including the pending departures of Ryan Hatfield, Cindy Parsons and Nicki Hayes, and the subsequent search for replacements. Director Goff also gave a short summary of the various Board lawsuits, the Legislative Audit status and the latest development on the Budget. Motion was made by Board Member Skaff to approve the report. The motion was seconded by Board Member Bernabei and passed unanimously with no discussion.
5. The Chief Financial Officer then gave his report. Mr. Smolder gave FY2018, 2019, 2020 and 2021 Year End Summaries along with FY 2022 YTD comparison. Mr. Smolder then followed with the cash balance and remaining Fiscal Year Budget along with reports that are provided on a quarterly basis. Motion was made by Board Member Bernabei to approve the report. The motion was seconded by Board Member Bowyer and passed unanimously with no discussion.
6. The General Counsel then gave his report. Mr. Hatfield stated that discipline was in a good place. Further, Mr. Hatfield stated that his last day with the Board will be in the end of July 2022. Mr. Hatfield offered to help onboard his replacement and be as much help as possible. Motion was made by Board Member Skaff to approve the report. The motion was seconded by Board Member Misiti and passed unanimously with no discussion.
7. The Director of Professional and Regulatory Affairs then gave her report. DPRA Capehart presented an update of the COVID-19 vaccination and therapeutics response. Pfizer 6months through 4 years and Moderna 6 mo. through 5 years is now available and pharmacists, pharmacy interns, and pharmacy technicians are able to administer under the federal PREP Act for ages 3 years and up. Pharmacies continue to dispense Paxlovid and molnupiravir. Hospitals provide bebtelovimab. The WVBOP Pharmacy Workload Task Force has continued to meet since November 2021. The final recommendations are presented in rules changes incorporated in in §15-1, §15-7, and §15-15. These changes were presented and discussed. Summaries of the communications to licensees/registrants, DPRA contact report, and newsletters were also provided. Motion was made by Board


Member Skaff to approve the report. The motion was seconded by Board Member Misiti and passed unanimously without discussion.

8. Motion was made by Board Member Kapourales to enter Executive Session. The motion was seconded by Board Member Bernabei and passed unanimously with no discussion.
9. Motion was made by Board Member Skaff to accept the recommendations of the complaint committee, finding probable cause to pursue discipline in the following cases: 2021-10-66 and 2022-02-16, and revocations following hearings for 2019-05-30 and 2020-01-04.
10. The Chief Compliance Officer then gave his report. Mr. LeMasters stated that a total of 199 inspections were conducted during the past quarter. The Board had received 102 suspicious order reports during the last quarter with 3 requiring further investigation. After inquiries into each, no further action was required, as all three issues were resolved. Mr. LeMasters discussed a meeting held with DEA Diversion Group Supervisor, Jim Hischar, that focused on interprofessional communication and the development of process between agencies to make the review of suspicious order reports more efficient. LeMasters also said that he would be reviewing all DEA Form-106 reports to determine if action is required on behalf of the Board of Pharmacy and if a referral to other licensing agencies is necessary. Chief Compliance Officer reviewed a new process implemented using tools of the Controlled Substance Monitoring Program. The new process will enhance the reporting compliance of dispensers and remove an often-confusing portion of paperwork from the inspection process. A discussion was held regarding the license renewal application of a manufacturer/503B outsourcing facility. After a review of the information, a motion was made by Board Member Bernabei to deny the application for Hybrid Pharma at this time. The motion was seconded by Board Member Skaff, and the motion passed unanimously. Motion was made by Board Member Misiti to accept the report. The motion was seconded by Board Member Bowyer and passed unanimously without discussion.
11. The Chief Financial Officer then presented the Board's annual budget. Motion to approve the budget was made by Board Member Rucker. The motion was seconded by Board Member Bowyer and passed unanimously without discussion.
12. Motion to not renew the license of Ryan Cobb was made by Board Member Bernabei. The motion was seconded by Board Member Skaff and passed unanimously.
13. The Controlled Substances Monitoring Program Administrator then gave his report. Director Goff gave a brief summary of the current year dispensing numbers, which indicated a continued decline in most drug types. Mr. Goff also discussed continued CDC grant funding and mentioned various Board epidemiologist projects. Motion was made by Board Member Misiti to accept the report. The motion was seconded by Board Member Skaff and passed unanimously without discussion.
14. Board Member Bowyer then gave a brief CE Committee update.
15. Board Member Bowyer then gave a report on the NABP Annual Conference. Board Member Bernabei also provided an update on medical cannabis.
16. Motion was made by Board Member Skaff to approve the following programs: Adkins Pharmacy, Flat Iron Drug Store, Goodykoontz Drug Store and Mannington Pharmacy. The motion was seconded by Board Member Bernabei and passed unanimously with no discussion.
17. Motion was made by Board Member Skaff to approve the collaborative practice application for Alice Gahbauer. The motion was seconded by Board Member Bernabei and passed with Board Member Bowyer abstaining.

18. Motion was made by Board Member Skaff to give Dr. Capehart the authority to approve collaborative practice applications. The motion was seconded by Board Member Rucker and passed unanimously without discussion.
19. Motion to approve the following rules as presented was made by Board President Lewis: 15-20; 15-15; 15-7; and 15-1. The motion was seconded by Board Member Rucker and passed unanimously.
20. The next Board meeting was scheduled for September 18 and 19, 2022.
21. Motion to adjourn was made by Board Member Skaff. The motion was seconded by Board Member Bowyer and passed unanimously.
