INDEPENDENT AUDITOR'S SPECIAL REPORT

The Joint Committee on Government and Finance:

At your request, we have performed the procedures enumerated below regarding the West Virginia Board of Risk and Insurance Management's (BRIM) unfunded liability and procedures for hiring attorneys to defend the State and all other entities insured by BRIM when lawsuits are filed, and the procedures regarding settling claims filed against BRIM insureds during the period July 1, 2000 through June 30, 2002.

- 1. We reviewed the following documentation provided by the West Virginia Board of Risk and Insurance Management (BRIM):
 - A. Audited Balance Sheets, Audited Statements of Revenues, Expenses, and Changes in Retained Earnings and Audited Statements of Cash Flows for years ended June 30, 1997 through 2001.
 - B. Unaudited Statements of Net Assets and Unaudited Statements of Revenues, Expenses, and Changes in Fund Net Assets dated September 30 and December 31, 2001 and March 31, April 30, May 31, June 30, 2002.
 - C. A sample of 82 litigated case files.
 - D. American International Group, Inc. (AIG) Litigation Management Procedures
 - E. BRIM Claim Department Procedures
 - F. BRIM Board minutes for the period July 1, 1996 through June 4, 2002
 - G. Payments made by West Virginia University and Marshall University for past due premiums in comparison with the universities' payment agreement.
 - H. West Virginia University and Marshall University's payments for current fiscal year 2003 premiums.

2. We also reviewed the following:

- A. Chapter 29, Article 12 of the West Virginia Code, as amended.
- B. Chapter 29, Article 12B, Section 10 of the West Virginia Code.
- C. BRIM's Legislative Rule Title 115.

We were asked to determine the procedures, if any, that are used by the West Virginia Board of Risk and Insurance Management (BRIM) for settling claims out of court; the procedures used in hiring attorneys to represent State Agencies and Senate Bill 3 (SB3) entities when lawsuits are filed against them; the basis of the unfunded liability; and whether or not BRIM has obtained any loans to fund claim settlements being made due to the unfunded liability. Senate Bill 3 passed on May 22, 1986 states in part ". . . If requested by a political subdivision or by a charitable or public service organization, the board is authorized to provide property and liability insurance to the political subdivision or such organizations to insure their property, activities and responsibilities... "Political subdivision" means any county commission, municipality and county board of education; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; any instrumentality supported in most part by municipalities; any public body charged by law with the performance of a government function and whose jurisdiction is coextensive with one or more counties, cities or towns; a combined city-county health department created under pursuant to article two, chapter sixteen of this code; public service districts; and other instrumentalities including, but not limited to, volunteer fire departments and emergency service organizations as recognized by an appropriate public body and authorized by law to perform a government function: Provided, That hospitals of a political subdivision and their employees are expressly excluded from the provisions of this article. . . . Charitable or public service organization as used in this subsection means a bona fide, not for profit, tax-exempt, benevolent, educational, philanthropic, humane, patriotic, civic, religious, eleemosynary, incorporated or unincorporated association, but does not include any nonprofit association or organization, whether incorporated or not, which is organized primarily for the purposes of influencing legislation or supporting or promoting the campaign of any candidate for public office. . . . " We held several meetings with BRIM personnel to discuss the issues presented in this Special Report.

The results of our work are contained on the pages which follow.

GENERAL REMARKS

1. What is the basis of the unfunded liability?

The unfunded liability is the deficiency in retained earnings, which means BRIM does not have enough assets to offset their projected liabilities if all the claims would become due today. Any increase in claims without an increase in premiums would result in a greater deficiency. The deficiency in retained earnings went from (\$19,387,000) for the year ended June 30, 2001 to (\$37,934,000) an increase of \$18,547,000 for the year ended June 30, 2002. The Chief Financial Officer of BRIM stated an adjustment of \$22,650,201 was made regarding the estimate of unpaid claims during the quarter ending March 31, 2002, as a result of an internal policy recommended by BRIM management and the Board. BRIM had previously made the estimate of unknown claims at year end using the projection from their independent actuary.

Table X illustrates the increase in the estimated value of known claims and unknown claims (IBNR) for State Agencies and SB3 entities from June 30, 2001 to June 30, 2002, according to the information provided by BRIM from BRIM's independent actuarial report. The Incurred But Not Reported (IBNR) shown on Table X represents the actuarial projection of unknown claims which are expected to be filed against BRIM insureds in the future.

The amount of \$161,198,967 represents the midpoint range of the actuarial projection for known and unknown claims as of June 30, 2002, which is reflected as Current and Long-term Estimated Unpaid Claims of \$47,892,047 and \$113,306,919, respectively, on BRIM's Unaudited Statement of Net Assets dated June 30, 2002. According to BRIM's Unaudited Statement of Net Assets as of June 30, 2002, Total Assets increased by year's end by \$12,715,000; however, Total Liabilities also increased by a total of \$31,262,000, resulting in the net deficiency of \$18,547,000. BRIM has said the significant increase in the deficiency is attributed to the significant increase in reserves relating to the general liability insurance coverage for State Agencies and SB3 entities and the medical malpractice insurance coverage for State Agencies. The increase in general liability and medical malpractice types of insurance coverage represent 32% and 49% of the \$24,228,800 increase in the estimated unpaid claims reflected in Table X above. We asked BRIM what is the reason for the 49% increase (\$13,948,567.00 in Table X) in medical malpractice claims for State Agencies. BRIM stated they do not know why the medical malpractice claims have increased so dramatically, but did say that the majority of these claims were filed against the West Virginia University Medical School. We then asked them if the this increase was a trend to be expected in future years or was it a one time occurrence and BRIM again stated they do not know, but will research and find out the answers. BRIM stated they will research and find out the answers to these questions for the November interim meeting.

Table Y details the fiscal year 2002 and 2001 Total Liability and the increase in the Total Liability as of June 30, 2002 on the accrual basis of accounting. These numbers were obtained from the independent auditor's actuarial report (As shown in Table X above). The fiscal year 2002 Unfunded Liability was obtained from BRIM's Unaudited Statement of Net Assets dated June 30, 2002. The fiscal year 2001 Unfunded Liability was obtained from BRIM's Audited Balance Sheet dated June 30, 2001. The increase in Unfunded Liability is a calculation of the change of Unfunded Liability from fiscal year 2001 to 2002.

By using these percentages, the Chief Financial Officer at BRIM said the medical malpractice claims for State Agencies have generated approximately half (\$9 million) of the deficiency in net assets during fiscal year 2002. The remaining \$9 million of the \$18,547 million deficiency in net assets during fiscal year 2002 is due to approximately \$2 million for the new medical malpractice program for health care providers and the remaining \$7 million is due to general liability claims for State Agencies and SB3 entities.

2. Has BRIM obtained outside financing to fund payments of claims as a result of their unfunded liability?

We have found no evidence that BRIM has borrowed money to fund payments of claims. The only borrowing indicated on BRIM's Unaudited Statement of Net Assets dated June 30, 2002, is a \$500,000 loan. The Director of BRIM said the \$500,000 loan on their financial statements was a loan received from the Legislature per House Bill 601, which referred us to Chapter 29, Article 12B, Section 10 of the West Virginia Code. We reviewed Chapter 29, Article 12B, Section 10(b) of the West Virginia Code which stated "start-up operating expenses of the medical liability fund, not to exceed five hundred thousand dollars, may be transferred to the medical liability fund pursuant to an appropriation by the Legislature from any special revenue funds available. The medical liability fund shall reimburse the board within twenty-four months of the date of transfer" (Chapter 29, Article 12B is known as the West Virginia Health Care Provider Professional Liability Insurance Availability Act). House Bill 618 passed on December 1, 2001 states \$500,000 is to be expired from the Department of Administration's Board of Risk and Insurance Management's Premium Tax Savings Fund 2367 to the Department of Administration's Board of Risk and Insurance Management's Medical Liability Fund 2368.

3. How are attorneys hired to represent the State for BRIM cases?

BRIM has contracted with American International Group, Inc. (AIG) to provide claims management services on behalf of BRIM for all lawsuits filed against a State Agencies or SB3 entity regarding general liability, automobile liability, medical malpractice, property liability, and mine subsidence claims. AIG also process claims filed against State Agencies

and SB3 entities covered by BRIM under general liability, automobile liability and medical malpractice insurance policies. BRIM administers all property and mine subsidence claims. As stated in the contract with AIG, BRIM has given AIG the right and duty to defend lawsuits filed against an entity insured through BRIM and the ultimate responsibility for the selection of defense counsel. AIG has selected specific law firms to be part of their panel counsel. AIG chooses firms from this panel counsel to represent the State Agencies and SB3 entities. The procedures AIG has in place to put firms on AIG's legal panel are not documented by BRIM.

State Agencies and SB3 entities may request a specific law firm to represent them; these requests may either be for a firm on AIG's panel counsel or a firm not on the panel. BRIM does not know how often these requests for specific counsel are honored by AIG. The State Agencies or SB3 entity sends their written request for specific counsel to BRIM, who in turn forwards it to AIG. AIG has agreed to consult with the State Agencies or SB3 entity requesting specific counsel per their contract with BRIM; however, AIG has the final decision regarding assignment of counsel to handle a lawsuit.

We received a letter from Charles T. Waugh, AIG Service Center Manager, explaining the procedures used by AIG to establish a panel counsel in late 1995 and the procedures used to add a firm to the panel. The letter stated,

" AIG Claims Services, Inc. (AIGCS) began working for BRIM in late 1995. At that time there was a program in place, administered by another carrier, and AIG essentially took over the program and carried it forward.

As part of the transition from the prior insurance carrier, BRIM provided a list of law firms they wanted to retain to handle cases on behalf of persons and entities covered by the BRIM program. An approval process was then conducted regarding the firms listed by BRIM. Certain firms already appeared on AIGCS' approved panel of firms, and these were automatically approved for the BRIM program. The others were asked to complete a brief questionnaire and submit it with a firm resume to AIGCS. The submissions were reviewed with particular emphasis on conflicts, expertise, fee rates and prior representation of BRIM. I believe that all of the firms proposed by BRIM were approved in late 1995.

Since that time, there have been requests to approve additional firms to handle cases under the BRIM program. When this occurs, BRIM notifies the undersigned that they want to use a non-panel firm. They send a letter stating that they have used the firm in the past and would like to continue using the firm. I send the law firm a non-panel attorney questionnaire and request a firm resume. Once the completed non-panel questionnaire is returned, it is reviewed as described above for addition to the list of counsel approved to handle cases for BRIM.

All approvals are for specified lines of business consistent with the firms's expertise, e.g., casualty, workers compensation, professional liability, etc. Agreements concerning fees, adherence to guidelines and other conditions of retainer are confirmed in a Letter of Understanding executed by the firms. For your information, I enclose copies of the forms used as described above."

BRIM stated they will attempt to get a more thorough description of the procedures used by AIG to select firms for their panel counsel from AIG for the November interim meeting.

4. What are the procedures for settling claims out of court?

When an individual files a lawsuit against a State Agencies or SB3 entity insured by BRIM. the complaint filed with the court is forwarded to the State Agencies or SB3 entity. The State Agencies or SB3 entity gives notice of the complaint to BRIM by sending a letter and copy of the complaint to them; BRIM then forwards the letter of notice and complaint to AIG. Defense counsel is selected by AIG from their panel. The AIG claims representative and defense counsel develop an Agreed-To Litigation Plan which identifies and prioritizes the issues presented by the case and the activities they will undertake to address these issues, including the date by which these activities will be completed. An AIG claims representative monitors the progress of the case in comparison to the Agreed-To Litigation Plan. After initial discovery has been conducted, the defense counsel updates AIG by providing a verdict value, apportionment of fault, net exposure of the defense and a current settlement value. AIG provides this information to BRIM and requests settlement authority. BRIM authorizes settlement authority and negotiations for settlement between plaintiff and defense counsel before they proceed with the negotiations. BRIM has a Claim Settling and Documentation Policy & Procedure, revised on April 29, 1998, which states, "There is to be no payment of or settlement authority granted in excess of \$500,000 without the express written signature of the Director confirming such authority." As of August 14, 2002, the Director of BRIM stated he is approving all settlement authority requests above \$100,000. If no settlement can be reached within the settlement value approved by BRIM the case will go to trial.

BRIM's Legislative Rule Title 115, Series 3 effective on February 9, 1990 states a Review Committee will be "established to determine the eligibility of claims presented by agencies of the State for reimbursement from the Self-Insurance Fund. The committee members are 1) the Chairman of the Board or his designee, 2) the Director of the Budget Division, Department of Finance and Administration, and 3) a "floating" member from the State agency involved in the claim."

BRIM does not follow Legislative Rule Title 115, Series 3 because they have never established this review committee. The Director of BRIM said there was a problem with establishing the Review Committee because of the attorney-client privileged information issue with these cases. BRIM has a Claim Settling and Documentation Policy & Procedure effective February 11, 2002 which states: "For settlement authority requests which exceeds

\$750,000, an Internal Review Committee will be convened for purposes of reviewing such requests. The Committee will consist of the Director, the Claim Manager and one other BRIM Department Head or other person designated by the Director. A unanimous decision of the three will be necessary for extension of settlement authority in an amount greater than \$750,000. Should the Committee fail to reach a unanimous decision, the claim will be submitted to the Board members for their consideration."

We reviewed a total of 82 litigated claim files and saw evidence of active defendant participation during the process of evidence discovery. The Director of BRIM said the State Agencies or SB3 entity involved in the lawsuit are given copies of the documentation BRIM receives from AIG keeping them informed of the case's progression. Chapter 29, Article 12, Section 5 of the West Virginia Code, as amended, authorizes and empowers BRIM "to negotiate and effect settlement of any and all insurance claims arising on or incident to losses of and damages to state properties, activities and responsibilities hereunder and shall have authority to execute and deliver proper releases of all such claims when settled".

We also asked about any State Agencies or SB3 entities who were in arrears with their premium payments to BRIM. The Director of BRIM identified West Virginia University (WVU) and Marshall University (Marshall) as the only insureds who are delinquent with their premium payments. According to BRIM, WVU and Marshall had a total indebtedness of \$2,070,840 and \$738,943, respectively, for fiscal year 2001. BRIM developed a payment plan for the universities to pay back the indebtedness. The payment plan called for a payment of 1/3 of their total indebtedness or \$690,280 and \$246,314, respectfully, to be paid by June 30, 2001. These payments were made on by WVU and Marshall on June 26, 2001 and June 22, 2001, respectively. The remaining 2/3 of the outstanding balance for WVU and Marshall or \$1,380,560 and \$492,628.67, respectively, will be made in monthly payments beginning July 30, 2001 through June 30, 2003. The monthly payment amounts for WVU and Marshall are \$57,523 and \$20,525, respectively. The following chart details the premium amounts due and paid toward the universities' outstanding premium balances for the period June 30, 2001 through August 31, 2002:

For the current fiscal year 2003, BRIM sent a quarterly billings to WVU and Marshall in the amounts of \$1,665,887 and \$529,417 on July 3, 2002. WVU paid \$1,665,887 on July 30, 2002 and Marshall paid \$529,147 on August 20, 2002; therefore, WVU and Marshall are current with their fiscal year 2003 premium payments.

Attached is a schedule of Senate Bill 3 entities insured by BRIM as of October 2, 2002.

Dear Mr. Shankin:

I have received your most recent draft of the Independent Auditor's special report, which accurately reflects the discussion and comments in the exit conference this morning.

Additionally, we advised that our studies revealed from June 30, 2001 to June 30 2002, there was an increase in open state agency medical malpractice claims from 106 to 132. We advised that the percentage of medical malpractice claims showed that 27% were OBGYN birth trauma and 32% surgery complications with the remaining 41% being all other specialties.

We will continue to monitor the claim activity to determine if there are repeat physician occurrences and/or other external factors such as more high risk patients to contribute to the increase and provide additional information. We will contact and work with West Virginia University and Marshall University to make these determinations and provide this information during the November interims.

Lastly, as it was indicated that the response from AIG was not as conclusive as was anticipated, we will follow up with AIG for more definitive panel counsel selection criteria to also be made available during the November interims.
