Dear Mr. President and Mr. Speaker:

As part of the audit of the State's fleet management practices, the Legislative Auditor directed the Post Audit Division to conduct an analysis of state-owned vehicles with Class A license plates (The Class A license plate is a plate that a private citizen has on their personal vehicle). Each spending unit of state government was asked to submit data regarding any vehicle in their fleet with a Class A plate. According to the data submitted by each state spending unit, West Virginia's fleet of state-owned vehicles includes 293 vehicles with a Class A license plate. Of these, 182 (62 percent) are assigned to the West Virginia State Police, to whom the DMV is statutorily authorized to issue an unlimited number of Class A license plates. A full listing of the number of Class A license plates issued to each state agency is attached.

At the December interim meeting of the Joint Committee on Government Organization and Government Operations, the Legislative Auditor reported that six agencies were in possession of more Class A license plates than authorized by West Virginia Code §17A-3-23, as shown in Table 1.

The Legislative Auditor recommended that each of the six agencies reduce its number of Class A license plates to comply with Code and report back its compliance with the Post Audit Division. The Division of Protective Services, Alcohol Beverage Control Administration, State Auditor's Office, and Regional Jail and Correctional Facility Authority have complied, or indicated plans to comply with the Legislative Auditor's recommendation. The Attorney General's Office and the Division of Corrections have not indicated compliance or plans to comply.

Finally, the Legislative Auditor asked each agency with Class A plates to justify having a Class A plate in lieu of a green state license plate for all vehicles other than those used for undercover or investigative work. In response, most agencies either cited their statutory authorization to possess Class A plates or cited security reasons as justification.

Most public and elected officials, such as the members of the West Virginia Legislature, the West Virginia Supreme Court of Appeals, and members of Congress all have special license plates indicating their status as a public official. The Legislative Auditor concludes that the security justification for having a Class A license plate on any state-owned vehicles that are not used in undercover or investigative work is questionable. It is the opinion of the Legislative Auditor that public officials should be held to a higher standard of accountability, and that possessing a Class A license plate on a state-owned vehicle that is not used in undercover or investigative work, particularly for commuting vehicles, gives the false impression that these vehicles are privately owned and impedes the ability of the public to hold its officials accountable. Therefore, the Legislative Auditor recommends that the Legislature consider restricting authorization for Class A license plates to only those state-owned vehicles used for undercover or investigative work.
