West Virginia Supreme Court of Appeals Domestic Appeals Summary FY2014



- 764 appeals were filed between July 1, 2013 and June 30, 2014 (fiscal year 2014) from Family Court final orders to the Circuit Court. In comparison to original petition filings for the same time period, appeals totaled approximately two percent.
- 233 appeals were refused during FY2014.
- 572 appeals were disposed during the fiscal year.
- 92 were remanded back to Family Court.
- Of those disposed, the average* age at disposal was 47 days.
- 202 petitioners represented themselves in their appeal.
- No appeals were reported as automatically transferred to the Supreme Court.
- Of the subject matters reported for these appeals, the most frequent was other at 22 percent.

**Data collected from the Circuit Clerks is reported in a summarized format, monthly. Therefore, if a judge disposed of more than one case of a particular type during a single month the age at disposal was reported as an average of such cases. The average calculated for this report utilizes the data collected on such reports and, consequently, may average summarized information.*
