



On October 26, 2010, the Board implemented the Governor's directive to utilize rental vehicles instead of privately owned vehicles, as a cost saving measure, for Board travel.








SURVEYORS 6-YEAR REVIEW (ACTIVE)

SURVEYORS 6-YEAR REVIEW (DELINQUENT)




LICENSE RENEWAL (Active & Inactive)







COMPLAINTS

Complaints are processed in accordance with Procedural Rule 23 CSR 3, *Disciplinary and Complaint Procedures for Land Surveyors* (2001). Once a complaint is received at the Board office, an acknowledgement letter explaining the complaint process is mailed to the complainant with a copy to the licensed surveyor. The complaint then goes through a preliminary review to determine whether it is founded or unfounded. An unfounded complaint is outside the jurisdiction of the Board or there are insufficient grounds to pursue an investigation. If the Board concurs, unfounded complaints are summarily dismissed. Founded complaints are filed, assigned a complaint number, and the licensee is sent a certified letter to respond to the allegations within 30 days. Following an opportunity for the complainant to review and respond to the surveyor's response, the complaint is sent to the Board's Complaint Review Committee (CRC) for review and recommendation.

During Fiscal Year 2011, 13 complaint forms were mailed and 2 emailed to potential complainants with an undetermined number downloaded from the Board's website. 9 founded (filed) complaints were received and an additional 10 complaints were filed by the Board. Of the 23 founded (filed) complaints, 9 or 39% were from unlicensed practice and 14 or 61% involved licensees.

The CRC assists the Board in the review and investigation of founded complaints by: summarizing complaint allegations and reviewing the surveyor's response to them; providing technical review and evaluation of the facts as they relate to the law, rules or regulations; and to make recommendations to the Board for further action. The CRC, which is chaired by Board Member Mark H. Hornish, P.S., consists of four other licensed professional surveyors who also function as contract investigators. The members represent different regions throughout the state and do not investigate complaints within their respective areas.


