

The current language in the DOP qualifications for the Sanitarian 2, Registered Sanitarian, Sanitarian Supervisor and Sanitarian Chief excludes candidates who may qualify but are not currently required to register with the WV State Board of Sanitarians. Sanitarians or Environmental Health Specialists are employed by other states, federal agencies or private companies will hold national or state certifications as Registered Environmental Health Specialist (REHS) or Registered Sanitarian (RS).


Lloyd White made a motion to support the above changes to the DOP listings, seconded by Richard Wheeler. Motion passed.

There were no SIT waivers needed for being a SIT longer than three years.



Also, that they accept a passing score on the PES exam in lieu of passing the NEHA REHS/RS test. This would be the same as they did for one year after the Board switched from giving the PES exam to the NEHA REHS/RS exam. The Board felt that they needed more information so the matter was tabled until the next Board meeting when Jennifer can present more information.



The Policies required by BRIM were discussed by Linda Lyter. Motion to Approve by Warren Elmer, seconded by Delores Cook. Motion passed.


New Rule Series 5 Waiver of Initial Application Fee based on Low Income was submitted and filed.
