In June of 2012, the West Virginia State Police opened the Post Exchange in accordance with West Virginia Code §15-2E-2. The Post Exchange is available to provide items of convenience and necessity as well as apparel and collectible memorabilia for purchase to individuals involved in training at the Academy and Professional Development Center (PDC). The Post Exchange is located in the PDC of the West Virginia State Police Academy in Institute, West Virginia. A uniformed member maintains and supervises the Post Exchange's operations and logistics.

During Fiscal Year 2015 and 2016, the funds derived from the Post Exchange were used for the sole purpose of purchasing inventory and payment of credit card fees, which are ordinary operating expenses.

The PDC is a 12,000 square foot facility with four large classrooms, multiple offices, storage rooms, and restrooms utilized to provide advanced level training and seminars to various law enforcement agencies throughout the state. These individuals receive training and updates related to law enforcement topics and skills. The PDC offers a location for numerous state and local agencies to provide their employees training and education to support their efforts to enforce state and local laws. Annually, the PDC hosts over 5,000 students and instructors.

The West Virginia State Police (WVSP) Academy is the only entry level law enforcement training facility in the state and certifies every newly hired officer from every law enforcement agency within the state, excluding federal agencies. All entry level officers in training reside at the WVSPA throughout the week and are released on the weekends during their training. On average, the WVSP Academy trains and certifies approximately 225 new officers every year.
