(BY SENATORS CRAIGO, ANDERSON, BAILEY, CHAFIN, HELMICK, JACKSON, LOVE, PLYMALE, PREZIOSO, MACNAUGHTAN, SHARPE, WALKER, BOLEY, DUGAN, MCKENZIE, MINEAR AND SPROUSE)

[Passed April 12, 1997; in effect from passage.]

AN ACT making a supplementary appropriation of public moneys out of the treasury from the balance of moneys remaining as an unappropriated surplus balance in the state fund, general revenue, to the department of agriculture, account no. fund 0131, fiscal year 1997, organization 1400, all supplementing and amending the appropriation for the fiscal year ending the thirtieth day of June, one thousand nine hundred ninety-seven.

WHEREAS, The governor submitted to the Legislature the executive budget document, dated February 12, 1997, which included a statement of the state fund, general revenue, setting forth therein the cash balance and investments as of July 1, 1996, and further included the estimate of revenues for fiscal year 1996-97, less net appropriation balances forwarded and regular appropriations for fiscal year 1996-97.

WHEREAS, It thus appearing from the governor's executive budget document there now remains an unappropriated surplus balance in the state treasury which is available for appropriation during the fiscal year ending the thirtieth day of June, one thousand nine hundred ninety-seven; therefore

Be it enacted by the Legislature of West Virginia:

That the total appropriation for the fiscal year ending the thirtieth day of June, one thousand nine hundred ninety-seven, to account no. fund 0131, fiscal year 1997, organization 1400, be supplemented and amended by increasing the total appropriation by two hundred seventy-five thousand dollars as follows:
