AN ACT establishing a fund and making a supplementary appropriation of federal funds out of the treasury from the balance of federal moneys remaining unappropriated for fiscal year ending the thirtieth day of June, two thousand three, to the secretary of state - federal consolidated fund, fund 8854, fiscal year 2003, organization 1600, creating and supplementing the appropriation for fiscal year ending the thirtieth day of June, two thousand three.

WHEREAS, The Legislature has established the availability of federal funds for programs now available for expenditure in fiscal year ending the thirtieth day of June, two thousand three, which are hereby appropriated by the terms of this supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

That the total appropriation for fiscal year ending the thirtieth day of June, two thousand three, to the secretary of state, fund 8854, fiscal
