AN ACT expiring funds to the unappropriated balance in the state fund, general revenue, for the fiscal year ending the thirtieth day of June, two thousand five, in the amount of two million five hundred thousand dollars from the board of risk and insurance management - premium tax savings fund, fund 2367, fiscal year 2005, organization 0218.

WHEREAS, The Legislature finds that the account balance in the board of risk and insurance management - premium tax savings fund, fund 2367, fiscal year 2005, organization 0218, will exceed that which is necessary for the purposes for which the account was established; therefore

*Be it enacted by the Legislature of West Virginia:*

- 1 That the balance of the funds available for expenditure
- 2 in the fiscal year ending the thirtieth day of June, two
- 3 thousand five, to the board of risk and insurance manage-
- 4 ment - premium tax savings fund, fund 2367, fiscal year
- 5 2005, organization 0218, be decreased by expiring the

6 amount of two million five hundred thousand dollars to  
7 the unappropriated balance of the state fund, general  
8 revenue, to be available for appropriation during fiscal  
9 year two thousand five.

10 The purpose of this bill is to expire the sum of two  
11 million five hundred thousand dollars from the board of  
12 risk and insurance management - premium tax savings  
13 fund, fund 2367, fiscal year 2005, organization 0218, to the  
14 unappropriated balance in the state fund, general revenue,  
15 for the fiscal year ending the thirtieth day of June, two  
16 thousand five, to be available for appropriation during  
17 fiscal year two thousand five.
