AN ACT supplementing, amending, decreasing and increasing items of the existing appropriations from the State Road Fund to the Department of Transportation, Division of Highways, fund 9017, fiscal year 2009, organization 0803, for the fiscal year ending June 30, 2009, by supplementing and amending the appropriations for the fiscal year ending June 30, 2009.

WHEREAS, The Governor submitted to the Legislature the Executive Budget Document, dated February 11, 2009, which included the statement of the State Road Fund setting forth therein the cash balances and investments as of July 1, 2008, and further included the estimate of revenues for the fiscal year 2009, less net appropriation balances forwarded and regular appropriations for the fiscal year 2009; and

WHEREAS, It thus appears from the Governor's Executive Budget Document, statement of the State Road Fund, there now remains an unappropriated balance in the State Treasury which is available for appropriation during the fiscal year ending June 30, 2009; therefore

Be it enacted by the Legislature of West Virginia:

1 That the items of the total appropriation from the State
2 Road Fund, fund 9017, fiscal year 2009, organization 0803,
3 be supplemented and amended to read as follows:

30 The above appropriations are to be expended in accor-
 31 dance with the provisions of chapters seventeen and
 32 seventeen-c of the Code of West Virginia.

33 The Commissioner of Highways shall have the author-
 34 ity to operate revolving funds within the State Road Fund
 35 for the operation and purchase of various types of equip-
 36 ment used directly and indirectly in the construction and
 37 maintenance of roads and for the purchase of inventories
 38 and materials and supplies.

39 There is hereby appropriated within the above items
 40 sufficient money for the payment of claims, accrued or
 41 arising during this budgetary period, to be paid in accor-
 42 dance with sections seventeen and eighteen, article two,
 43 chapter fourteen of the Code of West Virginia.

44 It is the intent of the Legislature to capture and match
 45 all federal funds available for expenditure on the Appala-
 46 chian Highway System at the earliest possible time.
 47 Therefore, should amounts in excess of those appropriated
 48 be required for the purposes of Appalachian programs,
 49 funds in excess of the amount appropriated may be made
 50 available upon recommendation of the commissioner and
 51 approval of the Governor. Further, for the purpose of
 52 Appalachian programs, funds appropriated to line items
 53 may be transferred to other line items upon recommenda-
 54 tion of the commissioner and approval of the Governor.

55 The purpose of this supplemental appropriation bill is
 56 ~~to supplement, amend, decrease, increase and add items of~~
 57 appropriation in the aforesaid account for the designated
 58 spending unit for expenditure during the fiscal year
 59 ending June 30, 2009.
