10 A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section, designated §5-5-7; to amend said 11 code by adding thereto a new section, designated §5-10-22k; 12 1.3 and to amend said code by adding thereto a new section, 14 designated \$18-7A-26v, all relating to providing cost-of--15 living adjustments for certain current and former public 16 employees generally; providing a \$1,200 cost-of-living 17 adjustment to be paid in full by June 30, 2011; providing for selection of payment date by the State Auditor; requiring 18 19 payment of the cost-of-living adjustments upon authorization; 20 providing for transfer and expenditure of funding appropriated 21 to State Budget Office to spending units and county boards of 22 education for payment of the cost-of-living adjustments; 23 defining terms; providing for \$1,200 cost-of-living adjustment 24 to certain retirees of the Public Employees Retirement System 25 and the state Teachers Retirement System by June 30, 2011; and providing for the pro rata distribution of the cost-of-living 26

- 1 adjustment to certain beneficiaries.
- 2 Be it enacted by the Legislature of West Virginia:
- 3 That the Code of West Virginia, 1931, as amended, be amended
- 4 by adding thereto a new section, designated §5-5-7; that said code
- 5 be amended by adding thereto a new section, designated §5-10-22k;
- 6 and that said code be amended by adding thereto a new section,
- 7 designated \$18-7A-26v, all to read as follows:
- 8 CHAPTER 5. GENERAL POWERS AND AUTHORITY OF THE GOVERNOR,

- 12 ARTICLE 5. SALARY INCREASE FOR STATE EMPLOYEES.
- 13 §5-5-7. Authorizing cost-of-living adjustments to full-time public
- employees.
- 15 (a) A \$1,200 cost-of-living adjustment is authorized for
- 16 public employees with at least one hundred eighty calendar days of
- 17 continuous service as of July 1, 2010. The cost-of-living
- 18 adjustment authorized by the provisions of this section shall be
- 19 paid no later than June 30, 2011.
- 20 (b) The cost-of-living adjustment authorized pursuant to this

 5 retirement system as provided in subsection (b) of this section.
 6 The cost-of-living adjustment shall equal \$1,200 and shall be paid
 7 in full by June 30, 2011.
- 8 (b) The cost-of-living adjustment provided in this section 9 applies to any retiree who currently receives an annual retirement 10 annuity. This cost-of-living adjustment is subject to any 11 applicable limitations under Section 415 of the Internal Revenue 12 Code of 1986, as amended.
- (c) The cost-of-living adjustment provided by this section 14 shall be payable pro rata to any beneficiaries of a qualifying 15 retiree who currently receives an annuity or other benefit payable 16 by the retirement system. It is the intent of the Legislature that 17 the cost-of-living adjustment authorized by this section be 18 retroactive to July 1, 2010, when the budget surplus was realized.

NOTE: The purpose of this bill is to provide a \$1,200 cost of living adjustment to all eligible state employees and retirees.

\$5-5-7, \$5-10-22k and \$18-7A-26v are new; therefore, they have been completely underscored.
