10	AN ACT to amend the Code of West Virginia, 1931, as amended, by
11	adding thereto a new section, designated §17A-6-10d, relating
12	to special plates for the testing of vehicles operated by
13	nonprofit corporations engaged in research and development of
14	motor vehicles, special fuels or equipment for motor vehicles;
15	requiring written records be kept; nonprofit corporations
16	issued a special plate are not required to comply with the
17	bond or dealer recovery fund otherwise required for that
18	vehicle; requiring vehicles to be insured; and exempting the
19	vehicles from safety inspections, but requiring the vehicles
20	to be safe.
21	Be it enacted by the Legislature of West Virginia:
22	That the Code of West Virginia, 1931, as amended, be amended
23	by adding thereto a new section, designated $$17A-6-10d$, to read as
24	follows:
25	ARTICLE 6. LICENSING OF DEALERS AND WRECKERS OR DISMANTLERS;

1 SPECIAL PLATES; TEMPORARY PLATES OR MARKERS.

2 §17A-6-10d. Special plates for nonprofit corporations engaged in

- 3 research and development.
- 4 (a) Notwithstanding any of the other provisions of this 5 article, a nonprofit corporation engaged in research and 6 development using motor vehicles pursuant to article twelve, 7 chapter eighteen-b of this code and affiliated with institutions of 8 higher education may operate or move a vehicle, either owned or in 9 the possession of the nonprofit corporation upon the highways of 10 this state for purposes of transporting or testing that vehicle 11 without first registering or titling the vehicle and displaying, in 12 a manner prescribed by the commissioner, a special plate issued to 13 the nonprofit corporation as provided in this section.
- (b) Any nonprofit corporation as prescribed in subsection (a)
 15 of this section may make application to the commissioner upon a
 16 form prescribed by him or her for a certificate containing a
 17 general distinguishing number and for a special plate or plates.
 18 The applicant shall verify that it is a Section 501(c)(3) of the
 19 Internal Revenue Code of 1986, as amended, nonprofit corporation
 20 and submit sufficient information, as may be required by the
 21 commissioner, that it is engaged in research and development of
 22 vehicles, special fuels or equipment for motor vehicles.
- (c) The commissioner, upon approving an application, may issue without charge to the applicant, a certificate containing the 25 nonprofit corporation's name and address and its general

- 1 distinguishing number. The commissioner may also issue without
- 2 charge, a special plate or plates, as determined by the
- 3 commissioner as necessary, that must be displayed on the vehicle.
- 4 Each plate shall also contain a number or symbol distinguishing it
- 5 from other plates bearing the same general distinguishing number.
- 6 (d) The nonprofit corporation that is issued a special plate
- 7 pursuant to this section must keep written records as required by
- 8 the commissioner concerning the operation of the vehicle. The
- 9 records shall be open to inspection by any law-enforcement officer
- 10 or division employee.
- 11 (e) This section does not apply to the use of any other
- 12 vehicles owned, leased or operated by the nonprofit corporation.
- 13 (f) A nonprofit corporation that has been issued a special
- 14 plate is not required to comply with the bond or dealer recovery
- 15 fund otherwise required under this article for that vehicle.
- 16 (g) A nonprofit corporation that has been issued a special
- 17 plate shall furnish information, satisfactory to the commissioner,
- 18 that the vehicle is covered by an appropriate insurance policy or
- 19 proof of financial responsibility in amounts not less than the
- 20 requirements of section two, article four, chapter seventeen-d of
- 21 this code.
- (h) Vehicles operated by a nonprofit corporation pursuant to
- 23 this section are exempt from the annual motor vehicle inspection
- 24 and the displaying of the certificate of inspection otherwise
- 25 required by article sixteen, chapter seventeen-c of this code.
- 26 However, a vehicle that has been issued a special plate pursuant to

- 1 this section must be safe and may not, in any manner, endanger the
- 2 driver, other vehicle occupants, other motorists, pedestrians or
- 3 the general public.
