10	A BILL to amend and reenact $\$17A-3-14$ of the Code of West Virginia,
11	1931, as amended, relating to authorizing the Division of
12	Motor Vehicles to issue a special license plate for applicants
13	who are hearing impaired; establishing requirements for
14	eligibility; and fees.
15	Be it enacted by the Legislature of West Virginia:
16	That \$17A-3-14 of the Code of West Virginia, 1931, as amended,
17	be amended and reenacted to read as follows:
18	ARTICLE 3. ORIGINAL AND RENEWAL OF REGISTRATION; ISSUANCE OF
19	CERTIFICATES OF TITLE.
20	$\S17A-3-14$. Registration plates generally; description of plates;
21	issuance of special numbers and plates;
22	registration fees; special application fees;
23	exemptions; commissioner to promulgate forms;
24	suspension and nonrenewal.
25	(a) The division upon registering a vehicle shall issue to the

- 1 owner one registration plate for a motorcycle, trailer, semitrailer 2 or other motor vehicle.
- 3 (b) Registration plates issued by the division shall meet the 4 following requirements:
- 5 (1) Every registration plate shall be of reflectorized material 6 and have displayed upon it the registration number assigned to the 7 vehicle; for which it is issued the name of this state, which may
- 8 be abbreviated; and the year number for which it is issued or the

9 date of expiration of the plate.

- 10 (2) Every registration plate and the required letters and 11 numerals on the plate shall be of sufficient size to be plainly 12 readable from a distance of one hundred feet during daylight.
- 13 Provided, That The requirements of this subdivision shall not apply
 14 to the year number for which the plate is issued or the date of
 15 expiration.
- 16 (3) Registration numbering for registration plates shall begin 17 with number two.
- 18 (c) The division may not issue, permit to be issued or 19 distribute any special registration plates except as follows:
- 20 (1) The Governor shall be issued two registration plates, on 21 one of which shall be imprinted the numeral one and on the other 22 the word one.
- 23 (2) State officials and judges may be issued special 24 registration plates as follows:
- 25 (A) Upon appropriate application, the division shall issue to 26 the Secretary of State, State Superintendent of Schools, Auditor,

- 1 Treasurer, Commissioner of Agriculture and the Attorney General, 2 the members of both houses of the Legislature, including the 3 elected officials of both houses of the Legislature, the justices 4 of Supreme Court of Appeals of West Virginia, the the 5 representatives and senators of the state in the Congress of the 6 United States, the judges of the West Virginia circuit courts, 7 active and retired on senior status, the judges of the United 8 States district courts for the State of West Virginia and the 9 judges of the United States Court of Appeals for the fourth 10 circuit, if any of the judges are residents of West Virginia, a 11 special registration plate for a Class A motor vehicle and a 12 special registration plate for a Class G motorcycle owned by the 13 official or his or her spouse. Provided, That In addition, the 14 division may issue a Class A special registration plate for each 15 vehicle titled to the official and a Class G special registration 16 plate for each motorcycle titled to the official.
- (B) Each plate issued pursuant to this subdivision shall bear any combination of letters and numbers not to exceed an amount determined by the commissioner and a designation of the office.

 20 Each plate shall supersede the regular numbered plate assigned to the official or his or her spouse during the official's term of office and while the motor vehicle is owned by the official or his or her spouse.
- (C) The division shall charge an annual fee of \$15 for every registration plate issued pursuant to this subdivision, which is in addition to all other fees required by this chapter.

- 1 (3) The division may issue members of the National Guard forces 2 special registration plates as follows:
- (A) Upon receipt of an application on a form prescribed by the division and receipt of written evidence from the chief executive officer of the Army National Guard or Air National Guard, as appropriate, or the commanding officer of any United States Armed Forces reserve unit that the applicant is a member thereof, the division shall issue to any member of the National Guard of this state or a member of any reserve unit of the United States Armed Forces a special registration plate designed by the commissioner for any number of Class A motor vehicles owned by the member. Upon presentation of written evidence of retirement status, retired members of this state's Army or Air National Guard, or retired members of any reserve unit of the United States Armed Forces, are eligible to purchase the special registration plate issued pursuant to this subdivision.
- 17 (B) The division shall charge an initial application fee of \$10 18 for each special registration plate issued pursuant to this 19 subdivision, which is in addition to all other fees required by 20 this chapter. Except as otherwise provided herein, effective July 21 1, 2007, all fees currently held in the special revolving fund used 22 in the administration of this section and all fees collected by the 23 division shall be deposited in the State Road Fund.
- (C) A surviving spouse may continue to use his or her deceased spouse's National Guard forces license plate until the surviving spouse dies, remarries or does not renew the license plate.

- 1 (4) Specially arranged registration plates may be issued as 2 follows:
- 3 (A) Upon appropriate application, any owner of a motor vehicle
- 4 subject to Class A registration, or a motorcycle subject to Class
- 5 G registration, as defined by this article, may request that the
- 6 division issue a registration plate bearing specially arranged
- 7 letters or numbers with the maximum number of letters or numbers to
- 8 be determined by the commissioner. The division shall attempt to
- 9 comply with the request wherever possible.
- 10 (B) The commissioner shall propose rules for legislative
- 11 approval in accordance with the provisions of chapter twenty-nine-a
- 12 of this code regarding the orderly distribution of the plates.
- 13 Provided, That For purposes of this subdivision, the registration
- 14 plates requested and issued shall include all plates bearing the
- 15 numbers two through two thousand.
- 16 (C) An annual fee of \$15 shall be charged for each special
- 17 registration plate issued pursuant to this subdivision, which is in
- 18 addition to all other fees required by this chapter.
- 19 (5) The division may issue honorably discharged veterans
- 20 special registration plates as follows:
- 21 (A) Upon appropriate application, the division shall issue to
- 22 any honorably discharged veteran of any branch of the armed
- 23 services of the United States a special registration plate for any
- 24 number of vehicles titled in the name of the qualified applicant
- 25 with an insignia designed by the Commissioner of the Division of
- 26 Motor Vehicles.

- 1 (B) The division shall charge a special initial application fee 2 of \$10 in addition to all other fees required by law. This special 3 fee is to compensate the Division of Motor Vehicles for additional 4 costs and services required in the issuing of the special 5 registration. All fees collected by the division shall be 6 deposited in the State Road Fund. *Provided*, That However, nothing 7 in this section may be construed to exempt any veteran from any 8 other provision of this chapter.
- 9 (C) A surviving spouse may continue to use his or her deceased 10 spouse's honorably discharged veterans license plate until the 11 surviving spouse dies, remarries or does not renew the license 12 plate.
- 13 (6) The division may issue disabled veterans special 14 registration plates as follows:
- (A) Upon appropriate application, the division shall issue to any disabled veteran who is exempt from the payment of registration fees under the provisions of this chapter a registration plate for a vehicle titled in the name of the qualified applicant which bears the letters "DV" in red and also the regular identification numerals in red.
- 21 (B) A surviving spouse may continue to use his or her deceased 22 spouse's disabled veterans license plate until the surviving spouse 23 dies, remarries or does not renew the license plate.
- (C) A qualified disabled veteran may obtain a second disabled 25 veterans license plate as described in this section for use on a 26 passenger vehicle titled in the name of the qualified applicant.

- 1 The division shall charge a one-time fee of \$10 to be deposited
- 2 into the State Road Fund, in addition to all other fees required by
- 3 this chapter, for the second plate.
- 4 (7) The division may issue recipients of the distinguished
- 5 Purple Heart medal special registration plates as follows:
- 6 (A) Upon appropriate application, there shall be issued to any
- 7 armed service person holding the distinguished Purple Heart medal
- 8 for persons wounded in combat a registration plate for a vehicle
- 9 titled in the name of the qualified applicant bearing letters or
- 10 numbers. The registration plate shall be designed by the
- 11 Commissioner of Motor Vehicles and shall denote that those
- 12 individuals who are granted this special registration plate are
- 13 recipients of the Purple Heart. All letterings shall be in purple
- 14 where practical.
- 15 (B) Registration plates issued pursuant to this subdivision are
- 16 exempt from all registration fees otherwise required by the
- 17 provisions of this chapter.
- 18 (C) A surviving spouse may continue to use his or her deceased
- 19 spouse's Purple Heart medal license plate until the surviving
- 20 spouse dies, remarries or does not renew the license plate.
- 21 (D) A recipient of the Purple Heart medal may obtain a second
- 22 Purple Heart medal license plate as described in this section for
- 23 use on a passenger vehicle titled in the name of the qualified
- 24 applicant. The division shall charge a one-time fee of \$10 to be
- 25 deposited into the State Road Fund, in addition to all other fees
- 26 required by this chapter, for the second plate.

- 1 (8) The division may issue survivors of the attack on Pearl 2 Harbor special registration plates as follows:
- (A) Upon appropriate application, the owner of a motor vehicle who was enlisted in any branch of the armed services that participated in and survived the attack on Pearl Harbor on December 7, 1941, the division shall issue a special registration plate for a vehicle titled in the name of the qualified applicant. The registration plate shall be designed by the Commissioner of Motor Vehicles.
- 10 (B) Registration plates issued pursuant to this subdivision are
 11 exempt from the payment of all registration fees otherwise required
 12 by the provisions of this chapter.
- 13 (C) A surviving spouse may continue to use his or her deceased 14 spouse's survivors of the attack on Pearl Harbor license plate 15 until the surviving spouse dies, remarries or does not renew the 16 license plate.
- 17 (D) A survivor of the attack on Pearl Harbor may obtain a 18 second survivors of the attack on Pearl Harbor license plate as 19 described in this section for use on a passenger vehicle titled in 20 the name of the qualified applicant. The division shall charge a 21 one-time fee of \$10 to be deposited into the State Road Fund, in 22 addition to all other fees required by this chapter, for the second 23 plate.
- 24 (9) The division may issue special registration plates to 25 nonprofit charitable and educational organizations authorized under 26 prior enactment of this subdivision as follows:

(A) Approved nonprofit charitable and educational organizations

- 2 previously authorized under the prior enactment of this subdivision
- 3 may accept and collect applications for special registration plates
- 4 from owners of Class A motor vehicles together with a special
- 5 annual fee of \$15, which is in addition to all other fees required
- 6 by this chapter. The applications and fees shall be submitted to
- 7 the Division of Motor Vehicles with the request that the division
- 8 issue a registration plate bearing a combination of letters or
- 9 numbers with the organizations' logo or emblem, with the maximum
- 10 number of letters or numbers to be determined by the commissioner.
- 11 (B) The commissioner shall propose rules for legislative
- 12 approval in accordance with the provisions of article three,
- 13 chapter twenty-nine-a of this code regarding the procedures for and
- 14 approval of special registration plates issued pursuant to this
- 15 subdivision.

- 16 (C) The commissioner shall set an appropriate fee to defray the
- 17 administrative costs associated with designing and manufacturing
- 18 special registration plates for a nonprofit charitable or
- 19 educational organization. The nonprofit charitable or educational
- 20 organization shall collect this fee and forward it to the division
- 21 for deposit in the State Road Fund. The nonprofit charitable or
- 22 educational organization may also collect a fee for marketing the
- 23 special registration plates.
- 24 (10) The division may issue specified emergency or volunteer
- 25 registration plates as follows:
- 26 (A) Any owner of a motor vehicle who is a resident of the State

- 1 of West Virginia and who is a certified paramedic or emergency
- 2 medical technician, a member of a paid fire department, a member of
- 3 the state Fire Commission, the state Fire Marshal, the state Fire
- 4 Marshal's assistants, the state Fire Administrator and voluntary
- 5 rescue squad members may apply for a special license plate for any
- 6 number of Class A vehicles titled in the name of the qualified
- 7 applicant which bears the insignia of the profession, group or
- 8 commission. Any insignia shall be designed by the commissioner.
- 9 License plates issued pursuant to this subdivision shall bear the
- 10 requested insignia in addition to the registration number issued to
- 11 the applicant pursuant to the provisions of this article.
- 12 (B) Each application submitted pursuant to this subdivision
- 13 shall be accompanied by an affidavit signed by the fire chief or
- 14 department head of the applicant stating that the applicant is
- 15 justified in having a registration with the requested insignia;
- 16 proof of compliance with all laws of this state regarding
- 17 registration and licensure of motor vehicles; and payment of all
- 18 required fees.
- 19 (C) Each application submitted pursuant to this subdivision
- 20 shall be accompanied by payment of a special initial application
- 21 fee of \$10, which is in addition to any other registration or
- 22 license fee required by this chapter. All special fees shall be
- 23 collected by the division and deposited into the State Road Fund.
- 24 (11) The division may issue specified certified firefighter
- 25 registration plates as follows:
- 26 (A) Any owner of a motor vehicle who is a resident of the State

- of West Virginia and who is a certified firefighter may apply for a special license plate which bears the insignia of the profession, for any number of Class A vehicles titled in the name of the qualified applicant. Any insignia shall be designed by the commissioner. License plates issued pursuant to this subdivision shall bear the requested insignia pursuant to the provisions of this article. Upon presentation of written evidence of certification as a certified firefighter, certified firefighters are eligible to purchase the special registration plate issued pursuant to this subdivision.
- (B) Each application submitted pursuant to this subdivision shall be accompanied by an affidavit stating that the applicant is justified in having a registration with the requested insignia; proof of compliance with all laws of this state regarding registration and licensure of motor vehicles; and payment of all required fees. The firefighter certification department, section or division of the West Virginia University fire service extension shall notify the commissioner in writing immediately when a firefighter loses his or her certification. If a firefighter loses his or her certification may not issue him or her a license plate under this subsection.
- (C) Each application submitted pursuant to this subdivision shall be accompanied by payment of a special initial application fee of \$10, which is in addition to any other registration or license fee required by this chapter. All special fees shall be collected by the division and deposited into the State Road Fund.

- 1 (12) The division may issue special scenic registration plates 2 as follows:
- 3 (A) Upon appropriate application, the commissioner shall issue 4 a special registration plate displaying a scenic design of West 5 Virginia which displays the words "Wild Wonderful" as a slogan.
- 6 (B) The division shall charge a special one-time initial 7 application fee of \$10 in addition to all other fees required by 8 this chapter. All initial application fees collected by the 9 division shall be deposited into the State Road Fund.
- 10 (13) The division may issue honorably discharged Marine Corps
 11 league members special registration plates as follows:
- 12 (A) Upon appropriate application, the division shall issue to
 13 any honorably discharged Marine Corps league member a special
 14 registration plate for any number of vehicles titled in the name of
 15 the qualified applicant with an insignia designed by the
 16 Commissioner of the Division of Motor Vehicles.
- (B) The division may charge a special one-time initial application fee of \$10 in addition to all other fees required by this chapter. This special fee is to compensate the Division of Motor Vehicles for additional costs and services required in the 21 issuing of the special registration and shall be collected by the division and deposited in the State Road Fund. *Provided*, That However, nothing in this section may be construed to exempt any veteran from any other provision of this chapter.
- 25 (C) A surviving spouse may continue to use his or her deceased 26 spouse's honorably discharged Marine Corps League license plate

- 1 until the surviving spouse dies, remarries or does not renew the 2 license plate.
- 3 (14) The division may issue military organization registration 4 plates as follows:
- 5 (A) The division may issue a special registration plate for the 6 members of any military organization chartered by the United States 7 Congress upon receipt of a guarantee from the organization of a 8 minimum of one hundred applicants. The insignia on the plate shall 9 be designed by the commissioner.
- 10 (B) Upon appropriate application, the division may issue
 11 members of the chartered organization in good standing, as
 12 determined by the governing body of the chartered organization, a
 13 special registration plate for any number of vehicles titled in the
 14 name of the qualified applicant.
- 15 (C) The division shall charge a special one-time initial 16 application fee of \$10 for each special license plate in addition 17 to all other fees required by this chapter. All initial 18 application fees collected by the division shall be deposited into 19 the State Road Fund. *Provided*, That However, nothing in this 20 section may be construed to exempt any veteran from any other 21 provision of this chapter.
- (D) A surviving spouse may continue to use his or her deceased spouse's military organization registration plate until the surviving spouse dies, remarries or does not renew the special military organization registration plate.
- 26 (15) The division may issue special nongame wildlife

- 1 registration plates and special wildlife registration plates as 2 follows:
- 3 (A) Upon appropriate application, the division shall issue a 4 special registration plate displaying a species of West Virginia 5 wildlife which shall display a species of wildlife native to West 6 Virginia as prescribed and designated by the commissioner and the 7 Director of the Division of Natural Resources.
- 8 (B) The division shall charge an annual fee of \$15 for each 9 special nongame wildlife registration plate and each special 10 wildlife registration plate in addition to all other fees required 11 by this chapter. All annual fees collected for nongame wildlife 12 registration plates and wildlife registration plates shall be 13 deposited in a special revenue account designated the Nongame 14 Wildlife Fund and credited to the Division of Natural Resources.
- 15 (C) The division shall charge a special one-time initial 16 application fee of \$10 in addition to all other fees required by 17 this chapter. All initial application fees collected by the 18 division shall be deposited in the State Road Fund.
- 19 (16) The division may issue members of the Silver Haired 20 Legislature special registration plates as follows:
- 21 (A) Upon appropriate application, the division shall issue to 22 any person who is a duly qualified member of the Silver Haired 23 Legislature a specialized registration plate which bears 24 recognition of the applicant as a member of the Silver Haired 25 Legislature.
- 26 (B) A qualified member of the Silver Haired Legislature may

- 1 obtain one registration plate described in this subdivision for use
- 2 on a passenger vehicle titled in the name of the qualified
- 3 applicant. The division shall charge an annual fee of \$15, in
- 4 addition to all other fees required by this chapter, for the plate.
- 5 All annual fees collected by the division shall be deposited in the
- 6 State Road Fund.
- 7 (17) Upon appropriate application, the commissioner shall issue
- 8 to a classic motor vehicle or classic motorcycle as defined in
- 9 section three-a, article ten of this chapter, a special
- 10 registration plate designed by the commissioner. An annual fee of
- 11 \$15, in addition to all other fees required by this chapter, shall
- 12 be charged for each classic registration plate.
- 13 (18) Honorably discharged veterans may be issued special
- 14 registration plates for motorcycles subject to Class G registration
- 15 as follows:
- 16 (A) Upon appropriate application, there shall be issued to any
- 17 honorably discharged veteran of any branch of the armed services of
- 18 the United States a special registration plate for any number of
- 19 motorcycles subject to Class G registration titled in the name of
- 20 the qualified applicant with an insignia designed by the
- 21 Commissioner of the Division of Motor Vehicles.
- 22 (B) A special initial application fee of \$10 shall be charged
- 23 in addition to all other fees required by law. This special fee is
- 24 to be collected by the division and deposited in the State Road
- 25 Fund. Provided, That However, nothing in this section may be
- 26 construed to exempt any veteran from any other provision of this

- 1 chapter.
- 2 (C) A surviving spouse may continue to use his or her deceased
- 3 spouse's honorably discharged veterans license plate until the
- 4 surviving spouse dies, remarries or does not renew the license
- 5 plate.
- 6 (19) Racing theme special registration plates:
- 7 (A) The division may issue a series of special registration
- 8 plates displaying National Association for Stock Car Auto Racing
- 9 themes.
- 10 (B) An annual fee of \$25 shall be charged for each special
- 11 racing theme registration plate in addition to all other fees
- 12 required by this chapter. All annual fees collected for each
- 13 special racing theme registration plate shall be deposited into the
- 14 State Road Fund.
- 15 (C) A special application fee of \$10 shall be charged at the
- 16 time of initial application as well as upon application for any
- 17 duplicate or replacement registration plate, in addition to all
- 18 other fees required by this chapter. All application fees shall be
- 19 deposited into the State Road Fund.
- 20 (20) The division may issue recipients of the Navy Cross,
- 21 Distinguished Service Cross, Distinguished Flying Cross, Air Force
- 22 Cross, Bronze Star, Silver Star or Air Medal special registration
- 23 plates as follows:
- 24 (A) Upon appropriate application, the division shall issue to
- 25 any recipient of the Navy Cross, Distinguished Service Cross,
- 26 Distinguished Flying Cross, Air Force Cross, Silver Star, Bronze

- 1 Star or Air Medal, a registration plate for any number of vehicles
- 2 titled in the name of the qualified applicant bearing letters or
- 3 numbers. A separate registration plate shall be designed by the
- 4 Commissioner of Motor Vehicles for each award that denotes that
- 5 those individuals who are granted this special registration plate
- 6 are recipients of the Navy Cross, Distinguished Service Cross,
- 7 Distinguished Flying Cross, Air Force Cross, Silver Star or Bronze
- 8 Star, or Air Medal as applicable.
- 9 (B) The division shall charge a special initial application fee
- 10 of \$10 in addition to all other fees required by law. This special
- 11 fee shall be collected by the division and deposited in the State
- 12 Road Fund. Provided, That However, nothing in this section exempts
- 13 the applicant for a special registration plate under this
- 14 subdivision from any other provision of this chapter.
- 15 (C) A surviving spouse may continue to use his or her deceased
- 16 spouse's Navy Cross, Distinguished Service Cross, Distinguished
- 17 Flying Cross, Air Force Cross, Silver Star, Bronze Star or Air
- 18 Medal special registration plate until the surviving spouse dies,
- 19 remarries or does not renew the special registration plate.
- 20 (21) The division may issue honorably discharged veterans
- 21 special registration plates as follows:
- 22 (A) Upon appropriate application, the division shall issue to
- 23 any honorably discharged veteran of any branch of the armed
- 24 services of the United States with verifiable service during World
- 25 War II, the Korean War, the Vietnam War, the Persian Gulf War or
- 26 the War Against Terrorism a special registration plate for any

- 1 number of vehicles titled in the name of the qualified applicant
- 2 with an insignia designed by the commissioner denoting service in
- 3 the applicable conflict.
- 4 (B) The division shall charge a special one-time initial
- 5 application fee of \$10 in addition to all other fees required by
- 6 law. This special fee shall be collected by the division and
- 7 deposited in the State Road Fund. Provided, That However, nothing
- 8 contained in this section may be construed to exempt any veteran
- 9 from any other provision of this chapter.
- 10 (C) A surviving spouse may continue to use his or her deceased
- 11 spouse's honorably discharged veterans registration plate until the
- 12 surviving spouse dies, remarries or does not renew the special
- 13 registration plate.
- 14 (22) The division may issue special volunteer firefighter
- 15 registration plates as follows:
- 16 (A) Any owner of a motor vehicle who is a resident of West
- 17 Virginia and who is a volunteer firefighter may apply for a special
- 18 license plate for any Class A vehicle titled in the name of the
- 19 qualified applicant which bears the insignia of the profession in
- 20 white letters on a red background. The insignia shall be designed
- 21 by the commissioner and shall contain a fireman's helmet insignia
- 22 on the left side of the license plate.
- 23 (B) Each application submitted pursuant to this subdivision
- 24 shall be accompanied by an affidavit signed by the applicant's fire
- 25 chief, stating that the applicant is a volunteer firefighter and
- 26 justified in having a registration plate with the requested

- 1 insignia. The applicant must comply with all other laws of this
- 2 state regarding registration and licensure of motor vehicles and
- 3 must pay all required fees.
- 4 (C) Each application submitted pursuant to this subdivision
- 5 shall be accompanied by payment of a special one-time initial
- 6 application fee of \$10, which is in addition to any other
- 7 registration or license fee required by this chapter. All
- 8 application fees shall be deposited into the State Road Fund.
- 9 (23) The division may issue special registration plates which
- 10 reflect patriotic themes, including the display of any United
- 11 States symbol, icon, phrase or expression which evokes patriotic
- 12 pride or recognition.
- 13 (A) Upon appropriate application, the division shall issue to
- 14 an applicant a registration plate of the applicant's choice,
- 15 displaying a patriotic theme as provided in this subdivision, for
- 16 a vehicle titled in the name of the applicant. A series of
- 17 registration plates displaying patriotic themes shall be designed
- 18 by the Commissioner of Motor Vehicles for distribution to
- 19 applicants.
- 20 (B) The division shall charge a special one-time initial
- 21 application fee of \$10 in addition to all other fees required by
- 22 law. This special fee shall be collected by the division and
- 23 deposited in the State Road Fund.
- 24 (24) Special license plates bearing the American flag and the
- 25 logo "9/11/01".
- 26 (A) Upon appropriate application, the division shall issue

- 1 special registration plates which shall display the American flag 2 and the logo "9/11/01".
- 3 (B) An annual fee of \$15 shall be charged for each plate in 4 addition to all other fees required by this chapter.

- (ii) If the organization fails to submit the required number of applications and fees within six months of the effective date of the approval of the application for the plate by the commissioner, the plate will not be produced until a new application is submitted and is approved by the commissioner. *Provided, That In addition,* an organization that is unsuccessful in obtaining the minimum number unmber of applications may not make a new application for a special plate until at least two years have passed since the approval of the previous application of the organization.

The design and 11 expiration of the plates shall be determined by the commissioner. 12 The commissioner shall, whenever possible and cost effective, 13 implement the latest technology in the design, production and 14 issuance of registration plates, indices of registration renewal 15 and vehicle ownership documents, including, but not limited to, 16 offering Internet renewal of vehicle registration and the use of 17 bar codes for instant identification of vehicles by scanning 18 equipment to promote the efficient and effective coordination and 19 communication of data for improving highway safety, aiding law 20 enforcement and enhancing revenue collection.
- (i) Any license plate issued or renewed pursuant to this 22 chapter which is paid for by a check that is returned for 23 nonsufficient funds is void without further notice to the 24 applicant. The applicant may not reinstate the registration until 25 the returned check is paid by the applicant in cash, money order or 26 certified check and all applicable fees assessed as a result

1 thereof have been paid.

NOTE: The purpose of this bill is to provide for the issuance of special license plates for the hearing impaired. The bill also exempts this plate from the minimum number of required applicants.
