10 A BILL to amend and reenact §1-2-2 of the Code of West Virginia,
11 1931, as amended, relating to the apportionment of the
12 membership of the House of Delegates; and adding a fifty-ninth
13 delegate district consisting of portions of Mason and Putnam
14 counties.

15 *Be it enacted by the Legislature of West Virginia:*

16 That §1-2-2 of the Code of West Virginia, 1931, as amended, be
17 amended and reenacted to read as follows:

18 **ARTICLE 2. APPORTIONMENT OF REPRESENTATION.**

19 **§1-2-2. Apportionment of membership of House of Delegates.**

20 (a) As used in this section:

21 (1) "County" means the territory comprising a county of this
22 state as it existed on January 1, 2000, notwithstanding any
23 boundary changes made subsequent thereto;

1 (2) "Block" and "voting district" mean those geographic areas
2 as defined by the Bureau of the Census of the United States
3 Department of Commerce for the taking of the 2000 census of
4 population and described on census maps prepared by the bureau of
5 the census. The maps are, at the time of the reenactment of this
6 section in the year 2001, maintained by the Bureau of the Census
7 and filed with the Joint Committee on Government and Finance.

8 (b) The House of Delegates is composed of one hundred members
9 elected from the delegate districts described in this subsection:
