## 1 nonrenewal.

- 2 (a) The division upon registering a vehicle shall issue to the 3 owner one registration plate for a motorcycle, trailer, semitrailer 4 or other motor vehicle.
- 5 (b) Registration plates issued by the division shall meet the 6 following requirements:
- 7 (1) Every registration plate shall be of reflectorized 8 material and have displayed upon it the registration number 9 assigned to the vehicle; for which it is issued the name of this 10 state, which may be abbreviated; and the year number for which it 11 is issued or the date of expiration of the plate.
- 12 (2) Every registration plate and the required letters and 13 numerals on the plate shall be of sufficient size to be plainly 14 readable from a distance of one hundred feet during daylight: 15 *Provided*, That the requirements of this subdivision shall not apply 16 to the year number for which the plate is issued or the date of 17 expiration.
- 18 (3) Registration numbering for registration plates shall begin 19 with number two.
- 20 (c) The division may not issue, permit to be issued or 21 distribute any special registration plates except as follows:
- 22 (1) The Governor shall be issued two registration plates, on 23 one of which shall be imprinted the numeral one and on the other 24 the word one.

- 1 (2) State officials and judges may be issued special 2 registration plates as follows:
- 3 (A) Upon appropriate application, the division shall issue to 4 the Secretary of State, State Superintendent of Schools, Auditor, 5 Treasurer, Commissioner of Agriculture and the Attorney General, 6 the members of both houses of the Legislature, including the 7 elected officials of both houses of the Legislature, the justices Appeals of West Virginia, the Supreme Court of 9 representatives and senators of the state in the Congress of the 10 United States, the judges of the West Virginia circuit courts, 11 active and retired on senior status, the judges of the United 12 States district courts for the State of West Virginia and the 13 judges of the United States Court of Appeals for the fourth 14 circuit, if any of the judges are residents of West Virginia, a 15 special registration plate for a Class A motor vehicle and a 16 special registration plate for a Class G motorcycle owned by the 17 official or his or her spouse. *Provided*, That In addition, the 18 division may issue a Class A special registration plate for each 19 vehicle titled to the official and a Class G special registration 20 plate for each motorcycle titled to the official.
- (B) Each plate issued pursuant to this subdivision shall bear 22 any combination of letters and numbers not to exceed an amount 23 determined by the commissioner and a designation of the office.

  24 Each plate shall supersede the regular numbered plate assigned to

- 1 the official or his or her spouse during the official's term of 2 office and while the motor vehicle is owned by the official or his 3 or her spouse.
- 4 (C) The division shall charge an annual fee of \$15 for every 5 registration plate issued pursuant to this subdivision, which is in 6 addition to all other fees required by this chapter.

Upon presentation of written evidence of retirement status, retired members of this state's Army or Air National Guard, or retired members of any reserve unit of the United States Armed Forces, are eligible to purchase the special registration plate issued pursuant to this subdivision.
- 23 (B) The division shall charge an initial application fee of 24 \$10 for each special registration plate issued pursuant to this

- 1 subdivision, which is in addition to all other fees required by
- 2 this chapter. Except as otherwise provided herein, effective July
- 3 1, 2007, all fees currently held in the special revolving fund used

The registration plate shall be designed by the Commissioner of Motor Vehicles and shall denote that those individuals who are granted this special registration plate are

The application shall include sufficient information, as determined by the commissioner, to determine whether the special registration plate requested and the organization making the application meet all of the requirements set forth in this subdivision (60). The application shall also include a proposed design, including lettering, logo, image or message to be placed on the registration plate. The commissioner shall notify the organization of the commissioner's approval or disapproval of the application.
- (C) (i) The commissioner may not begin the design or production of any license plates authorized and approved pursuant to this subdivision (60), subsection (c) of this section until the organization which applied for the special registration plate has collected and submitted collectively to the division applications completed by at least two hundred fifty persons and collectively deposited with the division all fees necessary to cover the first

- (2) The commissioner may not begin the design or production of 21 any license plates authorized by this section for which membership 22 or affiliation with a particular organization is not required until 23 at least two hundred fifty registrants complete an application and 24 deposit a fee with the division to cover the first year's basic

1 registration fee, one-time design and manufacturing fee and 2 additional annual fee if applicable. If the commissioner fails to 3 receive the required number of applications within six months of 4 the effective date of the original authorizing legislation, the 5 plate will not be produced and will require legislative 6 reauthorization. \*Provided\*, That \*In addition\*, if the minimum number 7 of applications is not satisfied within the six months of the 8 effective date of the original authorizing legislation, a person 9 may not request reconsideration of a special plate until at least 10 two years have passed since the effective date of the original 11 authorization.

- (e) (1) Nothing in this section requires a charge for a free prisoner of war license plate or a free recipient of the Congressional Medal of Honor license plate for a vehicle titled in the name of the qualified applicant as authorized by other provisions of this code.
- 17 (2) A surviving spouse may continue to use his or her deceased 18 spouse's prisoner of war license plate or Congressional Medal of 19 Honor license plate until the surviving spouse dies, remarries or 20 does not renew the license plate.

- (2) An initial nonrefundable fee shall be charged for each special registration plate issued pursuant to this subsection, which is the total amount of fees required by section fifteen, article ten of this chapter, section three, article three of this chapter or section three-a, article ten of this chapter for the period requested.
- 23 (g) The provisions of This section may not be construed to 24 exempt any registrant from maintaining motor vehicle liability

- 1 insurance as required by section three, article two-a, chapter
- 2 seventeen-d of this code or from paying personal property taxes on
- 3 any motor vehicle as required by section three-a of this article.
- 4 (h) The commissioner may, in his or her discretion, issue a
- 5 registration plate of reflectorized material suitable for permanent
- 6 use on motor vehicles, trailers and semitrailers, together with
- 7 appropriate devices to be attached to the registration to indicate
- 8 the year for which the vehicles have been properly registered or
- 9 the date of expiration of the registration. The design and

- 11 The commissioner shall, whenever possible and cost effective,
- 12 implement the latest technology in the design, production and

- 15 offering Internet renewal of vehicle registration and the use of
- 16 bar codes for instant identification of vehicles by scanning
- 17 equipment to promote the efficient and effective coordination and

- 20 (i) Any license plate issued or renewed pursuant to this
- 21 chapter which is paid for by a check that is returned for
- 22 nonsufficient funds is void without further notice to the
- 23 applicant. The applicant may not reinstate the registration until
- 24 the returned check is paid by the applicant in cash, money order or

- 1 certified check and all applicable fees assessed as a result
- 2 thereof have been paid.

NOTE: The purpose of this bill is to provide for the issuance of a special license plate for residents of the fifty-five counties. The bill also assesses a special initial application fee and a special annual fee.
