11	1931, as amended, relating to motor vehicle administration;
12	registration plates generally; and exempting certain
13	recipients of military medals of valor from special
14	registration fees.
15	Be it enacted by the Legislature of West Virginia:
16	That §17A-3-14 of the Code of West Virginia, 1931, as amended,
17	be amended and reenacted to read as follows:
18	ARTICLE 3. ORIGINAL AND RENEWAL OF REGISTRATION; ISSUANCE OF
19	CERTIFICATES OF TITLE.
20	§17A-3-14. Registration plates generally; description of plates;
21	issuance of special numbers and plates; registration
22	<pre>fees; special application fees; exemptions;</pre>
23	commissioner to promulgate forms; suspension and
24	nonrenewal.
25	(a) The division upon registering a vehicle shall issue to the

- 1 owner one registration plate for a motorcycle, trailer, semitrailer
- 2 or other motor vehicle.
- 3 (b) Registration plates issued by the division shall meet the
- 4 following requirements:
- 5 (1) Every registration plate shall be of reflectorized
- 6 material and have displayed upon it the registration number
- 7 assigned to the vehicle for which it is issued; the name of this
- 8 state, which may be abbreviated; and the year number for which it
- 9 is issued or the date of expiration of the plate.
- 10 (2) Every registration plate and the required letters and
- 11 numerals on the plate shall be of sufficient size to be plainly
- 12 readable from a distance of one hundred feet during daylight:
- 13 Provided, That the requirements of this subdivision shall not apply
- 14 to the year number for which the plate is issued or the date of
- 15 expiration.
- 16 (3) Registration numbering for registration plates shall begin
- 17 with number two.
- 18 (c) The division may not issue, permit to be issued or
- 19 distribute any special registration plates except as follows:
- 20 (1) The Governor shall be issued two registration plates, on
- 21 one of which shall be imprinted the numeral one and on the other
- 22 the word one.
- 23 (2) State officials and judges may be issued special
- 24 registration plates as follows:

- (A) Upon appropriate application, the division shall issue to 1 2 the Secretary of State, State Superintendent of Schools, Auditor, 3 Treasurer, Commissioner of Agriculture and the Attorney General, 4 the members of both houses of the Legislature, including the 5 elected officials of both houses of the Legislature, the justices Supreme Court of Appeals of West Virginia, the the 7 representatives and senators of the state in the Congress of the 8 United States, the judges of the West Virginia circuit courts, 9 active and retired on senior status, the judges of the United 10 States district courts for the State of West Virginia and the 11 judges of the United States Court of Appeals for the fourth 12 circuit, if any of the judges are residents of West Virginia, a 13 special registration plate for a Class A motor vehicle and a 14 special registration plate for a Class G motorcycle owned by the 15 official or his or her spouse: Provided, That the division may 16 issue a Class A special registration plate for each vehicle titled 17 to the official and a Class G special registration plate for each 18 motorcycle titled to the official.
- 19 (B) Each plate issued pursuant to this subdivision shall bear 20 any combination of letters and numbers not to exceed an amount 21 determined by the commissioner and a designation of the office. 22 Each plate shall supersede the regular numbered plate assigned to 23 the official or his or her spouse during the official's term of 24 office and while the motor vehicle is owned by the official or his

1 or her spouse.

- 2 (C) The division shall charge an annual fee of \$15 for every 3 registration plate issued pursuant to this subdivision, which is in 4 addition to all other fees required by this chapter.
- 5 (3) The division may issue members of the National Guard 6 forces special registration plates as follows:
- (A) Upon receipt of an application on a form prescribed by the division and receipt of written evidence from the chief executive officer of the Army National Guard or Air National Guard, as appropriate, or the commanding officer of any United States Armed Forces reserve unit that the applicant is a member thereof, the division shall issue to any member of the National Guard of this state or a member of any reserve unit of the United States Armed Forces a special registration plate designed by the commissioner for any number of Class A motor vehicles owned by the member. Upon presentation of written evidence of retirement status, retired members of this state's Army or Air National Guard, or retired members of any reserve unit of the United States Armed Forces, are eligible to purchase the special registration plate issued pursuant to this subdivision.
- 21 (B) The division shall charge an initial application fee of 22 \$10 for each special registration plate issued pursuant to this 23 subdivision, which is in addition to all other fees required by 24 this chapter. Except as otherwise provided herein, effective July

- 1 1, 2007, all fees currently held in the special revolving fund used
- 2 in the administration of this section and all fees collected by the
- 3 division shall be deposited in the State Road Fund.
- 4 (C) A surviving spouse may continue to use his or her deceased
- 5 spouse's National Guard forces license plate until the surviving
- 6 spouse dies, remarries or does not renew the license plate.
- 7 (4) Specially arranged registration plates may be issued as 8 follows:
- 9 (A) Upon appropriate application, any owner of a motor vehicle
- 10 subject to Class A registration, or a motorcycle subject to Class
- 11 G registration, as defined by this article, may request that the
- 12 division issue a registration plate bearing specially arranged
- 13 letters or numbers with the maximum number of letters or numbers to
- 14 be determined by the commissioner. The division shall attempt to
- 15 comply with the request wherever possible.
- 16 (B) The commissioner shall propose rules for legislative
- 17 approval in accordance with the provisions of chapter twenty-nine-a
- 18 of this code regarding the orderly distribution of the plates:
- 19 Provided, That for purposes of this subdivision, the registration
- 20 plates requested and issued shall include all plates bearing the
- 21 numbers two through two thousand.
- 22 (C) An annual fee of \$15 shall be charged for each special
- 23 registration plate issued pursuant to this subdivision, which is in
- 24 addition to all other fees required by this chapter.

- 1 (5) The division may issue honorably discharged veterans 2 special registration plates as follows:
- 3 (A) Upon appropriate application, the division shall issue to 4 any honorably discharged veteran of any branch of the armed 5 services of the United States a special registration plate for any 6 number of vehicles titled in the name of the qualified applicant 7 with an insignia designed by the Commissioner of the Division of 8 Motor Vehicles.
- 9 (B) The division shall charge a special initial application 10 fee of \$10 in addition to all other fees required by law. This 11 special fee is to compensate the Division of Motor Vehicles for 12 additional costs and services required in the issuing of the 13 special registration. All fees collected by the division shall be 14 deposited in the State Road Fund: *Provided*, That nothing in this 15 section may be construed to exempt any veteran from any other 16 provision of this chapter.
- 17 (C) A surviving spouse may continue to use his or her deceased 18 spouse's honorably discharged veterans license plate until the 19 surviving spouse dies, remarries or does not renew the license 20 plate.
- 21 (6) The division may issue disabled veterans special 22 registration plates as follows:
- 23 (A) Upon appropriate application, the division shall issue to 24 any disabled veteran who is exempt from the payment of registration

- 1 fees under the provisions of this chapter a registration plate for
- 2 a vehicle titled in the name of the qualified applicant which bears
- 3 the letters "DV" in red and also the regular identification
- 4 numerals in red.
- 5 (B) A surviving spouse may continue to use his or her deceased
- 6 spouse's disabled veterans license plate until the surviving spouse
- 7 dies, remarries or does not renew the license plate.
- 8 (C) A qualified disabled veteran may obtain a second disabled
- 9 veterans license plate as described in this section for use on a
- 10 passenger vehicle titled in the name of the qualified applicant.
- 11 The division shall charge a one-time fee of \$10 to be deposited
- 12 into the State Road Fund, in addition to all other fees required by
- 13 this chapter, for the second plate.
- 14 (7) The division may issue recipients of the distinguished
- 15 Purple Heart medal special registration plates as follows:
- 16 (A) Upon appropriate application, there shall be issued to any
- 17 armed service person holding the distinguished Purple Heart medal
- 18 for persons wounded in combat a registration plate for a vehicle
- 19 titled in the name of the qualified applicant bearing letters or
- 20 numbers. The registration plate shall be designed by the
- 21 Commissioner of Motor Vehicles and shall denote that those
- 22 individuals who are granted this special registration plate are
- 23 recipients of the Purple Heart. All letterings shall be in purple
- 24 where practical.

- 1 (B) Registration plates issued pursuant to this subdivision 2 are exempt from all registration fees otherwise required by the 3 provisions of this chapter.
- 4 (C) A surviving spouse may continue to use his or her deceased 5 spouse's Purple Heart medal license plate until the surviving 6 spouse dies, remarries or does not renew the license plate.
- 7 (D) A recipient of the Purple Heart medal may obtain a second 8 Purple Heart medal license plate as described in this section for 9 use on a passenger vehicle titled in the name of the qualified 10 applicant. The division shall charge a one-time fee of \$10 to be 11 deposited into the State Road Fund, in addition to all other fees 12 required by this chapter, for the second plate.
- 13 (8) The division may issue survivors of the attack on Pearl 14 Harbor special registration plates as follows:
- (A) Upon appropriate application, the owner of a motor vehicle who was enlisted in any branch of the armed services that 17 participated in and survived the attack on Pearl Harbor on December 18 7, 1941, the division shall issue a special registration plate for 19 a vehicle titled in the name of the qualified applicant. The 20 registration plate shall be designed by the Commissioner of Motor 21 Vehicles.
- (B) Registration plates issued pursuant to this subdivision
  are exempt from the payment of all registration fees otherwise
  required by the provisions of this chapter.

- 1 (C) A surviving spouse may continue to use his or her deceased 2 spouse's survivors of the attack on Pearl Harbor license plate 3 until the surviving spouse dies, remarries or does not renew the 4 license plate.
- 5 (D) A survivor of the attack on Pearl Harbor may obtain a 6 second survivors of the attack on Pearl Harbor license plate as 7 described in this section for use on a passenger vehicle titled in 8 the name of the qualified applicant. The division shall charge a 9 one-time fee of \$10 to be deposited into the State Road Fund, in 10 addition to all other fees required by this chapter, for the second 11 plate.
- 12 (9) The division may issue special registration plates to 13 nonprofit charitable and educational organizations authorized under 14 prior enactment of this subdivision as follows:
- 15 (A) Approved nonprofit charitable and educational 16 organizations previously authorized under the prior enactment of 17 this subdivision may accept and collect applications for special 18 registration plates from owners of Class A motor vehicles together 19 with a special annual fee of \$15, which is in addition to all other 20 fees required by this chapter. The applications and fees shall be 21 submitted to the Division of Motor Vehicles with the request that 22 the division issue a registration plate bearing a combination of 23 letters or numbers with the organizations' logo or emblem, with the 24 maximum number of letters or numbers to be determined by the

1 commissioner.

- 2 (B) The commissioner shall propose rules for legislative 3 approval in accordance with the provisions of article three, 4 chapter twenty-nine-a of this code regarding the procedures for and 5 approval of special registration plates issued pursuant to this 6 subdivision.
- 7 (C) The commissioner shall set an appropriate fee to defray 8 the administrative costs associated with designing and 9 manufacturing special registration plates for a nonprofit 10 charitable or educational organization. The nonprofit charitable 11 or educational organization shall collect this fee and forward it 12 to the division for deposit in the State Road Fund. The nonprofit 13 charitable or educational organization may also collect a fee for 14 marketing the special registration plates.
- 15 (10) The division may issue specified emergency or volunteer 16 registration plates as follows:
- (A) Any owner of a motor vehicle who is a resident of the State of West Virginia and who is a certified paramedic or 19 emergency medical technician, a member of a paid fire department, 20 a member of the state Fire Commission, the state Fire Marshal, the 21 state Fire Marshal's assistants, the state Fire Administrator and 22 voluntary rescue squad members may apply for a special license 23 plate for any number of Class A vehicles titled in the name of the 24 qualified applicant which bears the insignia of the profession,

- 1 group or commission. Any insignia shall be designed by the 2 commissioner. License plates issued pursuant to this subdivision 3 shall bear the requested insignia in addition to the registration
- 4 number issued to the applicant pursuant to the provisions of this 5 article.
- 6 (B) Each application submitted pursuant to this subdivision
  7 shall be accompanied by an affidavit signed by the fire chief or
  8 department head of the applicant stating that the applicant is
  9 justified in having a registration with the requested insignia;
  10 proof of compliance with all laws of this state regarding
  11 registration and licensure of motor vehicles; and payment of all
  12 required fees.
- (C) Each application submitted pursuant to this subdivision shall be accompanied by payment of a special initial application fee of \$10, which is in addition to any other registration or license fee required by this chapter. All special fees shall be collected by the division and deposited into the State Road Fund.
- 18 (11) The division may issue specified certified firefighter 19 registration plates as follows:
- 20 (A) Any owner of a motor vehicle who is a resident of the 21 State of West Virginia and who is a certified firefighter may apply 22 for a special license plate which bears the insignia of the 23 profession, for any number of Class A vehicles titled in the name 24 of the qualified applicant. Any insignia shall be designed by the

- 1 commissioner. License plates issued pursuant to this subdivision 2 shall bear the requested insignia pursuant to the provisions of
- 3 this article. Upon presentation of written evidence of
- 4 certification as a certified firefighter, certified firefighters
- 5 are eligible to purchase the special registration plate issued
- 6 pursuant to this subdivision.
- 7 (B) Each application submitted pursuant to this subdivision
- 8 shall be accompanied by an affidavit stating that the applicant is
- 9 justified in having a registration with the requested insignia;
- 10 proof of compliance with all laws of this state regarding
- 11 registration and licensure of motor vehicles; and payment of all
- 12 required fees. The firefighter certification department, section
- 13 or division of the West Virginia University fire service extension
- 14 shall notify the commissioner in writing immediately when a
- 15 firefighter loses his or her certification. If a firefighter loses
- 16 his or her certification, the commissioner may not issue him or her
- 17 a license plate under this subsection.
- 18 (C) Each application submitted pursuant to this subdivision
- 19 shall be accompanied by payment of a special initial application
- 20 fee of \$10, which is in addition to any other registration or
- 21 license fee required by this chapter. All special fees shall be
- 22 collected by the division and deposited into the State Road Fund.
- 23 (12) The division may issue special scenic registration plates
- 24 as follows:

- 1 (A) Upon appropriate application, the commissioner shall issue 2 a special registration plate displaying a scenic design of West
- 3 Virginia which displays the words "Wild Wonderful" as a slogan.
- 4 (B) The division shall charge a special one-time initial
- 5 application fee of \$10 in addition to all other fees required by
- 6 this chapter. All initial application fees collected by the
- 7 division shall be deposited into the State Road Fund.
- 8 (13) The division may issue honorably discharged Marine Corps
- 9 league members special registration plates as follows:
- 10 (A) Upon appropriate application, the division shall issue to
- 11 any honorably discharged Marine Corps league member a special
- 12 registration plate for any number of vehicles titled in the name of
- 13 the qualified applicant with an insignia designed by the
- 14 Commissioner of the Division of Motor Vehicles.
- 15 (B) The division may charge a special one-time initial
- 16 application fee of \$10 in addition to all other fees required by
- 17 this chapter. This special fee is to compensate the Division of
- 18 Motor Vehicles for additional costs and services required in the
- 19 issuing of the special registration and shall be collected by the
- 20 division and deposited in the State Road Fund: Provided, That
- 21 nothing in this section may be construed to exempt any veteran from
- 22 any other provision of this chapter.
- 23 (C) A surviving spouse may continue to use his or her deceased
- 24 spouse's honorably discharged Marine Corps League license plate

- 1 until the surviving spouse dies, remarries or does not renew the 2 license plate.
- 3 (14) The division may issue military organization registration 4 plates as follows:
- (A) The division may issue a special registration plate for the members of any military organization chartered by the United States Congress upon receipt of a guarantee from the organization of a minimum of one hundred applicants. The insignia on the plate shall be designed by the commissioner.
- 10 (B) Upon appropriate application, the division may issue 11 members of the chartered organization in good standing, as 12 determined by the governing body of the chartered organization, a 13 special registration plate for any number of vehicles titled in the 14 name of the qualified applicant.
- 15 (C) The division shall charge a special one-time initial 16 application fee of \$10 for each special license plate in addition 17 to all other fees required by this chapter. All initial 18 application fees collected by the division shall be deposited into 19 the State Road Fund: *Provided*, That nothing in this section may be 20 construed to exempt any veteran from any other provision of this 21 chapter.
- (D) A surviving spouse may continue to use his or her deceased spouse's military organization registration plate until the surviving spouse dies, remarries or does not renew the special

- 1 military organization registration plate.
- 2 (15) The division may issue special nongame wildlife
- 3 registration plates and special wildlife registration plates as
- 4 follows:
- 5 (A) Upon appropriate application, the division shall issue a
- 6 special registration plate displaying a species of West Virginia
- 7 wildlife which shall display a species of wildlife native to West
- 8 Virginia as prescribed and designated by the commissioner and the
- 9 Director of the Division of Natural Resources.
- 10 (B) The division shall charge an annual fee of \$15 for each
- 11 special nongame wildlife registration plate and each special
- 12 wildlife registration plate in addition to all other fees required
- 13 by this chapter. All annual fees collected for nongame wildlife
- 14 registration plates and wildlife registration plates shall be
- 15 deposited in a special revenue account designated the Nongame
- 16 Wildlife Fund and credited to the Division of Natural Resources.
- 17 (C) The division shall charge a special one-time initial
- 18 application fee of \$10 in addition to all other fees required by
- 19 this chapter. All initial application fees collected by the
- 20 division shall be deposited in the State Road Fund.
- 21 (16) The division may issue members of the Silver Haired
- 22 Legislature special registration plates as follows:
- 23 (A) Upon appropriate application, the division shall issue to
- 24 any person who is a duly qualified member of the Silver Haired

- 1 Legislature a specialized registration plate which bears
- 2 recognition of the applicant as a member of the Silver Haired
- 3 Legislature.
- 4 (B) A qualified member of the Silver Haired Legislature may
- 5 obtain one registration plate described in this subdivision for use
- 6 on a passenger vehicle titled in the name of the qualified
- 7 applicant. The division shall charge an annual fee of \$15, in
- 8 addition to all other fees required by this chapter, for the plate.
- 9 All annual fees collected by the division shall be deposited in the
- 10 State Road Fund.
- 11 (17) Upon appropriate application, the commissioner shall
- 12 issue to a classic motor vehicle or classic motorcycle as defined
- 13 in section three-a, article ten of this chapter, a special
- 14 registration plate designed by the commissioner. An annual fee of
- 15 \$15, in addition to all other fees required by this chapter, shall
- 16 be charged for each classic registration plate.
- 17 (18) Honorably discharged veterans may be issued special
- 18 registration plates for motorcycles subject to Class G registration
- 19 as follows:
- 20 (A) Upon appropriate application, there shall be issued to any
- 21 honorably discharged veteran of any branch of the armed services of
- 22 the United States a special registration plate for any number of
- 23 motorcycles subject to Class G registration titled in the name of
- 24 the qualified applicant with an insignia designed by the

- 1 Commissioner of the Division of Motor Vehicles.
- 2 (B) A special initial application fee of \$10 shall be charged
- 3 in addition to all other fees required by law. This special fee is
- 4 to be collected by the division and deposited in the State Road
- 5 Fund: Provided, That nothing in this section may be construed to
- 6 exempt any veteran from any other provision of this chapter.
- 7 (C) A surviving spouse may continue to use his or her deceased
- 8 spouse's honorably discharged veterans license plate until the
- 9 surviving spouse dies, remarries or does not renew the license
- 10 plate.
- 11 (19) Racing theme special registration plates:
- 12 (A) The division may issue a series of special registration
- 13 plates displaying National Association for Stock Car Auto Racing
- 14 themes.
- 15 (B) An annual fee of \$25 shall be charged for each special
- 16 racing theme registration plate in addition to all other fees
- 17 required by this chapter. All annual fees collected for each
- 18 special racing theme registration plate shall be deposited into the
- 19 State Road Fund.
- 20 (C) A special application fee of \$10 shall be charged at the
- 21 time of initial application as well as upon application for any
- 22 duplicate or replacement registration plate, in addition to all
- 23 other fees required by this chapter. All application fees shall be
- 24 deposited into the State Road Fund.

- 1 (20) The division may issue recipients of the Navy Cross,
- 2 Distinguished Service Cross, Distinguished Flying Cross, Air Force
- 3 Cross, Bronze Star, Silver Star or Air Medal special registration
- 4 plates as follows:
- 5 (A) Upon appropriate application, the division shall issue to
- 6 any recipient of the Navy Cross, Distinguished Service Cross,
- 7 Distinguished Flying Cross, Air Force Cross, Silver Star, Bronze
- 8 Star or Air Medal, a registration plate for any number of vehicles
- 9 titled in the name of the qualified applicant bearing letters or
- 10 numbers. A separate registration plate shall be designed by the
- 11 Commissioner of Motor Vehicles for each award that denotes that
- 12 those individuals who are granted this special registration plate
- 13 are recipients of the Navy Cross, Distinguished Service Cross,
- 14 Distinguished Flying Cross, Air Force Cross, Silver Star or Bronze
- 15 Star, or Air Medal as applicable.
- 16 (B) The division shall charge a special initial application
- 17 fee of \$10 in addition to all other fees required by law. This
- 18 special fee shall be collected by the division and deposited in the
- 19 State Road Fund: Provided, That nothing in this section exempts
- 20 the applicant for a special registration plate under this
- 21 subdivision from any other provision of this chapter.
- 22 (C) A surviving spouse may continue to use his or her deceased
- 23 spouse's Navy Cross, Distinguished Service Cross, Distinguished
- 24 Flying Cross, Air Force Cross, Silver Star, Bronze Star or Air

- 1 Medal special registration plate until the surviving spouse dies,
- 2 remarries or does not renew the special registration plate.
- 3 (D) Registration plates issued pursuant to this subdivision
- 4 are exempt from all registration fees otherwise required by this
- 5 chapter.
- 6 (E) A recipient of the Navy Cross, Distinguished Service
- 7 Cross, Distinguished Flying Cross, Air Force Cross, Bronze Star or
- 8 Silver Star may obtain a second license plate with that designation
- 9 for use on a passenger vehicle titled in the name of the qualified
- 10 applicant as provided in this section. The division shall charge
- 11 a one-time fee of \$10 to be deposited into a special revolving fund
- 12 to be used in the administration of this section, in addition to
- 13 all other fees required by this chapter, for the second plate.
- 14 (21) The division may issue honorably discharged veterans
- 15 special registration plates as follows:
- 16 (A) Upon appropriate application, the division shall issue to
- 17 any honorably discharged veteran of any branch of the armed
- 18 services of the United States with verifiable service during World
- 19 War II, the Korean War, the Vietnam War, the Persian Gulf War or
- 20 the War Against Terrorism a special registration plate for any
- 21 number of vehicles titled in the name of the qualified applicant
- 22 with an insignia designed by the commissioner denoting service in
- 23 the applicable conflict.
- 24 (B) The division shall charge a special one-time initial

- 1 application fee of \$10 in addition to all other fees required by
- 2 law. This special fee shall be collected by the division and
- 3 deposited in the State Road Fund: Provided, That nothing contained
- 4 in this section may be construed to exempt any veteran from any
- 5 other provision of this chapter.
- 6 (C) A surviving spouse may continue to use his or her deceased
- 7 spouse's honorably discharged veterans registration plate until the
- 8 surviving spouse dies, remarries or does not renew the special
- 9 registration plate.
- 10 (22) The division may issue special volunteer firefighter
- 11 registration plates as follows:
- 12 (A) Any owner of a motor vehicle who is a resident of West
- 13 Virginia and who is a volunteer firefighter may apply for a special
- 14 license plate for any Class A vehicle titled in the name of the
- 15 qualified applicant which bears the insignia of the profession in
- 16 white letters on a red background. The insignia shall be designed
- 17 by the commissioner and shall contain a fireman's helmet insignia
- 18 on the left side of the license plate.
- 19 (B) Each application submitted pursuant to this subdivision
- 20 shall be accompanied by an affidavit signed by the applicant's fire
- 21 chief, stating that the applicant is a volunteer firefighter and
- 22 justified in having a registration plate with the requested
- 23 insignia. The applicant must comply with all other laws of this
- 24 state regarding registration and licensure of motor vehicles and

- 1 must pay all required fees.
- 2 (C) Each application submitted pursuant to this subdivision
- 3 shall be accompanied by payment of a special one-time initial
- 4 application fee of \$10, which is in addition to any other
- 5 registration or license fee required by this chapter. All
- 6 application fees shall be deposited into the State Road Fund.
- 7 (23) The division may issue special registration plates which
- 8 reflect patriotic themes, including the display of any United
- 9 States symbol, icon, phrase or expression which evokes patriotic

- 6 (A) Upon appropriate application, the division may issue a 7 special registration plate designed by the commissioner for any 8 number of vehicles titled in the name of the qualified applicant.
- 9 (B) The division shall charge a special initial application 10 fee of \$10 in addition to all other fees required by law. This 11 special fee shall be collected by the division and deposited in the 12 State Road Fund.
- (C) The division shall charge an annual fee of \$15 for each special registration plate in addition to all other fees required to by this chapter.
- 16 (58) The commissioner may issue special registration plates to 17 the next of kin of a member of any branch of the armed services of 18 the United States killed in combat as follows:
- 19 (A) Upon appropriate application, the division shall issue a 20 special registration plate for any number of vehicles titled in the 21 name of a qualified applicant depicting the Gold Star awarded by 22 the United States Department of Defense as prescribed and 23 designated by the commissioner.
- 24 (B) The next of kin shall provide sufficient proof of

- 1 receiving a Gold Star lapel button from the United States
- 2 Department of Defense in accordance with Public Law 534, 89th
- 3 Congress, and criteria established by the United States Department
- 4 of Defense, including criteria to determine next of kin.
- 5 (C) The division shall charge a special initial application
- 6 fee of \$10 in addition to all other fees required by law. This
- 7 special fee shall be collected by the division and deposited in the
- 8 State Road Fund.
- 9 (D) The provisions of subsection (d) of this section are not
- 10 applicable for the issuance of the special license plates
- 11 designated by this subdivision.
- 12 (59) The commissioner may issue special registration plates
- 13 for retired or former Justices of the Supreme Court of Appeals of
- 14 West Virginia as follows:
- 15 (A) Upon appropriate application, the division may issue a
- 16 special registration plate designed by the commissioner for any
- 17 number of vehicles titled in the name of the qualified applicant.
- 18 (B) The division shall charge a special initial application
- 19 fee of \$10 in addition to all other fees required by law. This
- 20 special fee shall be collected by the division and deposited in the
- 21 State Road Fund.
- 22 (C) The division shall charge an annual fee of \$15 for each
- 23 special registration plate in addition to all other fees required
- 24 by this chapter.

- 1 (D) The provisions of subsection (d) of this section are not
- 2 applicable for the issuance of the special license plates
- 3 designated by this subdivision.
- 4 (60) Upon approval by the commissioner of an appropriate
- 5 application, and upon all requirements of this subdivision being
- 6 satisfied, the division may issue special registration plates for
- 7 class A and class G motor vehicles to members of an organization
- 8 for which a special registration plate has not been issued pursuant
- 9 to any other subdivision in this subsection prior to January 1,
- 10 2010, in accordance with the provisions of this subdivision.
- 11 (A) An organization desiring to create a special registration
- 12 plate must comply with the following requirements to be eligible
- 13 to apply for the creation and issuance of a special registration
- 14 plate:
- 15 (I) The organization must be a nonprofit organization
- 16 organized and existing under Section 501(c)(3) of Title 26 of the
- 17 Internal Revenue Code and based, headquartered or have a chapter in
- 18 West Virginia;
- 19 (ii) The organization may be organized for, but may not be
- 20 restricted to, social, civic, higher education or entertainment
- 21 purposes;
- 22 (iii) The organization may not be a political party and may
- 23 not have been created or exist primarily to promote a specific
- 24 political or social belief, as determined by the commissioner in

- 1 his or her sole discretion;
- 2 (iv) The organization may not have as its primary purpose the
- 3 promotion of any specific faith, religion, religious belief or
- 4 antireligion;
- 5 (v) The name of the organization may not be the name of a
- 6 special product or brand name, and may not be construed, as
- 7 determined by the commissioner, as promoting a product or brand
- 8 name; and
- 9 (vi) The organization's lettering, logo, image or message to
- 10 be placed on the registration plate, if created, may not be
- 11 obscene, offensive or objectionable as determined by the
- 12 commissioner in his or her sole discretion.
- 13 (B) Beginning July 1, 2010, an organization requesting the
- 14 creation and issuance of a special registration plate may make
- 15 application with the division. The application shall include
- 16 sufficient information, as determined by the commissioner, to
- 17 determine whether the special registration plate requested and the
- 18 organization making the application meet all of the requirements
- 19 set forth in this subdivision (60). The application shall also
- 20 include a proposed design, including lettering, logo, image or
- 21 message to be placed on the registration plate. The commissioner
- 22 shall notify the organization of the commissioner's approval or
- 23 disapproval of the application.
- (C) (I) The commissioner may not begin the design or production

- of any license plates authorized and approved pursuant to this subdivision (60), subsection (c) of this section until the organization which applied for the special registration plate has collected and submitted collectively to the division applications completed by at least two hundred fifty persons and collectively deposited with the division all fees necessary to cover the first year's basic registration, one-time design and manufacturing costs and to cover the first year additional annual fee for all of the applications submitted.
- (ii) If the organization fails to submit the required number of applications and fees within six months of the effective date of the approval of the application for the plate by the commissioner, the plate will not be produced until a new application is submitted and is approved by the commissioner: Provided, That an organization that is unsuccessful in obtaining the minimum number of applications may not make a new application for a special plate until at least two years have passed since the approval of the previous application of the organization.
- 19 (D) The division shall charge a special initial application 20 fee of \$25 for each special license plate in addition to all other 21 fees required by law. This special fee shall be collected by the 22 division and deposited in the State Road Fund.
- 23 (E) The division shall charge an annual fee of \$15 for each 24 special registration plate in addition to all other fees required

- 1 by this chapter.
- 2 (F) Upon appropriate application, the division may issue a
- 3 special registration plate designed by the commissioner in
- 4 consultation with the organization for any number of vehicles
- 5 titled in the name of a qualified registration plate applicant.
- 6 Persons desiring the special registration plate shall offer
- 7 sufficient proof of membership in the organization.
- 8 (G) The commissioner shall discontinue the issuance or renewal
- 9 of the registration of any special plate issued pursuant to this
- 10 subdivision (60) if:
- 11 (I) The number of valid registrations for the specialty plate
- 12 falls below two hundred fifty plates for at least twelve
- 13 consecutive months; or
- 14 (ii) The organization no longer exists or no longer meets the
- 15 requirements of this subdivision.
- 16 (d) The minimum number of applications required prior to
- 17 design and production of a special license plate shall be as
- 18 follows:
- 19 (1) The commissioner may not begin the design or production of
- 20 any license plates for which eligibility is based on membership or
- 21 affiliation with a particular private organization until at least
- 22 one hundred persons complete an application and deposit with the
- 23 organization a check to cover the first year's basic registration,
- 24 one-time design and manufacturing costs and to cover the first year

1 additional annual fee. If the organization fails to submit the 2 required number of applications with attached checks within six 3 months of the effective date of the original authorizing 4 legislation, the plate will not be produced and will require 5 legislative reauthorization: Provided, That an organization or 6 group that is unsuccessful in obtaining the minimum number of 7 applications may not request reconsideration of a special plate 8 until at least two years have passed since the effective date of 9 the original authorization: Provided, however, That the provisions 10 of th0is subdivision (1) are not applicable to the issuance of 11 plates authorized pursuant to subdivision (60), subsection (c) of 12 this section.

13 (2) The commissioner may not begin the design or production of
14 any license plates authorized by this section for which membership
15 or affiliation with a particular organization is not required until
16 at least two hundred fifty registrants complete an application and
17 deposit a fee with the division to cover the first year's basic
18 registration fee, one-time design and manufacturing fee and
19 additional annual fee if applicable. If the commissioner fails to
20 receive the required number of applications within six months of
21 the effective date of the original authorizing legislation, the
22 plate will not be produced and will require legislative
23 reauthorization: *Provided*, That if the minimum number of
24 applications is not satisfied within the six months of the

- 1 effective date of the original authorizing legislation, a person
- 2 may not request reconsideration of a special plate until at least
- 3 two years have passed since the effective date of the original
- 4 authorization.
- 5 (e) (1) Nothing in this section requires a charge for a free
- 6 prisoner of war license plate or a free recipient of the
- 7 Congressional Medal of Honor license plate for a vehicle titled in
- 8 the name of the qualified applicant as authorized by other
- 9 provisions of this code.
- 10 (2) A surviving spouse may continue to use his or her deceased
- 11 spouse's prisoner of war license plate or Congressional Medal of
- 12 Honor license plate until the surviving spouse dies, remarries or
- 13 does not renew the license plate.
- 14 (3) Qualified former prisoners of war and recipients of the
- 15 Congressional Medal of Honor may obtain a second special
- 16 registration plate for use on a passenger vehicle titled in the
- 17 name of the qualified applicant. The division shall charge a one-
- 18 time fee of \$10 to be deposited into the State Road Fund, in
- 19 addition to all other fees required by this chapter, for the second
- 20 special plate.
- 21 (f) The division may issue special ten-year registration
- 22 plates as follows:
- 23 (1) The commissioner may issue or renew for a period of no
- 24 more than ten years any registration plate exempted from

1 registration fees pursuant to any provision of this code or any
2 restricted use antique motor vehicle license plate authorized by
3 section three-a, article ten of this chapter: *Provided*, That the
4 provisions of this subsection do not apply to any person who has
5 had a special registration suspended for failure to maintain motor
6 vehicle liability insurance as required by section three, article
7 two-a, chapter seventeen-d of this code or failure to pay personal
8 property taxes as required by section three-a of this article.

- 9 (2) An initial nonrefundable fee shall be charged for each 10 special registration plate issued pursuant to this subsection, 11 which is the total amount of fees required by section fifteen, 12 article ten of this chapter, section three, article three of this 13 chapter or section three-a, article ten of this chapter for the 14 period requested.
- (g) The provisions of this section may not be construed to the exempt any registrant from maintaining motor vehicle liability insurance as required by section three, article two-a, chapter seventeen-d of this code or from paying personal property taxes on any motor vehicle as required by section three-a of this article.
- (h) The commissioner may, in his or her discretion, issue a registration plate of reflectorized material suitable for permanent use on motor vehicles, trailers and semitrailers, together with appropriate devices to be attached to the registration to indicate the year for which the vehicles have been properly registered or

1 the date of expiration of the registration. The design and

2 expiration of the plates shall be determined by the commissioner.

3 The commissioner shall, whenever possible and cost effective,

4 implement the latest technology in the design, production and

5 issuance of registration plates, indices of registration renewal

6 and vehicle ownership documents, including, but not limited to,

7 offering Internet renewal of vehicle registration and the use of

8 bar codes for instant identification of vehicles by scanning

9 equipment to promote the efficient and effective coordination and

10 communication of data for improving highway safety, aiding law

11 enforcement and enhancing revenue collection.

12 (I) Any license plate issued or renewed pursuant to this
13 chapter which is paid for by a check that is returned for
14 nonsufficient funds is void without further notice to the

15 applicant. The applicant may not reinstate the registration until

16 the returned check is paid by the applicant in cash, money order or

17 certified check and all applicable fees assessed as a result

18 thereof have been paid.

NOTE: The purpose of this bill is to exempt certain recipients of military medals of valor from special registration fees.
