10	AN ACT to amend and reenact $\$18-5A-5$ of the Code of West Virginia,
11	1931, as amended, relating to increasing the faculty senate
12	allotment for classroom teachers and librarians from \$50 to
13	\$100, to be spent on academic materials, supplies or equipment
14	to enhance instruction.
15	Be it enacted by the Legislature of West Virginia:
16	That \$18-5A-5 of the Code of West Virginia, 1931, as amended,
17	be amended and reenacted to read as follows:
18	ARTICLE 5A. LOCAL SCHOOL INVOLVEMENT.
19	§18-5A-5. Public school faculty senates established; election of
20	officers; powers and duties.
21	(a) There is established at every public school in this state
22	a faculty senate which is comprised of all permanent, full-time
23	professional educators employed at the school who shall all be
24	voting members. Professional educators, as used in this section,
25	means professional educators as defined in chapter eighteen-a of

1 this code. A quorum of more than one half of the voting members of 2 the faculty shall be present at any meeting of the faculty senate 3 at which official business is conducted. Prior to the beginning of 4 the instructional term each year, but within the employment term, 5 the principal shall convene a meeting of the faculty senate to 6 elect a chair, vice chair and secretary and discuss matters 7 relevant to the beginning of the school year. The vice chair shall 8 preside at meetings when the chair is absent. Meetings of the 9 faculty senate shall be held during the times provided in 10 accordance with subdivision (12), subsection (b) of this section as 11 determined by the faculty senate. Emergency meetings may be held 12 during noninstructional time at the call of the chair or a majority 13 of the voting members by petition submitted to the chair and vice 14 chair. An agenda of matters to be considered at a scheduled 15 meeting of the faculty senate shall be available to the members at 16 least two employment days prior to the meeting. For emergency 17 meetings the agenda shall be available as soon as possible prior to 18 the meeting. The chair of the faculty senate may appoint such 19 committees as may be desirable to study and submit recommendations 20 to the full faculty senate, but the acts of the faculty senate 21 shall be voted upon by the full body.

22 (b) In addition to any other powers and duties conferred by 23 law, or authorized by policies adopted by the state or county board 24 of education or bylaws which may be adopted by the faculty senate

1 not inconsistent with law, the powers and duties listed in this
2 subsection are specifically reserved for the faculty senate. The
3 intent of these provisions is neither to restrict nor to require
4 the activities of every faculty senate to the enumerated items
5 except as otherwise stated. Each faculty senate shall organize its
6 activities as it deems most effective and efficient based on school
7 size, departmental structure and other relevant factors.

(1) Each faculty senate shall control funds allocated to the 9 school from legislative appropriations pursuant to section nine, 10 article nine-a of this chapter. From such funds, each classroom 11 teacher and librarian shall be allotted \$100 for expenditure during 12 the instructional year for academic materials, supplies 13 equipment which, in the judgment of the teacher or librarian, will 14 assist him or her in providing instruction in his or her assigned 15 academic subjects or shall be returned to the faculty senate: 16 Provided, That nothing contained herein prohibits the funds from 17 being used for programs and materials that, in the opinion of the 18 teacher, enhance student behavior, increase academic achievement, 19 improve self-esteem and address the problems of students at-risk. 20 The remainder of funds shall be expended for academic materials, 21 supplies or equipment in accordance with a budget approved by the 22 faculty senate. Notwithstanding any other provisions of the law to 23 the contrary, funds not expended in one school year are available 24 for expenditure in the next school year: Provided, however, That

- 1 the amount of county funds budgeted in a fiscal year may not be
- 2 reduced throughout the year as a result of the faculty
- 3 appropriations in the same fiscal year for such materials, supplies
- 4 and equipment. Accounts shall be maintained of the allocations and
- 5 expenditures of such funds for the purpose of financial audit.
- 6 Academic materials, supplies or equipment shall be interpreted
- 7 broadly, but does not include materials, supplies or equipment
- 8 which will be used in or connected with interscholastic athletic
- 9 events.
- 10 (2) A faculty senate may establish a process for faculty
- 11 members to interview new prospective professional educators and
- 12 paraprofessional employees at the school and submit recommendations
- 13 regarding employment to the principal, who may also make
- 14 independent recommendations, for submission to the county
- 15 superintendent: Provided, That such process shall be chaired by
- 16 the school principal and must permit the timely employment of
- 17 persons to perform necessary duties.
- 18 (3) A faculty senate may nominate teachers for recognition as
- 19 outstanding teachers under state and local teacher recognition
- 20 programs and other personnel at the school, including parents, for
- 21 recognition under other appropriate recognition programs and may
- 22 establish such programs for operation at the school.
- 23 (4) A faculty senate may submit recommendations to the
- 24 principal regarding the assignment scheduling of secretaries,

- 1 clerks, aides and paraprofessionals at the school.
- 2 (5) A faculty senate may submit recommendations to the
- 3 principal regarding establishment of the master curriculum schedule
- 4 for the next ensuing school year.
- 5 (6) A faculty senate may establish a process for the review
- 6 and comment on sabbatical leave requests submitted by employees at
- 7 the school pursuant to section eleven, article two of this chapter.
- 8 (7) Each faculty senate shall elect three faculty
- 9 representatives to the local school improvement council established
- 10 pursuant to section two of this article.
- 11 (8) Each faculty senate may nominate a member for election to
- 12 the county staff development council pursuant to section eight,
- 13 article three, chapter eighteen-a of this code.
- 14 (9) Each faculty senate shall have an opportunity to make
- 15 recommendations on the selection of faculty to serve as mentors for
- 16 beginning teachers under beginning teacher internship programs at
- 17 the school.
- 18 (10) A faculty senate may solicit, accept and expend any
- 19 grants, gifts, beguests, donations and any other funds made
- 20 available to the faculty senate: Provided, That the faculty senate
- 21 shall select a member who has the duty of maintaining a record of
- 22 all funds received and expended by the faculty senate, which record
- 23 shall be kept in the school office and is subject to normal
- 24 auditing procedures.

- (11) Any faculty senate may review the evaluation procedure as conducted in their school to ascertain whether the evaluations were conducted in accordance with the written system required pursuant to section twelve, article two, chapter eighteen-a of this code and the general intent of this Legislature regarding meaningful performance evaluations of school personnel. If a majority of members of the faculty senate determine that such evaluations were not so conducted, they shall submit a report in writing to the State Board of Education: *Provided*, That nothing herein creates any new right of access to or review of any individual's evaluations.
- (12) A local board shall provide to each faculty senate a two13 hour block of time for a faculty senate meeting on a day scheduled
 14 for the opening of school prior to the beginning of the
 15 instructional term, and a two-hour block of time on each
 16 instructional support and enhancement day scheduled by the board
 17 for instructional activities for students and professional
 18 activities for teachers pursuant to section forty-five, article
 19 five of this chapter. A faculty senate may meet for an unlimited
 20 block of time per month during noninstructional days to discuss and
 21 plan strategies to improve student instruction and to conduct other
 22 faculty senate business. A faculty senate meeting scheduled on a
 23 noninstructional day shall be considered as part of the purpose for
 24 which the noninstructional day is scheduled. This time may be

- 1 utilized and determined at the local school level and includes, but 2 is not limited to, faculty senate meetings.
- 3 (13) Each faculty senate shall develop a strategic plan to
 4 manage the integration of special needs students into the regular
 5 classroom at their respective schools and submit the strategic plan
 6 to the superintendent of the county board of education periodically
 7 pursuant to guidelines developed by the State Department of
 8 Education. Each faculty senate shall encourage the participation
 9 of local school improvement councils, parents and the community at
 10 large in developing the strategic plan for each school.
- Each strategic plan developed by the faculty senate shall include at least: (A) A mission statement; (B) goals; (C) needs; (D) objectives and activities to implement plans relating to each goal; (E) work in progress to implement the strategic plan; (F) guidelines for placing additional staff into integrated classrooms to meet the needs of exceptional needs students without diminishing the services rendered to the other students in integrated classrooms; (G) guidelines for implementation of collaborative planning and instruction; and (H) training for all regular classroom teachers who serve students with exceptional needs in integrated classrooms.
