10	A BILL to amend and reenact $\$5A-3-10$ of the Code of West Virginia,
11	1931, as amended, relating to purchasing practices generally;
12	providing that the purchasing division director may not
13	approve certain purchases; providing that reverse auctions may
14	be used to purchase only commodities; defining the reverse
15	auction process; permitting the use of third-party vendors for
16	reverse auctions; providing purchasing division director with
17	rule-making and emergency rule-making authority to implement
18	reverse auctions; and providing technical clean-up.
19	Be it enacted by the Legislature of West Virginia:
20	That §5A-3-10 of the Code of West Virginia, 1931, as amended,
21	be amended and reenacted to read as follows:
22	ARTICLE 3. PURCHASING DIVISION.
23	§5A-3-10. Competitive bids; publication of solicitations for
24	sealed bids; purchase of products of nonprofit

- workshops; employee to assist in dealings with nonprofit workshops.
- 3 (a) A purchase of and contract for commodities, printing and 4 services shall be based, whenever possible, on competitive bids.
- 5 (b) The director shall solicit sealed bids for the purchase of 6 commodities and printing which is estimated to exceed \$25,000. No 7 spending unit shall issue a series of requisitions or divide or 8 plan procurements to circumvent this \$25,000 threshold or otherwise 9 avoid the use of sealed bids. Any spending unit which awards 10 multiple contracts for the same or similar commodity or service to 11 an individual vendor over any twelve-month period, the total value 12 of which exceeds \$25,000, shall file copies of all contracts 13 awarded to the vendor within the twelve preceding months with the 14 director immediately upon exceeding the \$25,000 limit, along with 15 a statement explaining how the multiple contract awards do not 16 circumvent the \$25,000 threshold. If the spending unit does not 17 immediately report to the director, the director may suspend the 18 purchasing authority of the spending unit until the spending unit 19 complies with the reporting requirement of this subsection. 20 director may conduct a review of any spending unit to ensure 21 compliance with this subsection. Following a review, the director 22 shall complete a report summarizing his or her findings and forward 23 the report to the spending unit. In addition, the director shall 24 report to the Joint Committee on Government and Finance on January

- 1 1 and July 1 of each year the spending units which have reported
- 2 under this subsection and the findings of the director. The
- 3 director may not approve purchases made in violation of this
- 4 section.
- 5 (c) The director may permit bids by electronic transmission to
- 6 be accepted in lieu of sealed bids.
- 7 (d) Notwithstanding any other provision of law, the director
- 8 may permit the use of a reverse auction to purchase commodities if
- 9 the director determines that the use of a reverse auction would be
- 10 advantageous to the state. The director may not, however, use
- 11 reverse auctions for the procurement of services.
- 12 (1) For purposes of this subsection, "reverse auction" means
- 13 a process in which bidders compete to provide commodities in an
- 14 open and interactive environment, including the use of electronic
- 15 media; bids are opened and made public immediately; bidders are
- 16 given an opportunity to submit revised bids until the bidding
- 17 process is complete; and the bid is awarded to the lowest
- 18 <u>responsible bidder.</u>
- 19 (2) The director may contract with qualified, industry-
- 20 recognized third-party vendors to conduct reverse auctions on
- 21 behalf of the director.
- 22 (3) The director shall propose rules for legislative approval

- 5 (d) (e) Bids shall be solicited by public notice. The notice
- 6 may be published by any advertising medium the director deems
- 7 advisable. The director may also solicit sealed bids by sending
- 8 requests by mail or electronic transmission to prospective vendors.
- 9 (e) (f) The director shall, without competitive bidding,
- 10 purchase commodities and services produced and offered for sale by
- 11 nonprofit workshops, as defined in section one, article one of this
- 12 chapter, which are located in this state: Provided, That such
- 13 commodities and services shall be of a fair market price and of
- 14 like quality comparable to other commodities and services otherwise
- 15 available as determined by the director with the advice of the
- 16 committee on the purchase of commodities and services from the
- 17 handicapped.
- 18 To encourage contracts for commodities and services with
- 19 nonprofit workshops, the director shall employ a person whose
- 20 responsibilities in addition to other duties shall be are to
- 21 identify all commodities and services available for purchase from
- 22 nonprofit workshops, to evaluate the need of the state for
- 23 commodities and services to coordinate the various nonprofit
- 24 workshops in their production efforts and to make available to such

- 1 workshops information about available opportunities within state
- 2 government for purchase of commodities or services which might be
- 3 produced and sold by such workshops. Funds to employ such a person
- 4 shall be included annually in the budget.

NOTE: The purpose of this bill is to allow the Director of the Purchasing Division to conduct reverse auctions to purchase commodities.
