25	§19-10-1. Fund created; administration of funds; advisory board

- 1 (a) There is created in the State Treasury a special revenue

- 5 The purposes of the fund is to provide funding to the Spay
- 6 Neuter Assistance Program of West Virginia, Inc., a 26 U.S.C.
- 7 §501(c)(3) nonprofit corporation. All moneys shall be used by the
- 8 Spay Neuter Assistance Program of West Virginia, Inc. for the

- 7 §19-20A-5. Type of vaccine to be furnished; fees.
- It is the duty of the veterinarian, or person vaccinating each animal to furnish vaccine of a type capable of establishing and maintaining immunity for a period of not less than thirty-six months and he or she shall charge and collect a fee of not more than \$8 for each animal vaccinated, if done at a clinic established by a county commission or, if vaccinated at any other place, he or she shall charge and collect a reasonable fee for his or her services. In addition to any fee charged for a rabies vaccination, a \$3 surcharge shall be collected for each rabies vaccination by the veterinarian or clinic to be remitted to the Department of Agriculture for deposit in the Spay Neuter Assistance Fund created by section one, article ten of this chapter. The commissioner shall propose rules in accordance with the provisions of article three, chapter twenty-nine-a of this code to implement the provisions of this section and article ten of this chapter.

NOTE: The purpose of this bill is to implement a \$3 fee on rabies vaccinations to help finance spay neuter programs in West

Virginia. Moneys collected from the \$3 fee will be deposited in the newly created Spay Neuter Assistance Fund, and will be distributed to the Spay Neuter Assistance Program of West Virginia, which is a program currently providing spay neuter assistance in the state.

Strike-throughs indicate language that would be stricken from the present law, and underscoring indicates new language that would be added.

Article §19-10 is new; therefore, it has been completely underscored.
