10	A BILL to amend and reenact $\$3-2-6$ and $\$3-2-16$ of the Code of West
11	Virginia, 1931, as amended; and to amend and reenact $\$3-5-17$
12	of said code, all relating to lengthening the period for voter
13	registration; lengthening the period during which voters may
14	register to the third day before an election; changing the
15	verification procedures to provide for the extended period of
16	registration; permitting registration during early elections
17	to occur only at locations designated by the county clerk;
18	permitting persons to register and vote on the same day during
19	the early-voting period; prohibiting persons from changing
20	party affiliation during the early-voting period preceding a
21	primary election; and changing the canvassing start day in
22	primary elections to Monday so clerks can comply with ten-day
23	post card verification requirement.
24	Be it enacted by the Legislature of West Virginia:
25	That $$3-2-6$$ and $$3-2-16$ of the Code of West Virginia, 1931, as

- 1 amended, be amended and reenacted; and that §3-5-17 of said code be
- 2 amended and reenacted all to read as follows:
- 3 ARTICLE 2. REGISTRATION OF VOTERS.
- 4 §3-2-6. Time of registration application before an election.
- 5 (a) (1) Voter registration before an election shall close on
- 6 the twenty-first day before the election, or on the first day
- 7 thereafter which is not a Saturday, Sunday or legal holiday.
- 8 (2) (A) Beginning January 1, 2012, and for each election held
- 9 thereafter, voter registration before an election shall close at
- 10 the end of business hours on the third day before the election.
- 11 For any election held on a Tuesday, voter registration pursuant to
- 12 this subdivision must be available from 9:00 a.m. to 5:00 p.m. on
- 13 the two Saturdays prior to the election.
- 14 (B) Voter registration conducted during the period beginning
- 15 on the twentieth day before an election and continuing through the
- 16 third day before an election shall occur only at a location
- 17 designated by the clerk of the county commission.
- 18 (C) During the period of voter registration beginning on the
- 19 twentieth day before an election and continuing through the third
- 20 day before an election, a person who is already registered to vote
- 21 in the county may update the information in the registration record
- 22 in accordance with section twenty-two, article two of this chapter,
- 23 and may also update an address if he or she has moved from one
- 24 county to a new county within the state.
- 25 (D) A person who registers to vote pursuant to the provisions

- 1 of this subdivision and who is eligible to vote, may only vote at
- 2 an early-voting site during the early-voting period as provided in
- 3 section three, article three of this chapter.
- 4 (E) During the period of voter registration beginning on the
- 5 twentieth day before an election and continuing through the third
- 6 day before the first or second partisan primary, a person who is
- 7 already registered to vote, may not change his or her party
- 8 <u>affiliation</u>.
- 9 (b) An application for voter registration, transfer of
- 10 registration, change of name or change of political party
- 11 affiliation submitted by an eligible voter by the close of voter
- 12 registration shall be effective for any subsequent primary, general
- 13 or special election if the following conditions are met:
- 14 (1) The application contains the information required by
- 15 subsection (c), section five of this article: Provided, That
- 16 incomplete applications for registration containing information
- 17 which are submitted within the required time may be corrected
- 18 within four business days after the close of registration if the
- 19 applicant provides the required information; and
- 20 (2) The application is received by the appropriate clerk of
- 21 the county commission no later than the hour of the close of
- 22 registration or is otherwise submitted by the following deadlines:
- 23 (A) If mailed, the application shall be addressed to the
- 24 appropriate clerk of the county commission and is postmarked by the
- 25 postal service no later than the date of the close of registration:

- 1 Provided, That if the postmark is missing or illegible, the
- 2 application shall be presumed to have been mailed no later than the
- 3 close of registration if it is received by the appropriate clerk of
- 4 the county commission no later than the third day following the
- 5 close of registration;
- 6 (B) If accepted by a designated agency or motor vehicle
- 7 licensing office, the application is received by that agency or
- 8 office no later than the close of registration;
- 9 (C) If accepted through a registration outreach program, the
- 10 application is received by the clerk, deputy clerk or registrar no
- 11 later than the close of registration; and
- 12 (3) The verification notice by the provisions of section
- 13 sixteen of this article mailed to the voter at the residence
- 14 indicated on the application is not returned as undeliverable.
- 15 §3-2-16. Procedures upon receipt of application for registration
- by the clerk of the county commission; verification
- 17 procedure and notice of disposition of application for
- 18 registration.
- 19 (a) Upon receipt of an application for voter registration, the
- 20 clerk of the county commission shall determine whether the
- 21 application is complete, whether the applicant appears to be
- 22 eligible to register to vote within the county and whether the
- 23 applicant is currently registered within the county. If the
- 24 application is incomplete or the applicant appears not to be

- 1 eligible, the clerk shall take the appropriate action as prescribed 2 in section seventeen of this article.
- 3 (b) If the application received is complete and appears to be
 4 from an eligible person who has not previously been registered
 5 within the county, or has not been included within the active voter
 6 registration files as defined in section eighteen of this article
 7 within the preceding calendar year and does not present a driver's
 8 license containing the residence address pursuant to the provisions
 9 of subdivision (2), subsection (d), section seven of this article,
 10 the clerk of the county commission shall conduct the following
 11 verification procedure:
- 12 clerk shall issue mail, by first-class (1)The or 13 nonforwardable return requested, a verification notice addressed to 14 the applicant at the residence and mailing address given on the 15 application, except that the mailing address shall not be included 16 on the notice if it appears to identify a distinctly different 17 location from the residence address, such as a business address, 18 another residence or a different city or town, unless the voter has 19 registered as a uniformed services, overseas or homeless voter and 20 provided a local residence address pursuant to the provisions of 21 subdivision (4), subsection (c), section five of this article.
- 22 (2) The verification notice shall state the purpose of the 23 procedure, the fact that no further action is required of the 24 applicant, and the fact that a notice of the disposition of the 25 registration application will be mailed after the ten day return

- 1 period has expired.
- 2 (3) If the verification notice is not returned as
- 3 undeliverable within ten days or by the start of canvas, whichever
- 4 occurs first, the application for registration shall be accepted
- 5 and entered into the active voter registration files and a
- 6 registration receipt mailed designating the voter's assigned
- 7 precinct.
- 8 (4) If the verification notice is returned undeliverable
- 9 within ten days, the clerk shall compare the address given on the
- 10 voter registration application with the address used on the
- 11 envelope and, if there is any discrepancy, shall send a second
- 12 verification notice to the correct address. If there is no
- 13 discrepancy, the application for registration shall be denied and
- 14 the notice of denial prescribed in section seventeen of this
- 15 article shall be mailed.
- 16 (5) If the verification notice is returned undeliverable after
- 17 the registration has been accepted, the clerk shall initiate the
- 18 confirmation procedure prescribed in section twenty-six of this
- 19 article.
- 20 (c) If the application received is complete and appears to be
- 21 from an eligible person who is currently registered within the
- 22 county, or has been included within the active voter registration
- 23 files as defined in section eighteen of this article within the
- 24 preceding calendar year, the clerk of the county commission shall
- 25 send, by first-class nonforwardable return requested mail, a

- 1 registration receipt or other notice of the disposition of the 2 application; and
- 3 (1) If the application is for a change of name, change of 4 address, change of political party affiliation, reinstatement or 5 other correction of the previous voter registration, the clerk 6 shall include a new voter registration receipt;
- 7 (2) If the application does not make any change in the 8 previous voter registration, the clerk shall notify the registrant 9 that the voter is not required to reregister or update the 10 registration as long as he or she lives at the same address and has 11 the same legal name; or
- 12 (3) If the notice of disposition is returned undeliverable 13 after the registration has been accepted, the clerk shall initiate 14 the confirmation procedure prescribed in section twenty-six of this 15 article.
- (d) If the application contains information indicating the address at which the applicant was previously registered to vote in another county or state, the clerk of the county commission shall give notice to the clerk or registrar of that jurisdiction for the purpose of canceling the previous registration.
- 21 ARTICLE 5. PRIMARY ELECTIONS AND NOMINATING PROCEDURES.
- 22 §3-5-17. Canvassing and certifying returns; recount procedures.
- The county <u>court commission</u> sitting as a board of canvassers, shall meet at the courthouse of the county on the <u>Friday Monday</u> next succeeding any primary election and shall proceed to canvass

- 1 the returns of such election. The procedures prescribed in section 2 nine of article six of this chapter, relating to canvass of general 3 election returns, shall, where adaptable, be applied in the canvass 4 of the primary election returns. The board shall proceed to 5 ascertain the result of such election in the county and district, 6 and election precincts thereof, and cause to be prepared and 7 recorded in the primary election precinct record book, a table or 8 tables which shall show, as to each candidate of each political 9 party for each office, the number of votes cast for him or her at 10 each precinct, and the total number thereof cast in the entire 11 county. The board shall then make up and enter in said record book 12 a certificate for each political party, showing, as to each 13 candidate for each political party for each office, the total 14 number of votes (in words and also in figures) cast for him or her 15 in the entire county and the number of votes received by all the 16 candidates of such party in such district, which shall be in the 17 following form:
- The board of canvassers of the county of, State of 19 West Virginia, having carefully and impartially examined the 20 returns of the primary election held in said county on the ... day 21 of ..., 19 20..., do hereby certify that in said county or 22 district, at said election, on the official ballot of the 23 party for the office of, A. B. received ... 24 (...) votes; C. D. received ... (...) votes.
- 25 And so on for each office for each political party according

- 1 to the truth. When the certificates are all entered, the report
- 2 shall be signed by the members of the board or a majority thereof.
- 3 Such members shall also sign separate certificates of the result of
- 4 said election, within the county, for each of the offices to be
- 5 filled by each political party, as provided by the following
- 6 section.
- 7 The provisions of article six of this chapter, relating to the
- 8 recount of votes in general elections, shall, to the extent
- 9 applicable, be operative in primary and other elections conducted
- 10 under provisions of this article.

NOTE: The purpose of this bill is to lengthen the period for voter registration and lengthens the period during which voters may register to the third day before an election. The bill permits registration during early elections to occur only at locations designated by the county clerk and permits persons to register and vote on the same day during the early-voting period. The bill also prohibits persons from changing party affiliation during the early-voting period preceding a primary election. Additionally, the bill changes the canvassing start day in primary elections to Monday so clerks can comply with ten-day postcard verification requirement.

The bill was reported from the Joint Committee on the Judiciary without recommendation.

Strike-throughs indicate language that would be stricken from the present law, and underscoring indicates new language that would be added.
