19	Be it enacted by the Legislature of West Virginia:
20	That §5B-1-2 of the Code of West Virginia, 1931, as amended,
21	be amended and reenacted; that $$5B-2-8$$ and $$5B-2-9$$ of said code be
22	amended and reenacted; and that $\$5F-2-1$ of said code be amended and
23	reenacted, all to read as follows:

- 22 ARTICLE 2. WEST VIRGINIA DEVELOPMENT OFFICE.
- 23 §5B-2-8. Division of Tourism and Tourism Commission created;
- 24 members, appointment and expenses.

- 1 (a) There is hereby <u>created continued</u> within the <u>West Virginia</u>
 2 <u>Development Office Department of Commerce</u> the Division of Tourism
 3 and an independent Tourism Commission, which is a body corporate
 4 and politic, constituting a public corporation and government
 5 instrumentality. The commission consists of <u>thirteen fifteen</u>
 6 members:
- (1) Nine Twelve members to be appointed by the Governor, with 8 the advice and consent of the Senate, representing participants in 9 the state's tourism industry. At least seven ten of the members 10 shall be from the private sector. Of the nine twelve members so 11 appointed, one shall represent a convention and visitors bureau and 12 another shall be a member of a convention and visitors bureau. In 13 making the appointments the Governor may select from a list 14 provided by the West Virginia Hospitality and Travel Association of 15 qualified applicants. Of the nine twelve members so appointed, no 16 more less than three shall be from each congressional district 17 within the state and shall be appointed to provide the broadest 18 geographic distribution which is feasible;
- (2) One member to be appointed by the Governor from the
 membership of the Council for Community and Economic Development
 created pursuant to the provisions of section two of this article;

 (3) (2) One member to be appointed by the Governor to
 represent public sector nonstate participants in the tourism
 industry within the state;

- 1 (4) (3) The Secretary of Transportation or his or her 2 designee, ex officio; and
- $\frac{(5)}{(4)}$ The Director of the Division of Natural Resources or 4 his or her designee, ex officio.
- 5 (b) Each member appointed by the Governor shall serve 6 staggered terms of four years. Any member whose term has expired 7 shall serve until his or her successor has been appointed. Any 8 person appointed to fill a vacancy shall serve only for the 9 unexpired term. Any member shall be eligible for reappointment. 10 In cases of vacancy in the office of member, such vacancy shall be 11 filled by the Governor in the same manner as the original
- (c) Members of the commission shall not be entitled to compensation for services performed as members. A majority of these members shall constitute a quorum for the purpose of conducting business. The Governor shall appoint a chair of the commission for a term to run concurrent with the term of the office of the member appointed to be the chair. The chair is eligible for successive terms in that position.

- 21 (a) The commission shall develop a comprehensive tourism
- 22 promotion and development strategy for West Virginia.
- 23 "Comprehensive tourism promotion and development strategy" means a
- 24 plan that outlines strategies and activities designed to continue,

- 1 diversify or expand the tourism base of the state as a whole;
- 2 create tourism jobs; develop a highly skilled tourism work force;

All boards that are appellate bodies or are independent 11 decision makers shall not have their appellate or independent

12 decision-making status affected by the enactment of this chapter.

- (m) Any department previously transferred to and incorporated in a department by prior enactment of this section means a division of the appropriate department. Wherever reference is made to any department transferred to and incorporated in a department created in section two, article one of this chapter, the reference means a division of the appropriate department and any reference to a division of a department so transferred and incorporated means a section of the appropriate division of the department.
- (n) When an agency, board or commission is transferred under 22 a bureau or agency other than a department headed by a secretary 23 pursuant to this section, that transfer is solely for purposes of 24 administrative support and liaison with the Office of the Governor, 25 a department secretary or a bureau. Nothing in this section extends

- 1 the powers of department secretaries under section two of this
- 2 article to any person other than a department secretary and nothing
- 3 limits or abridges the statutory powers and duties of statutory
- 4 commissioners or officers pursuant to this code.

NOTE: The purpose of this bill is to clarify that Division of Tourism is a separate division within the Department of Commerce; to increase the number of members of the Tourism Commission; and to change the makeup of the Commission.
