20 The Legislature finds that the above moral obligations and the  
21 appropriations made in satisfaction thereof shall be the full  
22 compensation for all claimants and that prior to the payments to  
23 any claimant provided in this bill, the Court of Claims shall  
24 receive a release from said claimant releasing any and all claims



1 for moral obligations arising from the matters considered by the  
2 Legislature in the finding of the moral obligations and the making  
3 of the appropriations for said claimant. The Court of Claims shall  
4 deliver all releases obtained from claimants to the department  
5 against which the claim was allowed.

NOTE: The purpose of this bill is for the Legislature to find and declare the existence of a moral obligation to pay, with public moneys, each of the claims herein against specified state agencies and the State of West Virginia, by the named claimants, payable from the specified funds, and in the amounts of the awards made.

A second and separate bill (either supplementary appropriation bill or a section of the budget bill) will actually appropriate the moneys herein awarded and permit payment in current fiscal year 2011 and through 2012.

The totals, as to type of funds and amounts of awards in the bill, are:

- (1) General Revenue Funds of \$5,957,941.63
- (2) Special Revenue Funds of \$70,428.87
- (3) State Road Funds of \$2,389,259.77
