10 A BILL making a supplementary appropriation of federal funds from

14 the Secretary, fund 8841, fiscal year 2011, organization 0431,
15 and to the Department of Health and Human Resources - Division
16 of Health - West Virginia Safe Drinking Water Treatment, fund
17 8824, fiscal year 2011, organization 0506, by supplementing
18 and amending the appropriations for the fiscal year ending
