## Senate Bill No. 581

(By Senators Unger and K. Facemyer)

A BILL to amend and reenact §3-3-3 of the Code of West Virginia, 1931, as amended, relating to reducing the days for early voting in person; and allowing Saturday early voting in all elections.

Be it enacted by the Legislature of West Virginia:

That §3-3-3 of the Code of West Virginia, 1931, as amended, be amended and reenacted to read as follows:

## ARTICLE 3. VOTING BY ABSENTEES.

## §3-3-3. Early voting in person.

- 1 (a) The voting period for early in-person voting is to be
- 2 conducted during regular business hours beginning on the
- 3 twentieth thirteenth day before the election and continuing
- 4 through the third day before the election. For any election

- 5 held on a Tuesday, The early voting period for in-person
- 6 voting is to be available from 9:00 a.m. to 5:00 p.m. on the
- 7 two Saturdays prior to the election.
- 8 (b) Any person desiring to vote during the period of early
- 9 in-person voting shall, upon entering the election room,
- 10 clearly state his or her name and residence to the official or
- 11 representative designated to supervise and conduct absentee
- 12 voting. If that person is found to be duly registered as a voter
- 13 in the precinct of his or her residence, he or she shall be is
- 14 required to sign his or her name in the space marked
- 15 "signature of voter" on the pollbook. If the voter is unable to
- 16 sign his or her name due to illiteracy or physical disability,
- 17 the person assisting the voter and witnessing the mark of the
- 18 voter shall sign his or her name in the space provided. No
- 19 ballot may be given to the person until he or she signs his or
- 20 her name on the pollbook.
- 21 (c) When the voter's signature or mark is properly on the
- 22 pollbook, two qualified representatives of the official
- 23 designated to supervise and conduct absentee voting shall
- 24 sign their names in the places indicated on the back of the
- 25 official ballot.

- 26 (d) If the official designated to supervise and conduct
- 27 absentee voting determines that the voter is not properly
- 28 registered in the precinct where he or she resides, the clerk
- 29 or his or her representative shall challenge the voter's
- 30 absentee ballot as provided in this article.
- 31 (e) The official designated to supervise and conduct
- 32 absentee voting shall provide each person voting an absentee
- 33 ballot in person the following items to be printed as pre-
- 34 scribed by the Secretary of State:
- 35 (1) In counties using paper ballots, one of each type of
- 36 official absentee ballot the voter is eligible to vote, prepared
- 37 according to law;
- 38 (2) In counties using punch card systems, one of each type
- 39 of official absentee ballot the voter is eligible to vote,
- 40 prepared according to law, and a gray secrecy envelope;
- 41 (3) In counties using optical scan systems, one of each type
- 42 of official absentee ballot the voter is eligible to vote,
- 43 prepared according to law, and a secrecy sleeve; or
- 44 (4) For direct recording election systems, access to the
- 45 voting equipment in the voting booth.
- 46 (f) The voter shall enter the voting booth alone and there
- 47 mark the ballot: *Provided*, That the voter may have assis-

- 48 tance in voting according to the provisions of section four of
- 49 this article. After the voter has voted the ballot or ballots,
- 50 the absentee voter shall: Place the ballot or ballots in the
- 51 gray secrecy envelope and return the ballot or ballots to the
- 52 official designated to supervise and conduct the absentee
- 53 voting: *Provided*, *however*, That in direct recording election
- 54 systems, once the voter has cast his or her ballot, the voter
- 55 shall exit the polling place.
- 56 (g) Upon receipt of the voted ballot, representatives of the
- 57 official designated to supervise and conduct the absentee
- 58 voting shall:
- 59 (1) Remove the ballot stub;
- 60 (2) Place punch card ballots and paper ballots into one
- 61 envelope which shall not have any marks except the precinct
- 62 number and seal the envelope; and
- 63 (3) Place ballots for all voting systems into a ballot box
- 64 that is secured by two locks with a key to one lock kept by
- 65 the president of the county commission and a key to the
- 66 other lock kept by the county clerk.
- 67 (4) Due to the reenactment of this section by the Legisla-
- 68 ture in the two thousand three regular session removing
- 69 authorization for early in-person voting on the Monday prior

to a Tuesday election, to assure notice to all persons that
voted on the Monday before the Tuesday election day of the
two thousand two general election are made aware of this
change, the clerk of each county shall, for the primary
election of the year two thousand four, include along with
the sample ballots published in local newspapers as required
by this chapter a notice to voters that Monday in-person
voting will no longer be available.

(NOTE: The purpose of this bill is to change the beginning time for early voting from the twentieth day prior to the election to the thirteenth day prior to the election. This will result in a loss of only five early voting days. This bill will allow Saturday early voting for all elections.

Strike-throughs indicate language that would be stricken from the present law, and underscoring indicates new language that would be added.)
