11	adding thereto a new section, designated §61-2-14h, relating
12	to crimes against the person; creating the felony criminal
13	offense of sale or purchase of a child; and providing for
14	penalties.
15	Be it enacted by the Legislature of West Virginia:
16	That the Code of West Virginia, 1931, as amended, be amended,
17	by adding thereto a new section, designated $$61-2-14h$, to read as
18	follows:
19	ARTICLE 2. CRIMES AGAINST THE PERSON.
20	§61-2-14h. Sale or purchase of child; penalties.
21	(a) Any person or agency who knowingly offers, gives or agrees
22	to give to another person money, property, service or other thing
23	of value in consideration for the recipient's locating, providing

- 1 or procuring a minor child for any purpose which entails a transfer
- 2 of the legal or physical custody of the child is guilty of a felony
- 3 and, subject to fine and imprisonment as provided herein.
- 4 (b) Any person who knowingly receives, accepts or offers to
- 5 accept money, property, service or other thing of value to locate,
- 6 provide or procure a minor child for any purpose which entails a
- 7 transfer of the legal or physical custody of the child, is guilty
- 8 of a felony and, subject to fine and imprisonment as provided
- 9 herein.
- 0 Any person who violates the provisions of this section is
- 11 guilty of a felony and, upon conviction thereof, shall be
- 12 imprisoned in a state correctional facility not less than one year
- 13 nor more than ten years or confined in jail not more than one year
- 14 and fined not less than \$2,000 nor more than \$10,000.

NOTE: The purpose of this bill is to create a separate criminal offense for the sale or purchase of a child from the offense contained in Article 22, Chapter 48 of the Code relating to adoptions. It creates a felony offense after the effective date of this section.

This section is new; therefore, it has been completely underscored.
