10	A BILL to amend and reenact $\$17C-15-36a$ of the Code of West
11	Virginia, 1931, as amended, relating to exempting unmarked
12	law-enforcement vehicles primarily used for covert or
13	undercover enforcement from sun screening restrictions.
14	Be it enacted by the Legislature of West Virginia:
15	That §17C-15-36a of the Code of West Virginia, 1931, as
16	amended, be amended and reenacted to read as follows:
17	ARTICLE 15. EQUIPMENT.
18	<pre>§17C-15-36a. Sun screening devices; penalty.</pre>
19	(a) No person may operate a motor vehicle that is registered
20	or required to be registered in the state on any public highway,
21	road or street that has a sun screening device on the windshield,
22	the front side wings and side windows adjacent to the right and
23	left of the driver and windows adjacent to the rear of the driver
24	that do not meet the requirements of this section: Provided, That

1 law-enforcement K-9 and other emergency vehicles that are designed 2 to haul animals <u>and unmarked law-enforcement vehicles primarily</u> 3 <u>used for covert or undercover enforcement</u> are exempt from this 4 requirement.

5 (b) A sun screening device when used in conjunction with the 6 windshield must be nonreflective and may not be red, yellow or 7 amber in color. A sun screening device may be used only along the 8 top of the windshield and may not extend downward beyond the ASI 9 line or more than five inches from the top of the windshield 10 whichever is closer to the top of the windshield.

(c) A sun screening device when used in conjunction with the 11 12 automotive safety glazing materials of the side wings or side 13 windows located at the immediate right and left of the driver shall 14 be a nonreflective type with reflectivity of not more than twenty 15 percent and have a light transmission of not less than thirty-five 16 percent. The side windows behind the driver and the rear most 17 windows may have a sun screening device that is designed to be used 18 on automotive safety glazing materials that has а light 19 transmission of not less than thirty-five percent and a 20 reflectivity of not more than twenty percent. If a sun screening 21 device is used on glazing behind the driver, one right and one left 22 outside rear view mirror is required.

23 (d) Each manufacturer shall:

24 (1) Certify to the West Virginia State Police and Division of

1 Motor Vehicles that a sun screening device used by it is in 2 compliance with the reflectivity and transmittance requirements of 3 this section;

4 (2) Provide a label not to exceed one and one-half square 5 inches in size, with a means for the permanent and legible 6 installations between the sun screening material and each glazing 7 surface to which it is applied that contains the manufacturer's 8 name and its percentage of light transmission; and

9 (3) Include instructions with the product or material for 10 proper installation, including the affixing of the label specified 11 in this section. The labeling or marking must be placed in the 12 left lower corner of each glazing surface when facing the vehicle 13 from the outside.

14 (e) No person may:

(1) Offer for sale or for use any sun screening product or 16 material for motor vehicle use not in compliance with this section; 17 or

(2) Install any sun screening product or material on vehicles
19 intended for use on public roads without permanently affixing the
20 label specified in this section.

(f) The provisions of this section do not apply to a motor vehicle registered in this state in the name of a person, or the sperson's legal guardian, who has an affidavit signed by a physician or an optometrist licensed to practice in this state that states

1 that the person has a physical condition that makes it necessary to 2 equip the motor vehicle with sun screening material which would be 3 of a light transmittance or luminous reflectance in violation of 4 this section. The affidavit must be in the possession of the 5 person so afflicted, or the person's legal guardian, at all times 6 while being transported in the motor vehicle.

7 (g) The light transmittance requirement of this section does
8 not apply to windows behind the driver on trucks, buses, trailers,
9 mobile homes and multipurpose passenger vehicles.

10 (h) As used in this section:

11 (1) "Bus" means a motor vehicle with motive power, except a 12 trailer, designed for carrying more than ten persons.

13 (2) "Light transmission" means the ratio of the amount of 14 total light to pass through a product or material to the amount of 15 the total light falling on the product or material.

16 (3) "Luminous reflectants" means the ratio of the amount of 17 total light that is reflected outward by the product or material to 18 the amount of the total light falling on the product or materials. 19 (4) "Manufacturer" means any person engaged in the 20 manufacturing or assembling of sun screening products or materials 21 designed to be used in conjunction with vehicle glazing materials 22 for the purpose of reducing the effects of the sun.

(5) "Motor homes" means vehicular units designed to provide24 temporary living quarters built into and an integral part of or

1 permanently attached to a self-propelled motor vehicle chassis.

2 (6) "Multipurpose passenger vehicle" means a motor vehicle 3 with motive power, except a trailer, designed to carry ten persons 4 or less which is constructed either on a truck chassis or with 5 special features for occasional off-road operation.

6 (7) "Nonreflective" means a product or material designed to 7 absorb light rather than to reflect it.

8 (8) "Passenger car" means a motor vehicle with motive power, 9 except a multipurpose passenger vehicle, motorcycle or trailer, 10 designed for carrying ten persons or less.

(9) "Sun screening device" means film material or device that l2 is designed to be used in conjunction with motor vehicle safety l3 glazing materials for reducing the effects of the sun.

14 (10) "Truck" means a motor vehicle with motive power, except 15 a trailer, designed primarily for the transportation of property or 16 special purpose equipment.

(i) Any person violating the provisions of this section is l8 guilty of a misdemeanor and, upon conviction thereof, shall be l9 fined not more than \$200.

NOTE: The purpose of this bill is to exempt unmarked lawenforcement vehicles used for covert or undercover enforcement from sun screening restrictions.
