10 AN ACT expiring funds to the surplus balance in the State Fund,
11 General Revenue, for the fiscal year ending June 30, 2012, in
12 the amount of \$3,700,000 from the Department of Health and
13 Human Resources - Medicaid Fraud Control Fund, fund 5141,
14 fiscal year 2012, organization 0511, and making a
15 supplementary appropriation of public moneys out of the
16 Treasury from the balance of moneys remaining as a surplus
17 balance in the State Fund, General Revenue, to the Department
18 of Health and Human Resources - Division of Human Services,
19 fund 0403, fiscal year 2012, organization 0511, by
20 supplementing and amending the appropriations for the fiscal
21 year ending June 30, 2012.

22 WHEREAS, The Legislature finds that the account balance in the
23 Department of Health and Human Resources - Medicaid Fraud Control
24 Fund, fund 5141, fiscal year 2012, organization 0511, exceeds that

1 which is necessary for the purposes for which the account was
2 established; and

3 WHEREAS, The Governor submitted to the Legislature the
4 Executive Budget document, dated January 11, 2012, which included
5 a statement of the State Fund, General Revenue, setting forth
6 therein the cash balance as of July 1, 2011; and further included
7 the estimate of revenues for the fiscal year 2012, less net
8 appropriation balances forwarded and regular appropriations for
9 fiscal year 2012; and

10 WHEREAS, It appears from the Governor's Executive Budget
11 document, statement of the State Fund, General Revenue, and this
12 legislation there now remains a surplus balance in the State
13 Treasury which is available for appropriation during the fiscal
14 year ending June 30, 2012; therefore

15 *Be it enacted by the Legislature of West Virginia:*

16 That the balance of the funds available for expenditure in the
17 fiscal year ending June 30, 2012, Department of Health and Human
18 Resources - Medicaid Fraud Control Fund, fund 5141, fiscal year
19 2012, organization 0511, be decreased by expiring the amount of
20 \$3,700,000 to the surplus balance of the State Fund, General
21 Revenue, to be available for appropriation during the fiscal year
22 2012.

23 And, That the total appropriation for the fiscal year ending
24 June 30, 2012, to fund 0403, fiscal year 2012, organization 0511,

1 be supplemented and amended by increasing an existing item of
2 appropriation as follows:

16 amend and increase an item of appropriation in the aforesaid
17 account for the designated spending unit for expenditure during the
18 fiscal year 2012.
