17 *Be it enacted by the Legislature of West Virginia:*

3 (a) The Legislature finds that in 1989, this chapter was
4 enacted to provide for the reorganization of the executive branch
5 of state government pursuant the findings set forth under section
6 one, article one of this chapter. This section was enacted as part
7 of that legislation to effect the transfer of agencies and board
8 and related entities into the various departments created within
9 the executive branch of government. Since its initial enactment,
10 the Legislature has amended and reenacted this section on a number
11 of occasions, in most instances to modify the initial
12 reorganization within the executive branch of government. The
13 Legislature further finds that the structure of this section by
14 which it provides an extensive list of executive agencies in a
15 single section of the code of West Virginia renders this section
16 unnecessarily lengthy and complicated. The designation of a
17 separate statute for each of the agencies and entities as they are
18 organized in subsections (a) through (l) of this subsection as
19 provided pursuant to the amendment and reenactment of this section
20 in 2011 would reduce the unnecessary length and complexity of the
21 statute without altering the Legislature's intent in providing for
22 the organization of the executive branch of state government
23 pursuant the original findings set forth under section one, article
24 one of this chapter and the Legislature's subsequent amendments and
25 reenactments of various sections of this chapter. The Legislature
26 therefore finds and declares that the amendment and reenactment of

1 this section and the further amendment of the code of West Virginia
2 by adding thereto twelve new sections, designated §5F-2-1a,
3 §5F-2-1b, §5F-2-1c, §5F-2-1d, §5F-2-1e, §5F-2-1f, §5F-2-1g,
4 §5F-2-1h, §5F-2-1i, §5F-2-1j, §5F-2-1k and §5F-2-1l in 2013 are
5 solely for purposes of designating a separate statute for each of
6 the agencies and entities as they are organized in subsections (a)
7 through (l) of this subsection as provided pursuant to the
8 amendment and reenactment of this section in 2011, and in §5F-2-1k
9 to provide for corrective descriptions of an agency and to add an
10 additional agency to the list of agencies organized under that
11 section. The Legislature further finds and declares that except as
12 otherwise provided in this section, the amendment and reenactment
13 of this section and the enactment of the new sections as aforesaid
14 in 2013 may not be construed to have altered or modified the
15 application of any other provision of this code to the agencies and
16 entities described in those sections, and that all other provisions
17 of this code, to the extent applicable to those subsections, as
18 well as the remaining subsections of this section, shall to apply
19 in like manner to the agencies and entities described in those new
20 sections.
