15   *Be it enacted by the Legislature of West Virginia:*

16   **CLAIMS AGAINST THE STATE.**

17   **§1.   Finding and declaring certain claims against the Board of**  
18           **Veterinary Medicine; Consolidated Public Retirement Board;**  
19           **Department of Administration; Department of Administration/**  
20           **Division of Real Estate; Department of Education; Division**  
21           **of Corrections; Division of Highways; Division of Motor**  
22           **Vehicles; Division of Veterans Affairs; Public Defender**  
23           **Services; Regional Jail Authority; State Fire Commission**

1           **and State of West Virginia to be moral obligations of the**  
2           **state and directing payment thereof.**

3           The Legislature has considered the findings of fact and

13       The Legislature finds that the above moral obligations and the
