| 16 | Be it enacted by the Legislature of West Virginia:                    |
| 17 | That the Code of West Virginia, 1931, as amended, be amended          |
| 18 | by adding thereto a new section, designated $\$18-11-12$ , to read as |
| 19 | follows:  |
| 20 | ARTICLE 11. WEST VIRGINIA UNIVERSITY.                                 |
| 21 | §18-11-12. Tax Checkoff For Jackson's Mill 4-H Camp.                  |
| 22 | (a) Each West Virginia individual income tax return form shall        |
| 23 | contain a designation as follows:                                     |

1 "Jackson's Mill 4-H Camp Checkoff Program" - "Donations to be 2 used as a source of revenue for the operation of the Jackson's Mill 3 4-H Camp."

4 "Check () if you wish to designate \$1, \$5, \$10 or more of 5 your tax refund for this program. If joint return, check () if 6 spouse wishes to designate \$1, \$5, \$10 or more."

7 (b) Each individual taxpayer desiring to contribute to the 8 "Jackson's Mill 4-H Camp Checkoff Program" may designate by placing 9 an "X" in the appropriate box on the state income tax return form. 10 His or her contribution shall be credited to the program.

(c) The tax department shall determine by July 1 of each year the total amount designated pursuant to this section and shall report the amount to the State Treasurer who shall credit the amount to the Jackson's Mill 4-H Camp Fund, to be used in section eleven of this accordance with the statement of purpose in section eleven of this article.

NOTE: The purpose of this bill is to include on the state personal income tax return a checkoff option to donate some or all of any tax refund to the "Jackson's Mill 4-H Camp Checkoff Program" for the operation of the camp.

This section is new; therefore, strike-throughs and underscoring have been omitted.
