- 3 Be it enacted by the Legislature of West Virginia:
- 4 That \$17B-3-3c and \$17B-3-9 of the Code of West Virginia,
- 5 1931, as amended, be amended and reenacted; and that said code be
- 6 amended by adding thereto a new section, designated \$17B-3-9a, all
- 7 to read as follows:
- 8 ARTICLE 3. CANCELLATION, SUSPENSION OR REVOCATION OF LICENSES.
- 9 §17B-3-3c. Suspending license for failure to pay fines or
- 10 penalties imposed as the result of criminal
- conviction or for failure to appear in court.
- 12 (a) The division shall suspend the license of $\frac{any}{a}$ resident 13 of this state or the privilege of a nonresident to drive a motor
- 14 vehicle in this state upon receiving notice from a circuit court,
- 15 magistrate court or municipal court of this state, pursuant to
- 16 section two-b, two-a article three, chapter fifty of this code, or
- 17 section two-b, article ten, chapter eight of said this code or
- 18 section seventeen, article four, chapter sixty-two of said this
- 19 code, that such the person has defaulted on the payment of costs,
- 20 fines, forfeitures, penalties or restitution imposed on the person

1 suspension is the same person named in the notice. The 2 Commissioner Office of Administrative Hearings' Chief Hearing 3 Examiner may grant an administrative hearing which substantially 4 complies with the requirements of the provisions of section two, 5 article five-a, chapter seventeen-c of this code upon a preliminary 6 showing that a possibility exists that it is possible the person 7 named in the notice of conviction is not the same person whose 8 license is being suspended. Such The request for hearing shall be 9 made within ten days after receipt of a copy of the order of 10 suspension. The sole purpose of this hearing shall be is for the 11 person requesting the hearing to present evidence that he or she is 12 not the person named in the notice. In the event the Commissioner 13 grants an administrative hearing, the Commissioner Office of 14 Administrative Hearings' Chief Hearing Examiner grants an 15 administrative hearing, the Office of Administrative Hearings will 16 send notice to the commissioner and the commissioner shall stay 17 the license suspension pending the Commissioner's Chief Hearing 18 Examiner's order resulting from the hearing. 19 (c) A suspension under this section and section three-a of 20 this chapter article will continue until the person provides proof 21 of compliance from the municipal, magistrate or circuit court and 22 pays the reinstatement fee as provided in section nine of this

23 article: <u>Provided</u>, That proof of compliance is not required when

- 1 the provisions of section nine-a of this article are met. The
- 2 reinstatement fee is assessed upon issuance of the order of
- 3 suspension regardless of the effective date of suspension.

4 §17B-3-9. Surrender and return of license not required.

- 5 The division, upon suspending or revoking a license, may not 6 require that the license be surrendered to and be retained by the 7 division. The surrender of a license may not be a precondition to 8 the commencement and tolling of any applicable period of suspension 9 or revocation. Provided, That Before the license may be 10 reinstated, the licensee shall pay a fee of \$50, in addition to all 11 other fees and charges, which shall be collected by the division 12 and deposited in a special revolving fund to be appropriated to the 13 division for use in the enforcement of the provisions of this 14 section. A fee or charge assessed for a reinstatement of 15 <u>suspension</u> for failure to satisfy a citation or unpaid ticket ten 16 years old or older for which amnesty was granted under the 17 provision of section nine-a of this article is waived.
- 18 §17B-3-9a. Amnesty program for certain licenses.
- (a) Notwithstanding any other provisions of this code to the 20 contrary, from October 1, 2013, until September 30, 2014, in 21 addressing whether a licensee is qualified for reinstatement, the 22 Division of Motor Vehicles shall treat all instances of failure to 23 satisfy a citation or unpaid ticket pursuant to section three-a or

- 1 three-c of this article or for driving while suspended or revoked
- 2 related to an unpaid citation or ticket as fully paid and complied
- 3 if the date of the unpaid citation or ticket is ten years old or
- 4 older: Provided, That the person does not hold a commercial
- 5 driver's license and the citation or ticket is not pertaining to an
- 6 offense related to the operation of a commercial motor vehicle as
- 7 defined in chapter seventeen-e of this code.
- 8 (b) All unpaid citations or tickets that are ten years old or
- 9 older will remain unpaid on the court's record despite the amnesty
- 10 provisions of subsection (a) of this section.
- 11 (c) The division shall waive any remaining time on a
- 12 suspension or revocation for a second or subsequent conviction of
- 13 subsection (a), section three, article four of this chapter if the
- 14 only underlying suspensions in effect at the time of the incident
- 15 were resolved through the amnesty program contained in this
- 16 section.
- 17 (d) This section does not waive any requirement for the
- 18 retesting of a driver's vision, written or road skills if an
- 19 offender's driver's license has expired for more than six months.
- 20 (e) Notwithstanding any other provision of this section, the
- 21 division may not waive requirements or fees if the waiver:
- 22 (1) Violates federal laws or federal rules pertaining to
- 23 commercial drivers or other licensees;

- 1 (2) Disqualifies or jeopardizes the ability of this state to
- 2 receive federal highway funding or highway safety funding; or
- 3 (3) Places this state in noncompliance with Interstate or
- 4 reciprocal agreements that may be in effect now or in the future.
- 5 (f) The division shall prepare and execute a public awareness
- 6 campaign to inform the public about the amnesty program contained
- 7 in this section and how the public can participate in the program.
- 8 (g) The commissioner may propose rules for legislative
- 9 approval, in accordance with the provisions of article three,
- 10 chapter twenty-nine-a of this code, to implement this section.

NOTE: The purpose of this bill is to create an amnesty program for drivers with suspended licenses based on nonpayment of certain court fees in order to allow them to obtain their legal driver's license without payment of tickets ten years old or older.

\$17B-3-9a is new; therefore, strike-throughs and underscoring have been omitted.

Strike-throughs indicate language that would be stricken from the present law and underscoring indicates new language that would be added.
