§18-9B-16 of said code; to repeal §18A-3-2b of said code; to further amend said code by adding thereto a new section, designated §18-2E-5e; to further amend said code by adding thereto a new section, designated §18-8-6a; and to amend and reenact §18-9A-10 of said code, all relating to restoring the authority, flexibility, and capacity of schools and school systems to improve student learning; eliminating requirement for annual summary and submission of certain county board policies; eliminating requirement for biennial report on public schools and institutions; eliminating expired provisions for RESA study; eliminating expired provisions for study on staff fluctuations at certain schools; eliminating outdated provisions on comprehensive education program plans; eliminating requirement for statewide curriculum technology resource center; eliminating outdated provisions for automatic cost of living adjustment plan; eliminating outdated provisions for student learning abilities grant program; eliminating expired provisions on flood and property insurance study; eliminating expired provisions on study of school teams and committees; eliminating prescriptive summer reading and math grant program provisions; eliminating provisions pilot program for

Efficiency Audit; making legislative findings on consistency of certain Audit conclusion and policy-oriented objectives of Goals for Education; stating purpose of section with respect to Goals for Education and policy-oriented objectives; requiring state board report on accountability supervisory method that does not affect school and district strategic plans in certain ways; requiring state board to provide clear and consistent expectations for reasonable period in certain ways; requiring state board to ensure certain school and school system capacity for professional development; requiring state board to evaluate its performance and progress on achieving goals and report to Legislative Oversight Commission on Education Accountability; eliminating state board approval of certain electronic strategic improvement plans; reducing percent of increase in local share added to allowance to improve instructional programs; requiring certain funds available for use for personnel to be used for only certain personnel subject to certain condition; increasing percent of increase in local share added to instructional technology purposes; changing purpose to county and school strategic improvement plans; and changing method of allocation to counties.

Be it enacted by the Legislature of West Virginia:

That §18-2-15, §18-2-15a, §18-2-18, §18-2-23, §18-2-30, §18-2-31, §18-2-36, §18-2-37 and §18-2-38 of the code of West Virginia, 1931, as amended, be repealed; that §18-2E-3c and §18-2E-3d of said code be repealed; that §18-5-40 of said code be repealed; that §18-9-2b, §18-9-5, §18-9-7 and §18-9-8 of said code be repealed; that §18-9A-3a, §18-9A-3b, §18-9A-13, §18-9A-13a, §18-9A-13b, §18-9A-25 and §18-9A-26 of said code be repealed; that §18-9B-11 and §18-9B-16 of said code be repealed; that §18A-3-2b of said code be repealed; that §18-2-5g of said code be amended and reenacted; that said code be further amended by adding thereto a new section, designated §18-2E-5e; that said code be further amended by adding thereto a new section, designated §18-8-6a; and that §18-9A-10 of said code be amended and reenacted, all to read as follows:

ARTICLE 2. STATE BOARD OF EDUCATION.

§18-2-5g. Review and determination of principal and teacher reports; identify reports with recommendations to Legislative Oversight Commission.

- 1 ~~In addition to filing each policy as required by section~~
- 2 ~~fourteen, article five of this chapter, the state board shall require~~
- 3 ~~each county board to provide a summary of any modifications to~~

~~1 the policies and copies of annual reports developed pursuant to
2 section fourteen, article five of this chapter. The state board
3 shall submit copies of these summaries of modifications to the
4 policies and annual reports, together with any comments and
5 recommendations, to the Legislative Oversight commission on
6 education accountability, no later than December 31, of each
7 year.~~

8 (a) The state board shall review and evaluate all reports
9 required to be written by principals and teachers in order to
10 determine which reports are repetitive, unnecessary,
11 counterproductive or outdated so that the administrative burden
12 on principals and teachers may be lessened.

13 (b) The state board shall submit a report to the Legislative
14 Oversight Commission on Education Accountability no later
15 than December 31 of each year identifying those unnecessary
16 reports, together with any comments and recommendations on
17 how to reduce or consolidate principal and teacher reports.

ARTICLE 2E. HIGH QUALITY EDUCATIONAL PROGRAMS.

**18-2E-5e. Restoring the authority, flexibility, and capacity of
schools and school systems to improve student learning;**

findings with respect to Goals for Education and Efficiency Audit; state board reports.

- 1 (a) The Legislature finds that the Goals for Education,
2 Vision 2020: An Education Blueprint for Two Thousand
3 Twenty, are set forth in section four, article one of this chapter
4 and among these Goals are policy-oriented objectives to be
5 accomplished or attained to meet the Goals, including objectives
6 for:
- 7 (1) Curriculum and engaging instruction;
8 (2) An accountability and accreditation system that is based
9 on rigorous standards for student outcomes aligned with national
10 and international standards;
- 11 (3) A statewide balanced assessment processes for state,
12 district, school and classroom decision-making that reflects
13 national and international rigorous performance standards;
- 14 (4) A personnel allocation, licensure and funding process
15 that aligns with the needs of 21st Century school systems and is
16 supported by a quality coordinated professional development
17 delivery system; and
- 18 (5) A leadership recruitment, development and support
19 continuum.

20 (b) The Legislature finds that, while the other policy-
21 oriented objectives relating to the promotion of a healthy, safe
22 and responsible school environment, equitable access to
23 technology and alignment with post-secondary and workplace
24 readiness are equally important, embodied within these five
25 listed objectives is the vision for a system of schools that:

26 (1) Has clear and consistent expectations for student learning
27 upon which schools and school systems will be held
28 accountable;

29 (2) Encourages school and district self-analysis and strategic
30 planning and the implementation of research-based strategies to
31 achieve the expectations for student learning;

32 (3) Allows schools and school districts to create innovative
33 approaches to instructional delivery and design that help students
34 develop a deep understanding and ability to apply content to
35 real-world situations;

36 (4) Includes ongoing professional development activities
37 focused on enhancing student achievement and achieving
38 specific goals the school and district strategic plans;

39 (5) Provides schools the ability to access, organize and
40 deliver high quality embedded professional development that
41 provides staff with in-depth sustained and supported learning;

42 (6) Allows opportunities for staff to collectively learn, plan
43 and implement curricular and instructional improvements on
44 behalf of the students they serve; and

45 (7) Develops high quality leadership at the classroom, school
46 and district levels.

47 (c) The Legislature finds further that among the major issues
48 raised by the Efficiency Audit of West Virginia's Primary and
49 Secondary Education System conducted by Public Works, LLC,
50 is a description of West Virginia's system of schools as heavily
51 regulated. The Audit report focuses on how the system can be
52 better designed to meet the needs of students, elevate their
53 aspirations, and prepare them for post-secondary education and
54 careers. Among its general conclusions is the need to drive more
55 educational decision-making down to the level closest to the
56 students, to the classroom and building level - allowing
57 principals to lead and teachers to deliver the most effective
58 curriculum for their students - and then holding them
59 accountable for student success.

60 (d) The Legislature finds that the Audit's conclusion that
61 more local flexibility is needed, and the responses to it expressed

62 during the Legislature's several reviews, are consistent with the
63 direction of policy-oriented objectives as set forth in the Goals
64 for Education, Vision 2020: An Education Blueprint for Two
65 Thousand Twenty. Therefore, the purpose of this section is to
66 establish the Goals and its policy-oriented objectives as set forth
67 in section four, article one of this chapter as the primary avenue
68 for restoring the authority, flexibility, and capacity of schools
69 and school systems to improve student learning to meet or
70 exceed the expectations established by the state board and
71 Legislature. Pursuant to this purpose, in addition the plan to be
72 submitted to the Legislative Oversight Commission on
73 Education Accountability as provided in said section four, the
74 state board shall:

75 (1) On or before November 1, 2013, report to the Legislative
76 Oversight Commission on Education Accountability its
77 recommendations, along with any recommended statutory
78 changes necessary to effectuate its recommendations, a method
79 for holding schools and school systems accountable for meeting
80 or exceeding its expectations for student learning and for
81 otherwise exercising its general supervisory authority that does

82 not impede the ability of schools and school systems to plan
83 strategically and implement strategies for improving student
84 learning, does not utilize school and school system strategic
85 plans as a mechanism for regulatory compliance and does not
86 subject them to state-level approval or annual updates to meet
87 the state-level objectives;

88 (2) Provide clear and consistent expectations for student
89 learning upon which schools and school systems may base their
90 school improvement efforts by limiting the frequency of large
91 scale revisions of curriculum standards and assessments to a
92 reasonable period of years to the extent possible by integrating
93 any new initiatives within the existing framework of standards
94 and assessments;

95 (3) Ensure that the state's mechanism for professional
96 development delivery allows adequate flexibility and resources
97 for schools and school systems to address in a timely and
98 focused manner the needed improvement in professional
99 personnel performance identified through the evaluation process
100 and strategic improvement plans; and

101 (4) Annually evaluate and report the results to the
102 Legislative Oversight Commission on Education Accountability

103 its performance and progress on achieving the Goals for
104 Education, Vision 2020: An Education Blueprint for Two
105 Thousand Twenty and the associated policy-oriented objectives.

ARTICLE 8. COMPULSORY SCHOOL ATTENDANCE.

**§18-8-6a. Incentive for county board participation in circuit court
juvenile probation truancy programs.**

1 A county board that enters into a truancy program agreement
2 with the circuit court of the county that (1) provides for the
3 referral of truant juveniles for supervision by the court's
4 probation office pursuant to section eleven, article five, chapter
5 forty-nine of this code and (2) requires the county board to pay
6 for the costs of the probation officer or officers assigned to
7 supervise truant juveniles, shall be reimbursed for one-half of the
8 costs of the probation officer or officers, subject to appropriation
9 of the Legislature for this purpose to the West Virginia
10 Department of Education. For any year in which the funds
11 appropriated are insufficient to cover the reimbursement costs,
12 the county's costs shall be reimbursed prorata.

ARTICLE 9A. PUBLIC SCHOOL SUPPORT.

**§18-9A-10. Foundation allowance to improve instructional
programs.**

1 (a) The total allowance to improve instructional programs
2 shall be the sum of the following:

3 (1) For instructional improvement, ~~in accordance with~~
4 ~~county and school electronic strategic improvement plans~~
5 ~~required by section five, article two-e of this chapter~~, an
6 amount equal to ~~fifteen~~ ten percent of the increase in the local
7 share amount for the next school year above any required
8 allocation pursuant to section six-b of this article shall be added
9 to the amount of the appropriation for this purpose for the
10 immediately preceding school year. The sum of these amounts
11 shall be distributed to the counties as follows:

12 (A) \$150,000 shall be allocated to each county; and

13 (B) Distribution to the counties of the remainder of these
14 funds shall be made proportional to the average of each county's
15 average daily attendance for the preceding year and the county's
16 second month net enrollment.

17 Moneys allocated by provision of this ~~section~~ subdivision
18 shall be used to improve instructional programs according to the
19 county and school ~~electronic~~ strategic improvement plans;
20 ~~required by section five, article two-e of this chapter and~~
21 ~~approved by the state board.~~ *Provided*, That notwithstanding any
22 other provision of this code to the contrary, moneys allocated by
23 provision of this section may also be used in the implementation

24 and maintenance of the uniform integrated regional computer
25 information system.

26 Up to twenty-five percent of this allocation may be used to
27 employ professional educators and service personnel in counties
28 after all applicable provisions of sections four and five of this
29 article have been fully utilized.

30 Prior to the use of any funds from this ~~section~~ subdivision
31 for personnel costs, the county board must receive authorization
32 from the state Superintendent of Schools. The state
33 superintendent shall require the county board to demonstrate: (1)
34 The need for the allocation; (2) efficiency and fiscal
35 responsibility in staffing; (3) sharing of services with adjoining
36 counties and the regional educational service agency for that
37 county in the use of the total local district board budget; and (4)
38 employment of technology integration specialists to meet the
39 needs for implementation of the West Virginia 21st Century
40 Strategic Technology Learning Plan. County boards shall make
41 application for ~~available funds~~ the use of funds for personnel for
42 the next fiscal year by May 1 of each year. On or before June 1,
43 the state superintendent shall review all applications and notify

44 applying county boards of the ~~distribution of the allocation. The~~
45 ~~funds shall be distributed~~ approval or disapproval of the use of
46 funds for personnel during the fiscal year appropriate. The state
47 superintendent shall require the county board to demonstrate the
48 need for an allocation for personnel based upon the county's
49 inability to meet the requirements of state law or state board
50 policy: *Provided*, That the funds available for personnel under
51 this ~~section~~ subsection may not be used to increase the total
52 number of professional noninstructional personnel in the central
53 office beyond four: *Provided, however*, That for the school year
54 beginning July 1, 2013, and thereafter, any funds available to a
55 county for use for personnel above the amount available for the
56 2012-2013 school year, may only be used for technology
57 systems specialists until the state superintendent determines that
58 the county has sufficient technology systems specialists to serve
59 the needs of the county. The plan shall be made available for
60 distribution to the public at the office of each affected county
61 board; plus

62 (2) For the purposes of ~~the West Virginia 21st Century~~
63 ~~Strategic Technology Learning Plan provided for in section~~

64 ~~seven, article two-e of this chapter~~ improving instructional
65 technology programs according to the county and school
66 strategic improvement plans, an amount equal to ~~fifteen~~ twenty
67 percent of the increase in the local share amount for the next
68 school year above any required allocation pursuant to section
69 six-b of this article shall be added to the amount of the
70 appropriation for this purpose for the immediately preceding
71 school year. ~~The sum of these amounts shall be allocated to the~~
72 ~~counties as provided in section seven, article two-e of this~~
73 ~~chapter to meet the objectives of the West Virginia 21st Century~~
74 ~~Strategic Technology Learning Plan~~ The sum of these amounts
75 shall be distributed to the counties as follows:

- 76 (A) \$30,000 shall be allocated to each county; and
77 (B) Distribution to the counties of the remainder of these
78 funds shall be made proportional to the average of each county's
79 average daily attendance for the preceding year and the county's
80 second month net enrollment.

81 Moneys allocated by provision of this subdivision shall be
82 used to improve instructional technology programs according to
83 the county and school strategic improvement plans; plus

84 (3) One percent of the state average per pupil state aid
85 multiplied by the number of students enrolled in dual credit,
86 advanced placement and international baccalaureate courses, as
87 defined by the state board, distributed to the counties
88 proportionate to enrollment in these courses in each county; plus

89 (4) An amount not less than the amount required to meet
90 debt service requirements on any revenue bonds issued prior to
91 January 1, 1994, and the debt service requirements on any
92 revenue bonds issued for the purpose of refunding revenue bonds
93 issued prior to January 1, 1994, shall be paid into the School
94 Building Capital Improvements Fund created by section six,
95 article nine-d of this chapter and shall be used solely for the
96 purposes of that article. The School Building Capital
97 Improvements Fund shall not be utilized to meet the debt
98 services requirement on any revenue bonds or revenue refunding
99 bonds for which moneys contained within the School Building
100 Debt Service Fund have been pledged for repayment pursuant to
101 that section.

102 (b) When the school improvement bonds secured by funds
103 from the School Building Capital Improvements Fund mature,

104 the state Board of Education shall annually deposit an amount
105 equal to \$24,000,000 from the funds allocated in this section into
106 the School Construction Fund created pursuant to the provisions
107 of section six, article nine-d of this chapter to continue funding
108 school facility construction and improvements.

109 (c) Any project funded by the School Building Authority
110 shall be in accordance with a comprehensive educational facility
111 plan which must be approved by the state board and the School
112 Building Authority.
