

# Senate Bill No. 157

(By Senator Beach)

[Introduced February 14, 2013; referred to the Committee on

and then to the Committee on the Judiciary.]

A BILL to amend and reenact §17B-2-2 of the Code of West  
Virginia, 1931, as amended, relating to driver's licensing; and  
providing an exemption from the requirement for a Class D  
driver's license for certain nonresident drivers.

*Be it enacted by the Legislature of West Virginia:*

That §17B-2-2 of the Code of West Virginia, 1931, as  
amended, be amended and reenacted to read as follows:

## **ARTICLE 2. ISSUANCE OF LICENSE, EXPIRATION AND RENEWAL.**

### **§17B-2-2. Persons exempt from license.**

- 1 The following persons are exempt from license
- 2 hereunder:

3 (1) Any person while operating a motor vehicle in the  
4 armed services of the United States while in the performance  
5 of his or her official duties;

6 (2) A nonresident who is at least sixteen years of age and  
7 who has in his or her immediate possession a valid driver's  
8 license issued to the person in the person's home state or  
9 country, unless the commissioner determines the person's  
10 home state or country does not extend the same privileges to  
11 a resident of this state, may operate a motor vehicle in this  
12 state only as a noncommercial driver for a period not to  
13 exceed ninety days in any one calendar year;

14 (3) A nonresident who is at least sixteen years of age who  
15 has in the person's immediate possession a valid driver's  
16 license issued to the person in the person's home state or  
17 country and who is employed in this state, or owns, maintains  
18 or operates a place or places of business in this state, or  
19 engages in any trade, profession or occupation in this state,  
20 in addition to the driving privileges extended under  
21 subdivision (2) of this section, unless the commissioner

22 determines the person's home state or country does not  
23 extend the same privileges to a resident of this state, may  
24 operate a motor vehicle in this state only as a noncommercial  
25 driver in traveling to and from the person's place or places of  
26 employment, place or places of business or place or places at  
27 which the person engages in the trade, profession or  
28 occupation and in the discharge of the duties of the person's  
29 employment, business, trade, profession or occupation if the  
30 duties are such that, if performed by a resident of the State of  
31 West Virginia over the age of eighteen years of age, the  
32 resident would not be required under the provisions of this  
33 chapter to obtain a Class A, B, C or D driver's license:  
34 Provided, That a nonresident driver who meets the minimum  
35 age and experience requirements for a Class D driver's  
36 license pursuant to subdivision (2), subsection (c), section  
37 one, article two, chapter seventeen-b of the code who is  
38 licensed in a jurisdiction that does not offer an equivalent  
39 driver's license may operate a motor vehicle in this state that  
40 requires a resident to have a Class D license. However, this

41 subsection shall not exempt any person who is required to  
42 obtain a West Virginia driver's license in accordance with the  
43 provisions of section one-a of this article;

44 (4) A nonresident who is at least eighteen years of age  
45 and who has in his or her immediate possession a valid  
46 commercial driver's license issued to the person in his or her  
47 home state or country and which meets the requirements of  
48 the federal Commercial Motor Vehicle Act of 1986, Title XI  
49 of public law 99-570, and unless the commissioner  
50 determines the person's home state or country does not  
51 extend the same privilege to a resident of this state, may  
52 operate a motor vehicle in this state either as a commercial  
53 driver subject to the age limits applicable to commercial  
54 driver in this state, or as a noncommercial driver subject to  
55 the limitations imposed on nonresident drivers in  
56 subdivisions (2) and (3) of this section;

57 (5) Any person who is a student, properly enrolled and  
58 registered in an accredited school, college or university in  
59 this state, who is at least sixteen years of age and who has in

60 his or her immediate possession a valid driver's license  
61 issued to the person in the person's home state,  
62 notwithstanding the limitations of subdivisions (2) and (3) of  
63 this section, may operate a motor vehicle in this state only as  
64 a noncommercial driver: *Provided*, That the state of which  
65 the person is a resident shall extend the same privileges to  
66 residents of this state. This exemption shall be canceled  
67 immediately when the student is graduated from school,  
68 college or university or is expelled or ceases to be a student.

(NOTE: The purpose of this bill is to provide reciprocity to certain nonresidents whose primary occupation is operating motor vehicles which would require a Class D license in this state but do not require an equivalent licence in the nonresident's state. Operation of vehicles requiring a Class D license does not require a commercial driver's license.

This legislation was recommended for passage in the 2013 Regular Session by the Legislative Select Committee on Infrastructure.
