20 WHEREAS, The Governor submitted to the Legislature the  
21 Executive Budget document, dated January 8, 2014, which included a  
22 Statement of the State Fund, General Revenue, setting forth therein  
23 the cash balance as of July 1, 2013, and further included the  
24 estimate of revenues for the fiscal year 2014, less net

1 appropriation balances forwarded and regular appropriations for the  
2 fiscal year 2014; and

3 WHEREAS, It appears from the Executive Budget document,  
4 Statement of the State Fund, General Revenue, and this legislation,  
5 there now remains an unappropriated surplus balance in the State  
6 Treasury which is available for appropriation during the fiscal  
7 year ending June 30, 2014; therefore

8 *Be it enacted by the Legislature of West Virginia:*
