10 AN ACT making a supplementary appropriation of Lottery Net Profits  
11 from the balance of moneys remaining as an unappropriated  
12 balance in Lottery Net Profits to the Division of Natural  
13 Resources, fund 3267, fiscal year 2014, organization 0310, and  
14 to the Bureau of Senior Services - Lottery Senior Citizens  
15 Fund, fund 5405, fiscal year 2014, organization 0508, by  
16 supplementing and amending the appropriations for the fiscal  
17 year ending June 30, 2014.

18 Whereas, The Governor submitted the Executive Budget Document  
19 to the Legislature on January 8, 2014, which included a Statement  
20 of the Lottery Fund setting forth therein the unappropriated cash  
21 balance as of July 1, 2013, and further included the estimate of  
22 revenues for the fiscal year 2014, less regular appropriations for

1 fiscal year 2014; and

2       Whereas, It appears from the Governor's Statement of Lottery  
3 Fund, there now remains an unappropriated balance in the State  
4 Treasury which is available for appropriation during the fiscal  
5 year ending June 30, 2014; therefore

6 *Be it enacted by the Legislature of West Virginia:*

7       That the total appropriation for the fiscal year ending June  
8 30, 2014, to fund 3267, fiscal year 2014, organization 0310, be  
9 supplemented and amended by increasing existing items and adding a  
10 new item of appropriation as follows:
