15	A BILL to amend and reenact §9A-1-10 of the Code of West Virginia,
16	1931, as amended; to amend and reenact \$16-1B-1 of said code;
17	and to amend and reenact $\$19-1-4$ of said code, all relating to
18	authorizing the Secretary of the Department of Veterans'
19	Assistance and the Commissioner of the Department of
20	Agriculture to enter into an agreement to transfer certain
21	property for construction of a veterans skilled nursing
22	facility; and making legislative findings.
23	Be it enacted by the Legislature of West Virginia:
24	That §9A-1-10 of the Code of West Virginia, 1931, as amended,

- 1 be amended and reenacted; that §16-1B-1 of said code be amended and
- 2 reenacted; and that \$19-1-4 of said code be amended and reenacted,
- 3 all to read as follows:
- 4 CHAPTER 9A. VETERANS' ASSISTANCE.
- 5 ARTICLE 1. DEPARTMENT OF VETERANS' ASSISTANCE.
- 6 §9A-1-10. Powers and duties of secretary.
- 7 The director secretary is the executive and administrative
- 8 head of the division department and has the power and duty, subject
- 9 to the provisions of section four of this article, to:
- 10 (a) Supervise and put into effect the purposes and provisions
- 11 of this article and the rules for the government of the division
- 12 department;
- 13 (b) Prescribe methods pertaining to investigations and
- 14 reinvestigations of all claims and to the rights and interests of
- 15 all veterans, their widows, dependents and orphans;
- 16 (c) Prescribe uniform methods of keeping all records and case
- 17 records of the veterans, their widows, dependents and orphans;
- 18 (d) Sign and execute, in the name of the state by West
- 19 Virginia Division Department of Veterans' Affairs Assistance, and
- 20 by and with the consent of the Veterans' Council, any contract or
- 21 agreement with the federal government or its agencies, other
- 22 states, subdivisions of this state, corporations, associations,
- 23 partnerships or individuals;

- 1 (e) Supervise the fiscal affairs and responsibilities of the 2 division department;
- 3 (f) Organize the <u>division</u> <u>department</u> to comply with the 4 requirements of this article and with the standards required by any 5 federal act or any federal agency;
- 6 (g) Establish any regional or area offices throughout the 7 state that are necessary to promote efficiency and economy in 8 administration;
- 9 (h) Make reports that comply with the requirements of any 10 federal act or federal agency and the provisions of this article;
- 11 (i) Cooperate with the federal and state governments for the 12 more effective attainment of the purposes of this article;
- (j) Keep a complete and accurate record of all proceedings;

 14 record and file all contracts and agreements and assume

 15 responsibility for the custody and preservation of all papers and

 16 documents pertaining to his or her office and the division

 17 department;
- (k) Prepare for the Veterans' Council the annual reports to 19 the Governor of the condition, operation and functioning of the 20 division department;
- 21 (1) Exercise any other powers necessary and proper to 22 standardize the work; to expedite the service and business; to 23 assure fair consideration of the rights and interests and claims of 24 veterans, their widows, dependents and orphans; to provide

- 1 resources for a program which will promote a greater outreach to
- 2 veterans and which will advise them of the benefits and services
- 3 that are available, and to promote the efficiency of the $\frac{\text{division}}{\text{division}}$
- 4 department;
- 5 (m) Invoke any legal, equitable or special remedies for the
- 6 enforcement of his or her orders or the provisions of this article;
- 7 (n) Appoint the veterans' <u>affairs</u> <u>assistance</u> officers and
- 8 heads of divisions of the division department, and of regional or
- 9 area offices, and employ assistants and employees, including case
- 10 managers and counselors, that are necessary for the efficient
- 11 operation of the division department;
- 12 (o) Provide resources and assistance in the development of an
- 13 internet website which is to be used to inform veterans of programs
- 14 and services available to them through the division department and
- 15 the state and federal governments;
- 16 (p) Delegate to all or any of his or her appointees,
- 17 assistants or employees all powers and duties vested in the
- 18 director secretary, except the power to sign and execute contracts
- 19 and agreements, but the director secretary shall be responsible for
- 20 the acts of his or her appointees, assistants and employees; and
- 21 (q) Provide volunteers who will drive or transport veterans to
- 22 veterans' hospitals from the veteran's home or local veterans'
- 23 affairs offices and who shall be paid an expense per diem of
- 24 seventy-five dollars; and

- 1 (r) Enter into an agreement with the Commissioner of the
- 2 Department of Agriculture to transfer all or part of the
- 3 approximately seventeen acres of Department of Agriculture property
- 4 in Beckley, West Virginia, located adjacent to the Jackie Withrow
- 5 Hospital which was formerly known as Pinecrest Hospital, for
- 6 construction of a veterans skilled nursing facility.
- 7 CHAPTER 16. PUBLIC HEALTH.
- 8 ARTICLE 1B. SKILLED NURSING FACILITIES FOR VETERANS OF THE UNITED
- 9 STATES ARMED FORCES.
- 10 §16-1B-1. Legislative findings.
- 11 The Legislature finds that the health and welfare of the
- 12 veterans of the armed forces who are citizens of our state will be
- 13 best served by the establishment of one or more skilled nursing
- 14 facilities exclusively for these veterans. Furthermore, the
- 15 Legislature finds that nearly two hundred thousand veterans in this
- 16 state have distinguished themselves with the highest level of
- 17 participation per capita of any state in the wars fought by this
- 18 nation. Further, an aging veterans' population which suffers from
- 19 wartime disabilities and illnesses are, or will be, in need of
- 20 skilled nursing care.
- 21 The Legislature further finds that construction of an
- 22 additional 120-bed veterans skilled nursing facility in southern
- 23 West Virginia is needed, to be located on Department of Agriculture
- 24 property in Beckley, West Virginia, adjacent to the Jackie Withrow

- 1 Hospital which was formerly known as Pinecrest Hospital. The West
- 2 Virginia veterans skilled nursing facility located in Clarksburg is
- 3 currently at its maximum capacity and has a large waiting list for
- 4 admission. With a veteran population that has now reached over two
- 5 hundred twenty thousand, there is an overwhelming need for
- 6 additional nursing home beds in other areas of our state to
- 7 accommodate our veterans as they become unable to take care of
- 8 themselves.
- 9 CHAPTER 19. AGRICULTURE.
- 10 ARTICLE 1. DEPARTMENT OF AGRICULTURE.
- 11 §19-1-4. Duties of commissioner.
- 12 The Commissioner of Agriculture shall perform the following 13 duties:
- 14 (a) Devise means of advancing the agricultural interests of
- 15 the state and, in the performance of such duty, he or she shall
- 16 have authority to call upon any state department, or officer of the
- 17 state or county, to cooperate in promoting the agricultural
- 18 interests of the state. It shall be the duty of any such
- 19 department, or officer, upon request of the commissioner to render
- 20 the assistance desired;
- 21 (b) Promote and encourage the organization of such societies
- 22 and associations as have for their object the improvement and
- 23 development of the state's agricultural, horticultural and kindred
- 24 interests, especially in production, processing for market and

- 1 distribution;
- 2 (c) Conduct cooperative work with the United States Department
- 3 of Agriculture in inspecting and determining the grade and
- 4 condition of farm produce at collecting centers, receiving centers
- 5 and shipping points;
- 6 (d) Induce the investment of capital in, and immigration into,
- 7 this state by the dissemination of information relative to the
- 8 soil, climate, health, natural resources, market opportunities and
- 9 advantages of the state;
- 10 (e) Investigate and report upon the kinds, conditions and
- 11 extent of the mineral products of the state and their value;
- 12 (f) Take charge of the museum of the Department of
- 13 Agriculture, collect, preserve and exhibit therein specimens of
- 14 agricultural, horticultural and kindred products, products of the
- 15 forests, minerals, flora and fauna of the state;
- 16 (g) Publish and distribute, from time to time, such reports
- 17 and bulletins concerning agriculture, horticulture and kindred
- 18 subjects as may be of value to the farmers of the state and, as
- 19 conditions may demand, publish a handbook giving the resources of
- 20 the several counties of the state, the varieties of soil and
- 21 products, both mineral and vegetable, and the adaptability of the
- 22 different sections of the state to the different branches of
- 23 agriculture, horticulture and kindred interests;
- 24 (h) Submit a biennial report to the Governor and Legislature

- 1 containing such information as to the operations of the department
- 2 as may be helpful to the agricultural interests of the state,
- 3 together with an itemized statement of all receipts and
- 4 disbursements during the biennial period covered thereby and giving
- 5 the name of every person employed during such period, the time
- 6 employed and the amount paid each employee;
- 7 (i) Perform such other duties and exercise such other powers
- 8 as are provided in this chapter and by general law; and
- 9 (j) Enter into an agreement with the Secretary of the
- 10 Department of Veterans' Assistance to transfer all or part of the
- 11 approximately seventeen acres of Department of Agriculture property
- 12 in Beckley, West Virginia, located adjacent to the Jackie Withrow
- 13 Hospital which was formerly known as Pinecrest Hospital, for
- 14 construction of a veterans skilled nursing facility; and
- 15 (j) (k) Propose rules, including regulatory standards, for
- 16 legislative approval in accordance with the provisions of article
- 17 three, chapter twenty-nine-a of this code for the purpose of
- 18 carrying out the requirements of this chapter.
