3 The Legislature finds that the above moral obligations and the
4 appropriations made in satisfaction thereof shall be the full
5 compensation for all claimants and that prior to the payments to
6 any claimant provided in this bill, the Court of Claims shall
7 receive a release from said claimant releasing any and all claims
8 for moral obligations arising from the matters considered by the
9 Legislature in the finding of the moral obligations and the making
10 of the appropriations for said claimant. The Court of Claims shall
11 deliver all releases obtained from claimants to the department
12 against which the claim was allowed.
