9 AN ACT finding and declaring certain claims against the state and  
10 its agencies to be moral obligations of the state; and  
11 directing the Auditor to issue warrants for the payment  
12 thereof.

13 *Be it enacted by the Legislature of West Virginia:*

14 **CLAIMS AGAINST THE STATE.**

15 **§1. Finding and declaring certain claims against the Department of**  
16 **Administration/Office of Technology; Department of Health**  
17 **and Human Resources; Division of Corrections; Division of**  
18 **Highways; Division of Juvenile Services; Division of Motor**  
19 **Vehicles; Real Estate Commission; Regional Jail Authority;**  
20 **and State of West Virginia to be moral obligations of the**  
21 **state and directing payment thereof.**

22 The Legislature has considered the findings of fact and

1 recommendations reported to it by the Court of Claims concerning  
2 various claims against the state and agencies thereof and in  
3 respect to each of the following claims, the Legislature adopts  
4 those findings of fact as its own and in respect of certain claims  
5 herein, the Legislature has independently made findings of fact and  
6 determinations of award and hereby declares it to be the moral  
7 obligation of the state to pay each such claim in the amount  
8 specified below and directs the Auditor to issue warrants for the  
9 payment thereof out of any fund appropriated and available for the  
10 purpose.
