| 20 | §5A-3-60. Purchase of goods and equipment manufactured in the |

| 22 | (a) In any instance that a contract for construction or a |
| 23 | purchase of supplies, material, equipment and any other articles or |

- 2 all bids shall specify and require that goods and equipment
- 3 comprising a substantial portion of the total bid amount shall be
- 4 American made and no bid shall be approved that does not comply

- 6 (b) As used in this section:
- 7 (1) "Goods and equipment" means supplies, material, equipment
- 8 and any other articles or things used by or furnished to a
- 9 department, agency or institution of state government pursuant to

- 12 agency exceed the cost of comparable foreign-made goods or
- 13 equipment by more than ten percent of the cost of that item.

NOTE: The purpose of this bill is to require materials, supplies, equipment and other items purchased by the state and its agencies to be made in the United States. The bill provides exceptions. The bill also defines terms.

This section is new; therefore, it has been completely underscored.

This bill was recommended for introduction and passage during the Regular Session of the Legislature by the Committee on Labor and Worker Safety Issues.
