10 A BILL to amend the Code of West Virginia, 1931, as amended, by
11 adding thereto a new section, designated §18-5-18f, relating
12 to establishing a four year pilot program to have social
13 workers in public schools, from prekindergarten through the
14 elementary school; requiring a minimum of one social worker
15 per county; defining a term; requiring rule-making; and
16 requiring annual and final reports.

17 Be it enacted by the Legislature of West Virginia:

18 That the Code of West Virginia, 1931, as amended, be amended
19 by adding thereto a new section, designated §18-5-18f, to read as
20 follows:

21 ARTICLE 5. COUNTY BOARD OF EDUCATION.

22 §18-5-18f. Social worker pilot programs; reports.

23 (a) County boards shall, by July 1, 2014, establish four year
24 social worker pilot programs for all children in prekindergarten
25 though elementary school.

1 (b) For purposes of this section, "social worker" means a
2 nonteaching school employee who, at a minimum:

3 (1) Possesses a license in social work with the West Virginia
4 Board of Social Work;

5 (2) Has a minimum of five years experience working with
6 children and families; and

7 (3) Has experience conducting home visits, providing parent
8 education, crisis intervention and advocacy and support services,
9 with school based social work experience being preferred.

10 (c) Abuse and neglect, poor nutrition and health care,
11 behavior problems, homelessness, poor academic performance, lack of
12 parent evolvement and substance abuse are areas of concern facing
13 public education. Teachers and support staff are called upon to
14 address these issues to the detriment of their educational
15 responsibilities. Having a trained social worker available to
16 students, staff and parents is beneficial in the following ways:

17 (1) Permit problems to be addressed by professionals trained
18 to deal with those issues and guide teachers and staff on child
19 protective laws;

20 (2) Unburden teachers and support staff so they can focus on
21 performing their educational responsibilities to the students;

22 (3) The social worker's role will be to work with the guidance
23 counselor with a team approach. The social worker would not only
24 work with the child at the school but conduct home visits as

1 necessary to address parent issues, provide parenting education,
2 address social and emotional issues, address physical and mental
3 health issues and advocate for the family linking them to necessary
4 community resources; and

5 (4) Assist in ensuring an atmosphere in the classroom where
6 learning can be achieved to ensure the child's success in school
7 and life.

8 (d) Pilot programs implemented by the county boards shall
9 provide for a minimum of one social worker for one Title 1,
10 prekindergarten through elementary school, in each county. If more
11 than one Title 1 elementary school exists in the county that
12 qualifies, the Title 1 school with the lowest test scores should be
13 given preference. This will ensure the social worker is placed in
14 a high poverty school where students are most in need. Addressing
15 issues of concern in a child's early educational experience can
16 prevent future problems from occurring.

17 (e) The state board with the advice of the state
18 superintendent shall establish and prescribe guidelines and
19 criteria relating to the establishment and operation of the social
20 worker pilot programs.

21 (f) Each county board shall submit an annual report on the
22 effectiveness of the social worker pilot programs to the state
23 board no later than June 15 of each year, beginning in 2015. The
24 state board shall compile these individual reports and submit its

1 own annual report to the Legislative Oversight Commission on
2 Education Accountability before September 1 of each year, beginning
3 in 2015.

4 (g) The state board shall submit a final report on the social
5 worker pilot program, including findings, conclusions and
6 recommendations, together with drafts of any legislation or rule
7 changes necessary to effectuate the recommendations, to the
8 Legislative Oversight Commission on Education Accountability no
9 later than September 1, 2018.

NOTE: The purpose of this bill is to establish a four year pilot program to have social workers in public schools, from prekindergarten through the elementary school. The bill requires a minimum of one social worker per county. The bill defines "social worker." The bill requires rule-making. The bill requires annual and final reports.
